**PURPOSE AND EFFECT:** The purpose and effect of this rulemaking is to incorporate by reference the Well Construction Permitting Agreements Between the Southwest Florida Water Management District and Sarasota County, Manatee County, and the Florida Department of Health in Marion County, which were recently approved by the District’s Governing Board. These Agreements memorialize and continue the long-standing delegation by the District of the well construction permitting program in Sarasota, Manatee, and Marion Counties. The Agreements are effective June 1, 2016, and expire May 31, 2021, unless terminated earlier. The amendment of this rule to incorporate these Agreements by reference maintains the regulatory status quo for well construction permitting in Sarasota, Manatee and Marion Counties.

68B-4.018 Boca Grande Pass Gear Restrictions

PURPOSE AND EFFECT: The purpose of this rule development is to modify the boundary of the area defined in rule as Boca Grande Pass in order to reflect changes made by the United States Coast Guard (USCG) to the navigation buoys marking Boca Grande Channel.

In February 2016, the USCG completed a channel marker redesign project for Boca Grande Channel to ensure that the marked channel better aligned with the current location and configuration of the natural channel. As part of this project, the USCG removed the #12 red buoy marking the entrance to the Boca Grande Channel, and replaced it with a new buoy (Charlotte Harbor Channel LB 6) located 0.21 miles (approximately 1,096 feet) to the east-southeast (see attached map). Because the #12 red buoy was used as a reference point in the Commission's rule that defines the boundary of Boca Grande Pass for purposes of implementing specific fishing gear restrictions that apply within this area, the rule needs to be amended.

The effect of this change would be to amend 68B-4.018, F.A.C. (Boca Grande Pass Gear Restrictions), to modify the boundary of Boca Grande Pass by deleting the reference to the #12 red buoy that has been removed and incorporate the location of the new buoy, Charlotte Harbor Channel LB 6, as the western boundary point. This proposed change will ensure that the boundary of the area where the Boca Grande Gear Restrictions apply aligns with the current configuration of the navigation buoys marking Boca Grande Channel. This change reduces the size of the area where the Boca Grande Pass Gear Restrictions apply by a total of 0.12 square miles.

SUMMARY: Rule 68B-4.018, F.A.C., would be amended to modify the boundary of Boca Grande Pass in rule to delete the reference to the #12 red buoy that was removed by the United States Coast Guard and incorporate the location of the new buoy, Charlotte Harbor Channel LB 6, as the western boundary point.

68B-4.018 Boca Grande Pass Gear Restrictions.

(1) BOCA GRANDE PASS – For purposes of the restrictions specified in subsections (2) and (3), Boca Grande Pass shall consist of all waters located within the following boundaries:

Begin at the westernmost edge of the Phosphate Dock (26°43.216' North Latitude, 82°15.517' West Longitude) on the southeast bay side of Gasparilla Island; thence proceed due east on a straight line to the westernmost edge of the intracoastal waterway (26°43.216' North Latitude, 82°14.703' West Longitude); thence proceed in a southerly direction to the #75 Intracoastal Waterway Marker (26°42.299' North Latitude, 82°14.580' West Longitude) on the northeast bay side of Cayo Costa; thence proceed around the northern tip of Cayo Costa along the shore to the QR test buoy (26°42.002' North Latitude, 82°15.448' West Longitude) on the northwest Gulf coast side of Cayo Costa; thence proceed westerly on a

straight line to the Charlotte Harbor Channel LB 6 buoy #12 red buoy (26°42.299' ~~26°42.336'~~ North Latitude, 82°16.551' ~~82°16.748'~~ West Longitude) marking the entrance to Boca Grande Pass; thence proceed northeast on a straight line to the easternmost edge of the concrete pier ruins (26°43.165' North Latitude, 82°15.778' West Longitude) at the lighthouse beach on the southwest Gulf side of Gasparilla Island; thence proceed along the shore around the southern tip of Gasparilla Island to the Phosphate Dock, the point of beginning.

**RULE NO.:** 68B-14.006 **RULE TITLE:** Other Prohibitions and Exception

**PURPOSE AND EFFECT:** In general, state and federal regulations require most marine fish to be landed whole (e.g., fish may not be possessed as fillets on the water). In December 1998, the South Atlantic Fishery Management Council (Council) created an exemption allowing recreational anglers to transit Atlantic federal waters with fillets of recreationally harvested reef fish from The Bahamas provided specific conditions were met. In January 2016, the Council revised and expanded the conditions for the federal exemption. The Commission is considering a rule that is consistent with the exemption for federal waters. Specifically, the proposed rule would create an exception in state rule allowing anglers to land reef fish as fillets instead of as whole fish, provided the

reef fish were recreationally harvested in The Bahamas and anglers adhere to several conditions.

This proposed exception would only apply to species managed as “snapper-grouper” by the Council in 50 CFR § 622. To qualify for this exception, anglers would be required to keep skin on fillets for the purpose of species identification. Anglers would also be required to comply with South Atlantic federal bag and possession limits. For the purpose of this rule, two fillets would count as one fish towards reef fish bag and possession limits. To serve as proof that the fish were harvested in Bahamian waters, the vessel would be required to have valid Bahamian fishing and cruising permits and each passenger aboard the vessel would be required to possess a valid government passport with current stamps and dates from The Bahamas. When transiting state waters, the vessel would be required to maintain a continuous course with all fishing gear stowed. The final condition would prohibit sale and purchase of reef fish transited to Florida under this exception. The proposed rule change would benefit Florida residents and tourists who depart from Florida ports to fish in The Bahamas, because it would allow them to return to Florida with their Bahamian-caught reef fish as fillets. Aboard small recreational fishing vessels, it is more practical to store fish as fillets, rather than as whole fish, and doing so can help minimize food safety risks. Additionally, implementing these proposed rules would create consistency with federal regulations off Florida’s Atlantic coast and make rule compliance simpler for recreational anglers.

The effect of the proposed rules would be an exception allowing recreational anglers to land reef fish as fillets, rather than as whole fish, when returning to Florida by boat with reef fish caught in Bahamian waters. Creating this exception would benefit Florida residents and tourists by offering them an alternative means to safely store and transport their Bahamian catch and by creating consistent regulations with adjacent federal waters.

**SUMMARY:** These proposed rules would create an exception allowing recreational anglers to land reef fish as fillets instead of as whole fish, provided the reef fish were recreationally harvested in The Bahamas and specific conditions are met. The conditions would require (1) skin to remain on the fillets; (2) anglers to comply with South Atlantic federal bag and possession limits; (3) the vessel to possess valid Bahamian fishing and cruising permits; and (4) each passenger to possess valid government passports with current Bahamian stamps and travel dates. For the purpose of the proposed rules, two fillets would count as one fish towards reef fish bag and possession limits. Vessels transporting filleted reef fish from The Bahamas would be required to maintain direct and continuous transit through state waters with all fishing gear stowed. Finally, the proposed rules would prohibit the sale and

purchase of reef fish transported to Florida under this exception.

68B-14.006 Other Prohibitions and Exception.

(1) through (3) No change.

(4) Landed in Whole Condition Requirement – Except as provided elsewhere in this rule. aAll fish harvested from

Florida or adjacent federal Exclusive Economic Zone (EEZ) waters pursuant to the requirements of this chapter shall be landed in a whole condition. The possession, while in or on state waters, on any public or private fishing pier, on a bridge or catwalk attached to a bridge from which fishing is allowed, or on any jetty, of such fish that have been deheaded, sliced, divided, filleted, ground, skinned, scaled or deboned is prohibited. Mere evisceration or “gutting” of fish, or mere removal of gills from fish, before landing is not prohibited. Preparation of fish for immediate consumption on board the vessel from which the fish were caught is not prohibited.

(5) Landed in Whole Condition Exception – Recreational anglers that lawfully harvest species listed as South Atlantic Snapper-Grouper in Table 4 of Appendix A to 50 C.F.R. § 622 (as of June 22, 2016), in waters of the Commonwealth of the Bahamas are exempt from the requirement to land such fish in whole condition under the following conditions:

(a) Skin must remain intact on the entire fillet of any fish carcass as specified in 50 C.F.R. § 622.186 (as of January 27, 2016).

(b) A person or vessel that lawfully harvests fish in Bahamian waters and transits through Florida waters must comply with the bag and possession limits specified in 50 C.F.R. § 622.187 (as of January 27, 2016), and the seasons specified in 50 C.F.R. § 622.183-184 (as of January 27, 2016). Two fillets of fish, regardless of the length of each fillet, is equivalent to one fish.

(c) Valid Bahamian fishing and cruising permits are on board the vessel.

(d) Each person on the vessel has a valid government passport with current stamps and dates from the Commonwealth of the Bahamas.

(e) The vessel is in transit through state waters with fishing gear appropriately stowed. For the purpose of this rule, a vessel is in transit when it is on a direct and continuous course through state waters and no one aboard the vessel fishes in state waters. A person whose substantial interests are affected by the Department's action may petition for an administrative proceeding (hearing) under Sections 120.569 and 120.57 of the Florida Statutes. The petition must contain the information set forth below and must be filed (received by the clerk) in the Office of General Counsel of the Department at 3900 Commonwealth Boulevard, MS 35, Tallahassee, Florida 32399-3000.

Mediation under Section 120.573, F. S., is not available.

Because the administrative hearing process is designed to redetermine final agency action on the adoption of the Plan, the filing of a petition for an administrative hearing may result in a modification of the agency action. If a sufficient petition for an administrative hearing or request for an extension of time to file a petition is timely filed, this agency action automatically becomes only proposed agency action on the adoption of the Inlet Management Plan, subject to the result of the administrative review process.

Under subsections 28-106.111(3) and 62-110.106(4), F.A.C., a person whose substantial interests are affected by the Department's action may also request an extension of time to file a petition for an administrative hearing. The Department may, for good cause shown, grant the request for an extension of time. Requests for extension of time must be filed with the Office of General Counsel of the Department at 3900 Commonwealth Boulevard, Mail Station 35, Tallahassee, Florida 32399-3000, before the applicable deadline. A timely request for extension of time shall toll the running of the time period for filing a petition until the request is acted upon. If a request is filed late, the Department may still grant it upon a motion by the requesting party showing that the failure to file a request for an extension of time before the deadline was the result of excusable neglect.

In the event that a timely and sufficient petition for an administrative hearing is filed, other persons whose substantial interests will be affected by the outcome of the administrative process have the right to petition to intervene in the proceeding. Any intervention will be only at the discretion of the presiding officer upon the filing of a motion in compliance with Rule 28-106.205, F.A.C.

In accordance with Rules 28-106.111 and 62-110.106, F.A.C., petitions for an administrative hearing by the applicant must

be filed within 21 days of receipt of this written notice. Petitions filed by any persons other than the applicant, and other than those entitled to written notice under Section 120.60(3), F.S., must be filed within 21 days of publication of the notice or within 21 days of receipt of the written notice, whichever occurs first.

Under Section 120.60(3), F.S., however, any person who has asked the Department for notice of agency action may file a petition within 21 days of receipt of such notice, regardless of the date of publication.

The failure of any person to file a petition for an administrative hearing within the appropriate time period shall constitute a waiver of that person's right to request an administrative determination (hearing) under Sections 120.569 and 120.57, F.S.

A petition that disputes the material facts on which the Department's action is based must contain the following information: (a) The name and address of each agency affected and each agency's file or identification number, if known; (b) The name, address, and telephone number of the petitioner; the name, address, and telephone number of the petitioner's representative, if any, which shall be the address for service purposes during the course of the proceeding; and an explanation of how the petitioner's substantial interests are or will be affected by the agency determination; (c) A statement of when and how the petitioner received notice of the agency decision; (d) A statement of all disputed issues of material fact. If there are none, the petition must so indicate; (e) A concise statement of the ultimate facts alleged, including the specific facts that the petitioner contends warrant reversal or modification of the agency's proposed action; and (f) A statement of the specific rules or statutes that the petitioner contends require reversal or modification of the agency's proposed action; (g) A statement of the relief sought by the petitioner, stating precisely the action that the petitioner wishes the agency to take with respect to the agency's proposed action.

A petition that does not dispute the material facts on which the Department's action is based shall state that no such facts are in dispute and otherwise shall contain the same information as set forth above, as required by Rule 28-106.301. Under Sections 120.569(2)(c) and (d), F.S., a petition for administrative hearing must be dismissed by the agency if the petition does not substantially comply with the above requirements or is untimely filed.

This action is final and effective on the date filed with the Clerk of the Department unless a petition is filed in accordance with the above. Upon the timely filing of a petition this order will not be effective until further order of the Department.



This action constitutes an order of the Department. The applicant has the right to seek judicial review of the order under Section 120.68, Florida Statutes, by the filing of a notice of appeal under Rule 9.110, Florida Rules of Appellate Procedure, with the Clerk of the Department in the Office of General Counsel, 3900 Commonwealth Boulevard, Mail Station 35, Tallahassee, Florida, 32399-3000; and by filing a copy of the notice of appeal accompanied by the applicable filing fees with the appropriate district court of appeal.
