Sub-subparagraphs 11B-27.0011(4)(c)15.a. and b., F.A.C.: Adds new subparagraphs to define “prejudicial behavior” violation and includes penalty guidelines for Florida officers who exhibit prejudicial behavioral courses of conduct and who participate in activity which furthers the interests of a “hate group”, as defined in Section 874.03(6), F.S.

Paragraph 11B-27.002(1)(d), F.A.C.: Combines the original Physician’s Assessment, form CJSTC-75, and the Physical Fitness Assessment, form CJSTC-75B, to create and incorporate the revised Physician’s Assessment, form CJSTC-75, which includes the student participation activities and medical conditions regarding OC/CS contamination; and prohibits a chiropractor from completing the form as a medical doctor. The original form CJSTC-75B will be repealed.

Subparagraph 11B-27.002(3)(a)11., F.A.C.: Incorporates the revised Exemption-From-Training, form CJSTC-76, to change the discipline field name to “Florida Correctional Probation Officer Training Academy” and revise the deficiency topics.

Subparagraph 11B-27.002(3)(a)15., F.A.C.: Incorporates the revised Affidavit of Separation, form CJSTC-61, and removes the reference to the Affidavit of Separation Supplement, form CJSTC-61A, which is being repealed. Also provides clarification concerning an agency’s responsibility in conducting an internal investigation upon the separation of an officer.

Subsection 11B-27.002(6), F.A.C.: Deletes paragraph containing the repealed Affidavit of Separation Supplement, form CJSTC-61A, because the form will no longer be used.

(a) Be a Florida resident, as evidenced by a valid Florida driver's license or identification card; a current utility bill in the person's name including a Florida address; a current Florida voter registration card; or for minors, a certified copy of birth certificate or current record of registration from a Florida school (K-12), and proof of residency of designated legal representative.

(b) Be a qualified patient who has been added to the Compassionate Use Registry, by an authorized physician licensed under Chapter 458 or Chapter 459, to receive low-THC cannabis or medical cannabis from a dispensing organization.

(c) Submit DH8009-OCU-10/2016, "Qualified Patient Application," and DH8011-OCU-10/2016, "Physician Certification," which are incorporated by reference and available at <http://www.flrules.org/Gateway/reference.asp?No=Ref-####> and <http://www.flrules.org/Gateway/reference.asp?No=Ref-####>.

(3) To apply for a legal representative Compassionate Use Registry identification card, a person must submit DH8010-OCU-10/2016, "Legal Representative Application," which is incorporated by reference and available at <http://www.flrules.org/Gateway/reference.asp?No=Ref-####>.

(4) In order for a minor applicant to receive a patient Compassionate Use Registry identification card, the minor applicant must reside in Florida and have a legal representative designated in his or her application and in the online Compassionate Use Registry.

(5) Each applicant shall pay a \$75.00 non-refundable application fee in the form of a check or money order payable to the Department of Health. The card shall expire one (1) year after the date of the physician's initial order.

(6) An applicant shall have sixty (60) days from the date the department provides notice that the application is incomplete to make corrections, provide additional information or resubmit the application.

(7) If there is no initial order by the patient's authorized physician at the time of the approval of the applicant's Compassionate Use Registry identification card, the Department will provide a temporary verification which may be used, with a photo ID, to obtain medical cannabis for a period of 30 days or until the applicant receives the permanent identification card, whichever occurs first.

(8) To maintain an active Compassionate Use Registry identification card, a patient and/or legal representative must annually submit DH8009-OCU-10/2016 and/or DH8010-OCU-10/2016, along with the application fee and any required

accompanying documents to the department forty-five (45) days prior to the card expiration date.

(9) When there has been a change in the patient's name, address, or assigned legal representative, that patient must notify the department within ten (10) days by submitting a completed Change, Replacement or Surrender Request, DH8012-OCU-10/2016, which is incorporated by reference and available at <http://www.flrules.org/Gateway/reference.asp?No=Ref-####>. A patient who has not designated a legal representative at the time of application to the department may do so in writing at any time during the effective period of the patient's registry identification card.

(10) A patient who no longer has a qualifying medical condition shall return his or her registry identification card to the department within ten (10) days of receiving such information by his or her physician along with a completed Change, Replacement or Surrender Request, DH8012-OCU-10/2016.

(11) Requests to replace a lost or stolen card will require the applicant to submit a Change, Replacement or Surrender Request, DH8012-OCU-10/2016, along with a copy of his or her Florida ID and a \$15 replacement fee.

(12) The department may revoke a Compassionate Use Registry identification card for any of the following, but not limited to:

(a) The patient or legal representative makes material misrepresentations in his or her application;

(b) The patient uses his or her card to obtain cannabis for another individual;

(c) The legal representative uses his or her card to obtain cannabis for an individual who has not designated them as their legal representative or who is not a qualified patient;

(d) The patient or legal representative purchases, obtains, possesses, or uses cannabis not sold by an approved dispensing organization; or

(e) The patient is no longer a qualified patient.

THE FULL TEXT OF THE EMERGENCY RULE IS:

53ER16-60 Holiday MILLIONAIRE RAFFLE™.

(1) Holiday MILLIONAIRE RAFFLE™ is a number-match draw lottery game (also known as an online lottery game) with a limited number of tickets available that will be sold within a limited sales period.

(2) Each Holiday MILLIONAIRE RAFFLE ticket sells for \$20.

(3) Holiday MILLIONAIRE RAFFLE tickets will go on sale October 31, 2016. Sales of Holiday MILLIONAIRE RAFFLE tickets will cease immediately after the 750,000th ticket is sold or at midnight ET on January 2, 2017, whichever occurs first.

(4) Each Holiday MILLIONAIRE RAFFLE ticket will contain a unique raffle ticket number that will be automatically entered into the Grand Prize drawing on January 3, 2017. Tickets purchased by December 26, 2016, will also be entered into one of five weekly drawings based upon the date of purchase. Drawings will be held from tickets sold before midnight (ET) on the last day of the raffle ticket sales period for each drawing. The drawing schedule is as follows:

(6) Holiday MILLIONAIRE RAFFLE tickets will automatically print from the terminal with raffle ticket numbers issued in sequential order from 000001 to 750000 as they are sold throughout the state. Each Holiday MILLIONAIRE RAFFLE ticket will contain only one raffle ticket number. Players cannot select their own raffle ticket numbers.

(7) Holiday MILLIONAIRE RAFFLE tickets cannot be canceled.

(8) Instant \$50 Cash Prize.

(a) Every 40th Holiday MILLIONAIRE RAFFLE ticket sold statewide will be an instant winner of \$50 until the first 100,000 tickets are sold. When a Holiday MILLIONAIRE RAFFLE ticket is produced that entitles the player to an instant prize of \$50, a “winner” audio message will play on the terminal. The Holiday MILLIONAIRE RAFFLE ticket will contain a Lottery prize alert symbol and a message that the ticket holder is an instant winner. The ticket holder’s “Cash Prize Coupon” will be produced from the terminal. Should an issue arise concerning the transaction and/or prize, it is the player’s responsibility to seek resolution of the issue with the retailer and the Florida Lottery prior to leaving the retail location.

(b) Winners can redeem a \$50 Cash Prize Coupon at any Florida Lottery retailer or any Florida Lottery office, or call (850)487-7777 [TDD (850)487-7784] for instructions on how to redeem the Cash Prize Coupon by mail.

(c) Winners must redeem Cash Prize Coupons by midnight (ET) on March 3, 2017. A player choosing to redeem a Cash Prize Coupon by mail must submit the coupon for receipt by the Florida Lottery by March 3, 2017.

(d) The number of \$50 Cash Prize Coupons produced will depend on the number of raffle tickets sold. If at least 100,000

tickets are sold, a maximum of 2,500 \$50 Cash Prize Coupons will be produced.

(e) The odds of winning an instant prize of \$50 are 1:40.

(9) Holiday MILLIONAIRE RAFFLE Drawings. Drawings shall be conducted using a certified random number generation process.

(a) Weekly Drawings. In each weekly drawing, only raffle ticket numbers purchased during the corresponding sales period will be included in the drawing. The first and second raffle ticket numbers drawn will each win a first prize. The third through the fifty-second raffle ticket numbers drawn will each win a second prize. The fifty-third through the two hundred and fifty-second raffle ticket numbers drawn will each win a third prize. A total of 1,260 prizes will be available in the five weekly drawings.

1. In the event that all 750,000 Holiday MILLIONAIRE RAFFLE tickets sell out during a weekly drawing sales period in which there are fewer tickets in the weekly drawing than weekly prizes to be awarded, a two-part drawing for that weekly sales period will be held on the date scheduled. Part one of the drawing will include only those raffle ticket numbers sold during the sales period. Raffle ticket numbers will be drawn to determine the weekly winners starting with the first prize winners and continuing with the second and third prize winners for as many raffle tickets as are sold during the sales period. Part two of the drawing will include all 750,000 raffle ticket numbers, except that, raffle ticket numbers that were included in part one of the drawing and raffle ticket numbers selected in the prior weekly drawings will be excluded and ineligible for a prize. The number of eligible raffle ticket numbers drawn in part two of the drawing will be equal to the total number of first, second and third prizes remaining after part one of the drawing is conducted. Raffle ticket numbers drawn will win, in order drawn, any residual first, second or third prizes not awarded in part one of the drawing. The overall odds of winning a prize in part one of the drawing are 1:1. The overall odds of winning a prize in part two of the drawing are (252 minus the number of raffle tickets included in part one of the drawing) in (750,000 minus the number of raffle tickets included in part one of the drawing and the number of raffle tickets selected in the prior weekly drawings).

2. In the event that all 750,000 Holiday MILLIONAIRE RAFFLE tickets sell out and there are no ticket sales during a weekly sales period, the prizes for that sales period will be awarded in a drawing on the date scheduled. The drawing will include all 750,000 raffle ticket numbers, except that, raffle ticket numbers selected in the prior weekly drawings will be excluded and ineligible for a prize. Prizes will be awarded as set forth in paragraph (9)(a). The overall odds of winning a

prize are 252 in 750,000 minus the number of raffle tickets selected in the prior weekly drawings.

(b) Grand Prize Drawing. In the Grand Prize drawing, all raffle tickets sold during the Grand Prize drawing sales period will be included in the drawing. The first through seventh raffle ticket numbers drawn will each win a grand prize. The eighth through the fourteenth raffle ticket numbers drawn will each win a second prize. The fifteenth through the thirty-fourth raffle ticket numbers drawn will each win a third prize and the thirty-fifth through the five hundred and thirty-fourth raffle ticket numbers drawn will each win a fourth prize. A total of 534 prizes will be available in the Grand Prize drawing.

(c) Holiday MILLIONAIRE RAFFLE drawings shall be public, held in Tallahassee, Florida, and witnessed by an accountant employed by an independent certified public accounting firm. Winning raffle ticket numbers will be available after each drawing on the Florida Lottery's website at flalottery.com. The top prize winning raffle ticket numbers will be available after each drawing at Florida Lottery retailers.

(10) Upon validation of a winning weekly drawing Holiday MILLIONAIRE RAFFLE ticket valued at \$500, the terminal will produce a "continuation ticket" for the Grand Prize drawing. Upon validation of a winning weekly drawing Holiday MILLIONAIRE RAFFLE ticket valued at greater than \$500, the terminal will produce "player claim instructions" and a "continuation ticket" for the Grand Prize drawing. The Holiday MILLIONAIRE RAFFLE continuation ticket automatically issued for the claimant shall be the instrument from which a claim on the Grand Prize drawing will be paid. Holiday MILLIONAIRE RAFFLE tickets and Holiday MILLIONAIRE RAFFLE continuation tickets are the only valid receipts to redeem a prize. Any winning weekly drawing Holiday MILLIONAIRE RAFFLE tickets validated after the Grand Prize drawing will not produce a "continuation ticket."

(11) Winning Holiday MILLIONAIRE RAFFLE tickets valued at \$500 may be presented to a Florida Lottery retailer or Florida Lottery office for payment. Winning Holiday MILLIONAIRE RAFFLE tickets valued at \$1,000, \$5,000, \$10,000 and \$50,000 must be presented to a Florida Lottery office for payment. Winning Holiday MILLIONAIRE RAFFLE tickets valued at \$1,000,000 must be presented at Florida Lottery headquarters in Tallahassee, Florida for payment. Information about procedures for filing a claim can be obtained at flalottery.com or by calling (850)487-7787 (TDD (850)487-7784).

(12) Holiday MILLIONAIRE RAFFLE prizes must be claimed within 180 days from the date of the drawing.

(13) From October 31, 2016, through midnight (ET) on January 2, 2017, Holiday MILLIONAIRE RAFFLE tickets will be available for purchase daily between the hours of 6:00 a.m. and midnight, subject to a retailer’s hours of operation, on-line system availability and Holiday MILLIONAIRE RAFFLE ticket availability.

(14) Players must be at least 18 years of age. Persons prohibited by Section 24.116, F.S., from purchasing a Florida Lottery ticket are not eligible to play.

(15) All Holiday MILLIONAIRE RAFFLE prizes are subject to the provisions of Chapter 24, F.S., and rules promulgated thereunder. Prizes will be paid in accordance with the rule of the Florida Lottery governing payment of prizes. Lottery retailers who sell a winning \$1 million Holiday MILLIONAIRE RAFFLE ticket in the Holiday MILLIONAIRE RAFFLE Grand Prize drawing on January 3, 2017.

The state is coordinating review of the U.S. Army Corps of Engineers' (USACE) federal consistency determination for its Update of the Water Control Manual for the Apalachicola-Chattahoochee-Flint River Basin in Alabama, Florida and Georgia and a Water Supply Storage Assessment, as required by Section 403.061(42), F.S.

USACE is proposing to update the Apalachicola-Chattahoochee-Flint River Basin Master Water Control Manual, including a water supply storage assessment to address potential reallocation of reservoir storage in Lake Sidney Lanier, Georgia, for water supply to Georgia. The USACE action is subject to review for consistency with the enforceable policies of the Florida Coastal Management Program (CMP). The USACE released a Draft Environmental Impact Statement on October 2, 2015 and concluded that its proposed action "is consistent with the enforceable policies of the Florida CMP to the maximum extent practicable." The State of Florida objected to the Draft Environmental Impact Statement as inconsistent with the enforceable policies of the Florida CMP.

USACE has revised its proposed action alternative. On September 26, 2016, Florida Department of Environmental Protection received a supplemental consistency determination from the USACE. The USACE "determined that the PAA is consistent with the enforceable policies of the Florida CMP to the maximum extent practicable."
