SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

(3) Is there a limit on the number of homes you may build for yourself on your property or is there any requirement that you have to show proof of your intentions for the use of the property. The Board reviewed the declaratory statement at its meeting held on August 14, 2020. The Boards Order filed on February 9, 2020, declines to answer the Petition because the questions arise from the past actions of a third party that have already occurred and therefore Petition has no standing to bring this Petition.
