59G-4.251: Prescribed Drugs Reimbursement Methodology

**PURPOSE AND EFFECT:** The purpose of the amendment to Rule 59G-4.251, Florida Administrative Code (F.A.C.), is to update methodology factors contained in the rule, and include definitions.

**SUMMARY:** The amendment specifies changes to the reimbursement calculation for physician administered drugs, removes obsolete or duplicative language, and adds the definition of a new term referenced in the rule.

**SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:**

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the Agency.

The Agency has determined that the proposed rule is not expected to require legislative ratification based on the statement of estimated regulatory costs or if no SERC is required, the information expressly relied upon and described herein: A checklist was prepared by the Agency to determine the need for a SERC. Based on this information at the time of the analysis and pursuant to section 120.541, Florida Statutes, (F.S.) the rule will not require legislative ratification.

THE FULL TEXT OF THE PROPOSED RULE IS:

59G-4.251 Prescribed Drugs Reimbursement Methodology.

(1) This rule applies to all prescribed drug service providers enrolled in the Florida Medicaid program that provide services under the fee-for-service delivery system in accordance with Rule 59G-4.250, Florida Administrative Code, (F.A.C.).

(2) Definitions.

(a) Actual Acquisition Cost for Prescribed Drugs – (AAC) – The National Average Drug Acquisition Cost (NADAC) will be used for the AAC, when available. If the NADAC is unavailable, the AAC will be equal to the wholesaler acquisition cost.

(b) Average Sales Price – (ASP) – The average sales price as reported by prescribed drug manufacturers to the Centers for Medicare and Medicaid Services (CMS).

~~(c)~~ State Maximum Allowable Cost – (SMAC) – The maximum allowable unit cost established by the state; SMAC may be manually set.

~~(d)~~ Usual and Customary Charge – (U&C Charge) – The average charge to all other customers in any quarter for the same drug, quantity, and strength.

~~(e)~~ Wholesaler Acquisition Cost – (WAC) – The cost wholesalers pay for a prescribed drug.

(3) Reimbursement Methodology.

(a) Florida Medicaid reimburses for drugs dispensed by an approved Florida Medicaid pharmacy provider, or a provider enrolled as a dispensing practitioner, in an amount not to exceed the lesser of:

1. The AAC plus a professional dispensing fee (PDF) of \$10.24.
2. The WAC plus a PDF of \$10.24.
3. The SMAC plus a PDF of \$10.24.
4. The provider’s U&C Charge.

(b) The above reimbursement methodology applies to all of the following:

1. Covered outpatient drugs dispensed by a retail community pharmacy.
2. Specialty drugs dispensed primarily through the mail.
3. Drugs not purchased pursuant to the 340B program by a covered entity, as defined in section 340B(a)(4) of the federal Public Health Service Act.

~~4. Drugs acquired at a nominal price, except for drugs purchased through the 340B program or the Federal Supply Schedule (FSS).~~

~~4~~ 5. Drugs dispensed in an institutional or long-term care pharmacy, when not included as part of the floor stock contained in the institution’s cost report.

(4) Florida Medicaid utilizes the actual purchased drug price plus a PDF in the reimbursement methodology for drugs acquired via the Federal Supply Schedule~~FSS~~.

(5) Florida Medicaid utilizes the actual purchased drug price plus a PDF in the reimbursement methodology for drugs acquired via nominal price.

(6) Florida Medicaid reimburses for drugs purchased under the 340B program at the actual purchased drug price, which cannot exceed the 340B ceiling price, plus a dispensing fee of \$10.24. This provision only applies to covered entities, Indian Health Services, tribal organizations, urban Indian pharmacies, and federally qualified health centers that dispense drugs purchased at prices authorized under section 340B of the Public Health Services Act.

(7) Florida Medicaid reimburses for clotting factor to the vendor(s) awarded the state’s hemophilia contract(s) at the negotiated price.

(8) Florida Medicaid reimburses for prescribed drugs administered by a licensed practitioner in an office setting at 106 percent of ASP, as provided by CMS quarterly in the format of drug pricing files, available at <https://www.cms.gov/Medicare/Medicare-Fee-for-Service-Part-B-Drugs/McrPartBDrugAvgSalesPrice/index.html>; or, when no ASP rate is available, at WAC.

~~(9) Florida Medicaid reimburses for prescribed drugs administered in an outpatient facility at WAC.~~

~~(9)~~~~(10)~~ Florida Medicaid reimburses for prescribed drugs purchased under the 340B program administered in an outpatient facility at an amount not to exceed the 340B ceiling price.

~~(10)~~~~(11)~~ Florida Medicaid does not reimburse for investigational or experimental drugs.

(11) The rule is in effect for five years from its effective date.

**PART I GENERAL**

**62-600.200 Definitions.**

Terms used in this chapter shall have the meanings specified below.

(1) through (30) No change.

(31) "Infiltration" means groundwater that enters a collection/transmission system, including service connections, through defective pipes, pipe joints, connections, service connections, manholes, or pump stations. Infiltration does not include, and is distinguished from inflow. Infiltration is generally observed during seasonally high ground water conditions.

(32) "Inflow" means surface water and stormwater that enters a collection/transmission system through service connections, from sources such as roof leaders, cellar drains, yard drains, area drains, drains from wet areas, foundation drains, cross connections between storm sewers and sanitary sewers, catch basins, stormwater, surface runoff, manhole covers, or drainage. Inflow does not include permitted industrial discharges into the collection system or the intentional introduction of water into a collection system to supplement reclaimed water supplies, and is distinguished from, infiltration. Inflow is generally observed during wet weather and in coastal communities, during some high tide flooding events.

(33)~~(34)~~ No change.

(34) "Leakage" or "exfiltration" means wastewater that leaks into surrounding soil from deteriorated, poorly designed, poorly constructed, or otherwise defective collection/transmission systems including from service connections, pipes, manholes, and pump stations.

(59) "Sanitary sewer lateral" means a privately-owned pipeline connecting a property to the main sewer line which is maintained and repaired by the property owner.

(60) "Sanitary sewer overflow" means any overflow, spill, release, discharge, or diversion of wastewater from a domestic wastewater collection/transmission system.

(61) "Satellite collection system" means a collection/transmission system owned or operated by an entity other than the entity that owns the wastewater treatment facility.

**62-600.520 Discharge to Surface Waters – (Coastal and Open Ocean).**

(1) through (5) No change.

(6) The discharge of domestic wastewater through ocean outfalls is prohibited after December 31, 2025, except as a backup discharge that is part of a functioning reuse system or other wastewater management system authorized by the Department. A backup discharge may occur only during periods of reduced demand for reclaimed water in the reuse system, such as periods of wet weather, or as a result of peak flows from other wastewater management systems, and must comply with the advanced wastewater treatment requirements of paragraph 403.086(10)(b), F.S.

This rule is being amended to allow the compensation notice to be electronically sent to the employer; reduce the required size of the compensation notice to 8½ inches by 11 inches; allow the compensation notice to be posted separately or as a part of a Florida and federal labor law poster; and make other necessary updates.

SUMMARY: Updates to forms required by this rule, their posting requirements, and other necessary updates.

(1)(a) Upon issuance of an insurance policy or certificate of membership in a self-insurance fund or a renewal certificate thereof, the insurer or self-insurance servicing agent shall electronically send the compensation notice to the employer or

furnish the employer with a sufficient number of typewritten or printed compensation notices, commonly referred to as the “broken arm poster.” The compensation notice shall be printed on paper or cardboard stock in a size no less than 8½ inches by 11 inches, and have the same form and content as Form DFS-F4-1548, “Workers’ Comp Works For You Poster,” (Rev. 3/10), or Form DFS-F4-2026, “Compensación por accidentes de trabajo labora para usted Poster,” (Rev. 3/10), which are incorporated herein by reference. (1) This rule applies to providers enrolled in the Florida Medicaid program that furnish home health services (home health visits, private duty nursing, and personal care services) ~~or and~~ behavior analysis services to eligible recipients in accordance with Rules 59G-4.130, 59G-4.261, 59G-4.215, and 59G-4.125, Florida Administrative Code (F.A.C.), respectively.

(2) No change.

(3) Electronic Visit Verification.

(a) No change.

(b) For providers participating in the fee-for-service delivery system: –

1. The Agency for Health Care Administration (AHCA) contracts with a vendor(s) to electronically verify the delivery of services provided to recipients in their residence or other authorized setting.

2-1. Providers must document the service encounter for each recipient served (in accordance with the recipient’s approved plan of care) and verify delivery of the services rendered using AHCA’s designated vendor’s EVV system, or the provider’s EVV system which must be interoperable with AHCA’s designated vendor’s EVV system.

~~(c) For providers participating in the Statewide Medicaid Managed Care program Florida Medicaid managed care plans contract with a vendor(s) to electronically verify the delivery of services covered by the managed care plans and provided to recipients in their residence or other authorized setting.~~

~~1. Providers must document the service encounter for each recipient served (in accordance with the recipient’s approved plan of care) and verify delivery of the services rendered using the managed care plan’s designated vendor’s EVV system, or~~

~~the provider's EVV system which must be interoperable with the managed care plan's designated vendor's EVV system.~~

3.(4) Providers who furnish home health or behavioral analysis services must submit claims through the AHCA's designated EVV vendor's system to the Florida Medicaid fiscal agent for services rendered and verified in accordance with prior authorizations in the Florida Medicaid Management Information System. Neither a provider who furnishes home health or behavior analysis services, nor a billing agent of that provider, may submit claims directly to the Florida Medicaid fiscal agent irrespective of any other provision including, but not limited to, Rule 59G-4.001, F.A.C.

(5) This rule is in effect for five years from its effective date.
