PURPOSE AND EFFECT: To clarify that the variations on the term “site survey” in statute and rule have the same meaning.

SUMMARY: The term “site survey” is not defined in statute or in rule. Seven variations on the term appear in statute and in rule: “onsite visit” in section 395.4025(6), (11), (12), F.S.; “site survey” in section 395.4025(15)(d), F.S. and in Rules 64J-2.012(3), 64J-2.015(2), (3), 64J-2.016(9)(c)-(e), F.A.C.; “site review” in section 395.4025(15)(d), F.S.; “site visit” in Rules 64J-2.011(2)(b), (4)(b), 64J-2.012(1) (Table), (k), (l), 64J-2.016(3), (7), (8), F.A.C.; “on-site survey” in Rules 64J-2.015(2), 64J-2.016(3), F.A.C.; “on-site evaluation” in Rule 64J-2.016(1), (2), F.A.C.; and “onsite review” in Rule 64J-2.016(5)(b), F.A.C. In each instance, the variation on the term “site survey” describes the same inspection and observation that the Department is authorized to conduct to verify that a trauma center is compliant with the standards adopted by the Department by rule, irrespective of the method by which the inspection and observation is conducted; i.e., in-person and onsite, remote and offsite, or a combination thereof. The proposed change will clarify that the terms “onsite visit,” “site survey,” “site review,” “site visit,” “on-site survey,” “on-site evaluation,” and “onsite review” all describe the in-person or remote inspection and observation of trauma center operations to determine compliance with trauma center standards.

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the Agency.

The Agency has determined that the proposed rule is not expected to require legislative ratification based on the statement of estimated regulatory costs or if no SERC is required, the information expressly relied upon and described herein: Through its analysis of regulatory costs required as a part of the SERC analysis, the Department has determined this

rule will not require legislative ratification pursuant to Section 120.541(3), F.S.

The change is in response to written comments submitted by the staff of the Joint Administrative Procedures Committee and discussion and subsequent vote by the Board at the public telephonic meetings held November 19, 2020 and March 25, 2021. The rules shall now read as follows:

61G6-9.001 Continuing Education for Reactivation.

As a condition to the reactivation of an inactive license, a licensee must submit proof of continuing education which meets the criteria set forth in Rule 61G6-9.002 or 61G6-9.004, F.A.C.

(1) through (2) No change.

(3) No later than 90 days prior to December 31, 2025, the Board shall review and amend, modify, or sunset this rule if it determines this rule creates barriers to entry for private business competition, is duplicative, outdated, obsolete, overly burdensome, or imposes excessive costs.

61G6-9.004 Continuing Education Requirements for Renewal for Certificateholders and Registrants.

(1) Each person who is certified or registered by the Board must, as a condition of each renewal of the certificate or registration, provide proof of completion of continuing education in one or more courses approved by the Board.

(a) Certified and Registered Electrical Contractors must complete continuing education in the following areas: seven (7) hours technical to include: one (1) hour of an approved provider's specialized or advanced module course, approved by the Florida Building Commission, on any portion of the Florida

Building Code, relating to the contractor's respective discipline; one (1) hour ~~on~~ workers' compensation, one (1) hour ~~on~~ workplace safety, one (1) hour ~~on~~ business practices, and one (1) hour of Florida laws and rules education. For certified electrical contractors engaged in alarm system contracting, two (2) hours on false alarm prevention which is designated as technical education.

(b) Certified and Registered Alarm and Specialty Contractors must complete continuing education in the following areas: seven (7) hours to include: one (1) hour of an approved provider's specialized or advanced module course, approved by the Florida Building Commission, on any portion of the Florida Building Code, relating to the contractor's respective discipline; one (1) hour workers' compensation, one (1) hour workplace safety, one (1) hour business practices, one (1) hour of Florida laws and rules education and two (2) hours on false alarm prevention.

(2) through (3) No change.

(4) For his or her initial license renewal, a A Certified or Registered Electrical Contractor ~~initially~~ licensed 12 or more months prior to the end of ~~the first~~ a biennial period is required to complete 5 hours of continuing education as a condition of renewal. The 5 hours of continuing education must be in the following areas: 1 hour technical, 1 hour business, 1 hour worker's compensation, 1 hour work place safety, and 1 hour laws and rules. For electrical contractors actively engaged in alarm contracting, the remaining 1 hour shall be in false alarm prevention which will satisfy the 1 hour technical requirement.

(5) For his or her initial license renewal , a A Certified or Registered Alarm Contractor ~~initially~~ licensed 12 or more months prior to the end of the first a biennial period is required to complete 4 hours of continuing education as a condition of renewal. The 4 hours of continuing education must be in the following areas: 1 hour worker's compensation, 1 hour work place safety, 1 hour laws and rules and 1 hour false alarm prevention.

(6) For his or her initial license renewal, a A Certified or Registered Specialty Contractor ~~initially~~ licensed 12 or more months prior to the end of a biennial period is required to complete 4 hours of continuing education as a condition of renewal. The 4 hours of continuing education must be in the following areas: 1 hour business; 1 hour worker's compensation; 1 hour work place safety; and 1 hour laws and rules.

(7) For his or her initial license, a A person ~~initially~~ licensed for less than 12 months prior to the end of ~~the first~~ a biennial period need not complete any continuing education as a condition of renewal.
