SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the Agency.

The Agency has determined that the proposed rule is not expected to require legislative ratification based on the

statement of estimated regulatory costs or if no SERC is required, the information expressly relied upon and described herein: During discussion of the economic impact of this rule at its Board meeting, the Board concluded that this rule change will not have any impact on licensees and their businesses or the businesses that employ them. This change will not increase any direct or indirect regulatory costs. 3. A new clubhouse, golf pro shop, bar, kitchen, restaurant golf cart barn and maintenance building.
4. A new state-of-the art driving range, chipping/putting area and teaching facilities including entertainment booths.
5. Infrastructure including entryway, car park, outbuildings, drainage/recirculation systems, computer-controlled irrigation system, lighting, and general landscaping.
6. Management of the renovated site and day to day operations of the redesigned courses.

The City owns the Orangebrook site, which is approximately 245 acres and is bounded by significant corridors including South Park Road, Pembroke Road, and Interstate 95. The site is also conveniently located a few blocks from a Tri-Rail Commuter train station. Orangebrook is a historic 36-hole championship golf course located in the heart of Hollywood, Florida. Originally built as an 18-hole facility in 1933, a second 18-hole course was added in 1959. During its history, Orangebrook played host to the Women’s International 4-Ball golf tournament, which was the longest-running women’s amateur event held at one location in the United States. Past

champions include Babe Zaharias, Peggy Kirk Bell and Louise Suggs. Orangebrook has also played host to the Men’s Amateur 4-Ball golf tournament, which in 1960 was won by Jack Nicklaus and Deane Beman. In addition to its 36 holes of golf, Orangebrook has a Pro Shop, lighted driving range, restaurant with full bar service, and a banquet room with seating for up to 250 people.

On March 12, 2019, residents of the City of Hollywood voted to pass a General Obligation Bond (GO Bond) during a Special Election to fund a variety of city-wide public improvement projects totaling \$165 million. As part of that referendum, residents agreed to invest up to \$24.7 million in improvements to Orangebrook, including the following:

- A new 15,000 sq. ft. multi-use clubhouse
- An ADA accessible nature preserve path, designed with wildlife habitat/biodiversity for walking, jogging, biking, etc.
- Improved course drainage and enhanced water retention capacity
- Renovated 36 holes of golf to include an 18-hole championship course and an 18-hole Par 3 course
- Enhanced putting/chipping area and driving range
- A new 10,000 sq. ft. cart barn
- A new 12,000 sq. ft. maintenance building, course restrooms and starter shack
- New golf cart paths, illuminated 9 holes for evening play, parking lot and entryway signage

The City has determined that the UP has sufficiently met the criteria for consideration as a qualifying project on a preliminary basis and is publishing notice pursuant to Section 255.065, F.S. In accordance with the aforementioned Statute, the City is accepting other proposals for the Orangebrook improvements described above during this notification period. **FINAL ORDER**  
**APPROVING CITY OF KEY WEST ORDINANCE NO.**  
**21-02**

The Department of Economic Opportunity (“Department”) hereby issues its Final Order, pursuant to subsection 380.05(6), Florida Statutes (2020), approving the requested changes to land development regulations (“LDRs”), adopted by the City of Key West, Florida (“City”) by Ordinance No. 21-02 (“Ordinance”).

**FINDINGS OF FACT**

1. Rule 28-36.002, *Florida Administrative Code*, designates the City as an area of critical state concern.
2. The City adopted the Ordinance on January 21, 2021.
3. The Ordinance amends the definitions of “courtyard” and “patio” under Chapter 86 of the City of Key West Land Development Regulations. The Ordinance also amends the Historic Architectural Review Commission design guidelines to provide guidelines for spas and other related equipment and to amend existing regulations regarding decks, patios, hot tubs, spas, pools, and related equipment. The Historical Architectural Review Commission’s design guidelines are also modified to change the definition of “courtyard” and add definitions for the terms “deck”, “landing”, “patio”, “paving”, and “pond”.

**CONCLUSIONS OF LAW**

4. The City may amend its LDRs, but the amendment becomes effective only upon approval by the Department. § 380.05(6), Fla. Stat (2020).
5. “Land development regulations” include local zoning, subdivision, building, and other regulations controlling the development of land. § 380.031(8), Fla. Stat. (2020) The

regulations amended by the Ordinance are land development regulations.

6. The Ordinance is consistent with the City’s Comprehensive Plan generally, as required by subsection 163.3177(1), Florida Statutes (2020), and specifically, with Policies 1A-1.2.1.

7. LDRs enacted, amended, or rescinded within an area of critical state concern must be consistent and in compliance with the principles for guiding development for that area. *See* § 380.05(6), Fla. Stat. (2020) Rule 28-36.003, *Florida Administrative Code* sets forth the Principles for Guiding Development for the City.

8. The Ordinance is consistent and in compliance with the Principles for Guiding Development for the City as a whole, and specifically furthers the following principles:

- (1)(a) Strengthen local government capabilities for managing land use and development; and
- (e) Protection of the historical heritage of Key West and the Key West Historical Preservation District.
- (h) Protection of the public health, safety, welfare, and economy of the City of Key West, and the maintenance of Key West as a unique Florida resource.

WHEREFORE, IT IS ORDERED that the Department finds that Ordinance No. 21-02 is consistent and in compliance with the City’s Comprehensive Plan and Principles for Guiding Development for the City and is hereby **APPROVED**.

This Final Order becomes effective 21 days after publication in the Florida Administrative Register unless a petition is timely filed as described in the Notice of Administrative Rights below. **DONE AND ORDERED** in Tallahassee, Florida.
