RULE NO.: 61G20-1.001 RULE TITLE: Florida Building Code Adopted
PURPOSE AND EFFECT: To adopt the Florida Building Code, 8th Edition (2023), to address the statutorily-mandated triennial update.

SUMMARY: This rule amendment represents the section 553.73(7)(a), F.S., triennial update process. The Florida Building Commission (Commission) has reviewed local amendments to the Code and proposals for modifying the Code and has approved for adoption the Florida Building Code, 8th Edition (2023), which incorporates those proposed modifications which received at least a 75% supermajority vote of the Commission, as well as amendments and modifications previously adopted and required by law to be carried forward into the next edition of the Code. The Commission intends to update the Florida Building Code by amending the language of Rule 61G20-1.001, F.A.C. to incorporate the Florida Building Code, 8th Edition (2023), by reference. The proposed Code is published and available for review via link on the Commission

website, www.floridabuilding.org and at codes.iccsafe.org/public/collections/FL.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

The Agency has determined that this will have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has been prepared by the Agency.

The following is a Summary of the Statement of Estimated Regulatory Costs:

- The rule is not likely to directly or indirectly have an adverse impact on economic growth, private-sector job creation or employment, or private-sector investment in excess of \$1 million in the aggregate within 5 years after the implementation of the rule.
- The rule is not likely to directly or indirectly have an adverse impact on business competitiveness, including the ability of persons doing business in the state to compete with persons doing business in other states or domestic markets, productivity, or innovation in excess of \$1 million in the aggregate within 5 years after the implementation of the rule.
- The rule is likely to directly or indirectly increase regulatory costs, including any transaction costs, in excess of \$1 million in the aggregate within 5 years after the implementation of the rules.
- The number of individuals and entities likely to be required to comply with the rule based on the number of building code administrators/inspectors, electrical contractors, engineers, the construction industry, architects, and interior designers will be approximately 166,934.
- The agency will not incur any costs for implementing or enforcing the proposed rule.
- The cost to any other state and local government entities of implementing the proposed rule is indeterminate.
- The total estimated costs to the individuals and entities that are required to comply with the rule in a 5 year period is in excess of \$1 million in the aggregate within 5 years after the implementation of the rule.
- The estimated number of small businesses that would be subject to the rule is greater than 5,000.
- There are small counties or small cities that will be impacted by the rule.

The Agency has determined that the proposed rule is not expected to require legislative ratification based on the statement of estimated regulatory costs or if no SERC is required, the information expressly relied upon and described herein: the exemption listed in sections 120.541(4) and 120.80(16), Florida Statutes.

FINAL ORDER

APPROVING CITY OF KEY WEST ORDINANCE NO. 23-23

The Florida Department of Commerce (“Commerce”) hereby issues its Final Order, pursuant to Section 380.05(6), Florida Statutes, approving land development regulations adopted by the City of Key West, Florida (“City”), by Ordinance No. 23-23 (“Ordinance”).

FINDINGS OF FACT

1.The City is designated within an area of critical state concern. See § 380.0552, Fla. Stat., and Rule 28-36.002, Fla. Admin. Code.

2.The City adopted the Ordinance on May 16, 2023, and rendered it to Commerce on June 23, 2023.

3.The Ordinance amends Section 86-9, Definition of Terms, by revising the definition of the term “abandon” to clarify the different factors that indicate when a land use is abandoned.

4.In addition, the Ordinance amends Section 122-30, Abandonment of Non-Conforming Use, by clarifying when a non-conforming use is considered abandoned and by eliminating the requirement for removal of all material and equipment associated with an abandoned non-conforming use.

CONCLUSIONS OF LAW

5.Commerce is required to approve or reject land development regulations that are adopted by any local government in an area of critical state concern. See Section 380.05(6), Florida Statutes.

6.“Land development regulations” include local zoning, subdivision, building, and other regulations controlling the development of land. Section 380.031(8), Florida Statutes. The regulations adopted by the Ordinance are land development regulations.

7.The Ordinance is consistent with the City’s Comprehensive Plan generally, as required by Section 163.3177(1), Florida Statutes, and is specifically consistent with Policy 7-1.5.4.

8.All land development regulations enacted, amended, or rescinded within an area of critical state concern must be consistent with the principles for guiding development for that area. See Section 380.05(6), Florida Statutes. The Principles for Guiding Development for the City are set forth in Rule 28-36.003, Florida Administrative Code.

9.The Ordinance is consistent with the Principles for Guiding Development for the City as a whole, and specifically furthers the following Principles:

(a) Strengthen local government capabilities for managing land use and development;

(f)Protection of the value, efficiency, cost-effectiveness and amortized life of existing and proposed major public investments, including:

The Florida Keys Aqueduct and water supply facilities,

Sewage collection and disposal facilities,

Solid waste collection and disposal facilities,

Key West Naval Air Station,

The maintenance and expansion of transportation facilities, and Other utilities, as appropriate;

(g)Minimize the adverse impacts of proposed public investments on the natural and environmental resources of the City of Key West; and

(h)Protection of the public health, safety, welfare and economy of the City of Key West, and the maintenance of Key West as a unique Florida resource.

WHEREFORE, IT IS ORDERED that Commerce finds that Ordinance No. 23-23 is consistent with the City’s Comprehensive Plan and the Principles for Guiding Development for the City and is hereby APPROVED.

This Final Order becomes final 21 days after publication in the Florida Administrative Register unless a petition is timely filed as described in the Notice of Administrative Rights.
