(1) In accordance with the provisions of Section 464.012, F.S., any person who wishes to be licensed as an Advanced Practice Registered Nurse shall submit a completed Advanced Practice Registered Nurse (APRN) Application, form number DH-MQA 1124, 4/2021, hereby incorporated by reference and available at <http://www.flrules.org/Gateway/reference.asp?No=Ref-13335>, and Financial Responsibility, form number DH-MQA 1186, 1/09, hereby incorporated by reference and available at <http://www.flrules.org/Gateway/reference.asp?No=Ref-14025>, or from the Board office or on the Board's website: [www.FloridasNursing.gov](http://www.FloridasNursing.gov).

**64B9-15.0025 CNA Medication Administration.**

With the exception of those aspects of medication administration deemed outside the scope of practice of the certified nursing assistant by Rule 64B9-15.0026, F.A.C., and subject to the approval of the home health agency with whom the certified nursing assistant is employed or the approval of the nursing home facility with whom the certified nursing assistant is employed as a qualified medication aide, any certified nursing assistant who meets the requirements of this rule is authorized to administer medications to a patient of a home health agency or to a resident of a nursing home facility, respectively, as delegated by a registered nurse and as further described in this rule.

(1) through (4) No change.

(5) Education Providers: The certified nursing assistant medication administration training courses in subsections 64B9-15.0025(2) and (4), F.A.C., must be sponsored by a provider of continuing education courses approved by the Board pursuant to Rule 64B9-5.005, F.A.C. To be qualified to teach any such course, the instructor must be a currently licensed registered nurse in good standing in this state, have at least one year of experience teaching adults, and at least one year of professional nursing experience, including one year home health care or one year nursing home facility experience, as appropriate, and the supervision of certified nursing assistants. The education provider or course instructor is ~~will be~~ responsible for issuing a certificate verifying completion of the requisite number of hours and course content. In addition, all of

the training under subsections 64B9-15.0025(2) and (4), F.A.C., must be through in-person instruction.

To the extent the Special Conditions supersede the limit of liability in the PUR 1000, the Special Conditions must address such topic. For purchases made off a State Term Contract, to the extent a Customer attaches Special Conditions to its purchase and such Special Conditions reduce an obligation of the Contractor under the PUR 1000, the Customer shall seek a corresponding equitable reduction in price or equitable increase in other

Contractor obligations. This offset may include reducing liability limits in exchange for a reduction in price or an increase in insurance.

The following changes are made to the PUR 1000:

Page 5, Section 4.c.ii., the second paragraph is changed in the following manner:

Except for defaults of subcontractors at any tier, the Contractor will not be liable for any excess costs if the failure to perform the Contract arises from events completely beyond the control, and without the fault or negligence, of the Contractor. If the failure to perform is caused by the default of a subcontractor at any tier, and if the cause of the default is completely beyond the control of both the Contractor and the subcontractor, and without the fault or negligence of either, the Contractor will not be liable for any excess costs for failure to perform, unless the subcontracted Products were obtainable from other sources in sufficient time for the Contractor to meet the required delivery schedule. If, after termination, it is determined that the Contractor was not in default, or that the default was excusable, the rights and obligations of the parties will be the same as if the termination had been issued for the convenience of the Customer. The rights and remedies of the Customer in this clause are in addition to any other rights and anpubd remedies provided by law or under the Contract. The Customer shall notify the Department of Management Services of any vendor that has met the grounds for placement of the vendor on the Department of Management Services’ Suspended Vendor List, as required in section 287.1351, F.S.

Page 6, Section 5.a. is changed in the following manner:

a. Warranty of Ability to Perform. Upon the effective date of the Contract, and each year on the anniversary date of the Contract, the Contractor shall submit to the Customer a completed PUR 7801, Vendor Certification Form. This requirement will not

apply to purchases off a term contract, as defined in section 287.012, F.S., unless specifically requested in the Contract by the Customer.
