progression for kindergarten to grade 8 and in grade bands for
grade levels 9-12. The access points contained in the state
academic standards provide access to the general education
curriculum for students with significant cognitive disabilities.

RULE NO.: 6A-4.0021 RULE TITLE: Florida Teacher Certification Examinations

PURPOSE AND EFFECT: Pursuant to s. 1012.59, F.S., as amended by Senate Bill (SB) 7002, the proposed rule waives the initial fees for the Exceptional Student Education K–12 or the Elementary Education K–6 subject area examination for examinees meeting the specified criteria. Pursuant to s. 1012.56, F.S., as amended by SB 7002, this rule amendment also incorporates minimum passing scores on the SAT, ACT, and Classic Learning Test (CLT) that may be used to satisfy the mastery of general knowledge requirements for educator certification. The effect of this rule adoption will be greater access to general knowledge certification and certification in Exceptional Student Education K–12 and Elementary Education K–6 subject areas.

SUMMARY: To align with changes made by SB 7002 during the 2024 Legislative session, the proposed rule incorporates additional testing fee waiver eligibilities for specified areas and concordant passing scores on the SAT, ACT, and Classic Learning Test (CLT) to meet the mastery of general knowledge certification requirement.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the Agency.

6A-4.0021 Florida Teacher Certification Examinations.

(1) through (11) No change.

(12) Alternative Assessments: Graduate Record Examinations (GRE) Revised General Test, SAT, ACT, and Classic Learning Test (CLT).

(a) GRE test administrations on or after July 1, 2015, and SAT, ACT, and CLT test administrations on or after March 1, 2016, may be used as an acceptable means of demonstrating a mastery of general knowledge. In all cases, the minimum required score on the GRE, SAT, ACT, and CLT must have been earned during the ten (10) years immediately preceding application and qualification for a certificate, unless otherwise stipulated in law or rule. The GRE scores listed below shall be considered the minimum passing scores that may be used to satisfy the demonstration of mastery of general knowledge requirements. Passing scores are required in each of the general knowledge content areas assessed on the General Knowledge Test, which include writing (essay), English language skills, reading, and mathematics. The table below provides the ~~defines~~ the General Knowledge Test content area subtests for GRE, SAT, ACT, and CLT and corresponding GRE subtest alternatives, followed by the minimum required passing scores to satisfy the General Knowledge requirements for each of the GRE subtests indicated. A passing score on a GRE subtest in an applicable general knowledge content area, as defined in the table below, will satisfy the requirement of demonstrating a mastery of general knowledge for the applicable general knowledge content area.

2. Holds a valid active Temporary or Professional Certificate in Elementary Education K-6 and applies to add a subject coverage in Exceptional Student Education K-12.

(b) To apply for a testing fee waiver, a request must be submitted via the Department of Education, Bureau of Educator Certification website at <https://web03.fldoe.org/TeacherCertFeeWaiver> along with documentation establishing that the applicant meets the requirements for a testing fee waiver per paragraph (15)(a) of this rule.

Where the required documentation submitted does not establish eligibility, due to a name change or other circumstance, the applicant will be notified by the Department within ninety (90) days and afforded the opportunity to submit additional documentation to verify eligibility.

(d) All documents submitted to verify eligibility for the Exceptional Student Education K-12/ Elementary Education K-6 fee waivers will be retained in the certification record maintained by the department and will not be returned to the applicant. Approval for testing fee waivers remains valid for five (5) years from the date issued unless a document used to verify indicates an earlier expiration date or end date of its validity and, in that case, validity of the testing fee waiver expires when the verifying document expires. In no case shall a person use or attempt to use a testing fee waiver if the person does not meet the eligibility criteria set forth in Section 1012.59(4), F.S.

(e) Fees for retake examinations under subsection (4) of this rule may not be waived. Subsequent registration for any examination under subsection (4) of this rule will be considered a retake and not eligible for a fee waiver under this section.

The Petitioner sought a determination from the Board regarding whether chiropractic physicians who directly supervise a trained employee or Chiropractic Assistant to perform a myofascial release, either mechanically or manually, that is customarily billed pursuant to CPT code 97140, would not violate section 460, Florida Statutes. The Notice of Petition for Declaratory Statement was published in Vol. 49, No. 218, on November 8, 2023, in the Florida Administrative Register. The Board, at its meeting held on February 22, 2024, determined that “as part of the practice of chiropractic medicine is defined in Section 460.403(9)(a) and (c), Florida Statutes...chiropractic physicians may lawfully delegate the performance of physical therapy modalities to assistants who are not licensed, whom the chiropractic physician knows to be trained and competent to perform such physical therapy modalities under appropriate supervision.” Wherefore, the Board clarifies that the Declaratory Statement discussed above extends to chiropractic physician lawfully delegating the performance of myofascial release, either mechanically or manually to assistants who are not licensed, whom the chiropractic physician knows to be trained and competent to perform under appropriate supervision, and therefore would not violate Chapter 460, Florida Statutes.
