WHEREAS, on October 24, 2023, the Governor issued Executive Order No. 23-212, renewing Executive Order No. 23-171, as amended by Executive Order Nos. 23-172, 23-174, and 23-175, for 60 days; and

WHEREAS, on December 19, 2023, the Governor issued Executive Order No. 23-244, renewing Executive Order No. 23-171, as amended by Executive Order Nos. 23-172, 23-174, 23-175, and 23-212 for 60 days; and

WHEREAS, Section 4.B. of Executive Order 23-171 gives each state agency the authority to suspend the provisions of any regulatory statute prescribing the procedures for conduct of state business or the orders or rules of that agency, if strict compliance with the provisions of any such statute, order, or rule would in any way prevent, hinder, or delay necessary action in coping with the emergency; and

WHEREAS, the Department's timely performance of emergency response functions related to Hurricane Idalia as assigned by the State Coordinating Officer would be hindered by the application of certain procedures imposed by statute, rule, or order.

NOW THEREFORE, I, J. ALEX KELLY, Secretary of the Florida Department of Commerce, pursuant to the authority granted by Section 4.B. of Executive Order 23-171, find that strict compliance with the following statute would prevent, hinder, or delay any necessary action in coping with the emergency, and I hereby:

1. Waive the \$250,000 funding cap in section 288.018(1)(c), Florida Statutes, for grants entered into for the 2023/2024 grant year with any of the three regional economic development organizations that serve the entire region of a rural area of opportunity designated pursuant to section 288.0656(7), Florida

Statutes. Funds above the \$250,000 cap will be used to respond to the impacts caused by Hurricane Idalia.

This Emergency Order is effective immediately upon execution by the Secretary and shall expire on June xx, 2024, unless modified or extended by further order.

TO INITIATE JUDICIAL REVIEW OF THIS FINAL AGENCY ACTION, A NOTICE OF APPEAL MUST BE FILED WITH THE APPROPRIATE DISTRICT COURT OF APPEAL WITHIN THIRTY (30) CALENDAR DAYS AFTER THE DATE THE FINAL AGENCY ACTION WAS FILED BY THE AGENCY CLERK. THE NOTICE OF APPEAL MUST BE ACCOMPANIED BY THE FILING FEE SPECIFIED IN SECTION 35.22, FLORIDA STATUTES. A COPY OF THE NOTICE OF APPEAL MUST ALSO BE FILED WITH THE DEPARTMENT'S AGENCY CLERK, 107 EAST MADISON STREET, CALDWELL BUILDING, 110, TALLAHASSEE, FLORIDA 32399-4128, AGENCY.CLERK@COMMERCE.FL.GOV. A DOCUMENT IS FILED WHEN IT IS RECEIVED. THE NOTICE OF APPEAL MUST BE SUBSTANTIALLY IN THE FORM PRESCRIBED BY FLORIDA RULE OF APPELLATE PROCEDURE 9.900(A).

AN ADVERSELY AFFECTED PARTY WAIVES THE RIGHT TO JUDICIAL REVIEW IF THE NOTICE OF APPEAL IS NOT TIMELY FILED WITH BOTH THE DEPARTMENT'S AGENCY CLERK AND THE APPROPRIATE DISTRICT COURT OF APPEAL.
