Amendments were also made to the following Group 2 basins: Apalachicola-Chipola, Tampa Bay Tributaries, Charlotte Harbor, Middle St. Johns River, and Lower St. Johns River. The Group 5 amendments included waters in the following basins: Everglades, Indian River Lagoon, and Upper East Coast. These revisions/amendments will be submitted to the United States Environmental Protection Agency (EPA) pursuant to Section 303(d) of the federal Clean Water Act and shall serve to update the previously approved Section 303(d) list of Florida waters.
