(1) Beginning Monday, October 3, 2011, through Tuesday, December 6, 2011, the Florida Lottery will conduct the Dolphins Fin-tastic Fantasy 5® Football Retailer Incentive ("Incentive"). Publix Supermarkets, Inc., Hess Mart, Inc., and 7-Eleven, Inc. retailer chain stores in the following South Florida counties will be included in the Incentive: Collier, Hendry, and Lee in the Lottery's Fort Myers Sales District (District 10); Indian River, Martin, Okeechobee, Palm Beach, and St. Lucie in the West Palm Beach Sales District (District 11); and Broward, Miami-Dade, and Monroe in the Miami Sales District (District 13). (a) A winner of a \$1,000,000 prize may choose one of two payment options for receiving his or her prize. Payment options are "Cash Option" or "Annual Payment." At the time the \$1,000,000 prize is claimed, the terminal will produce a player claim instructions ticket. The winner has sixty (60) days from the date the player claim instructions ticket is produced to file a claim choosing the Cash Option. If a winner does not choose the Cash Option within such time, the Annual Payment option will be applied. Once the winner files a claim and exercises the winner's chosen option, the election of that option shall be final.

(b) Cash Option prizes will be paid in one (1) lump sum cash payment of \$700,000, less applicable federal withholding taxes.

(c) Annual Payment prizes will be paid in twenty (20) equal annual installments of \$50,000, less applicable federal withholding taxes.
