PURPOSE AND EFFECT: The purpose of the proposed rule revision is to update the child application process for VPK. The rule addresses the process of child registration, eligibility determination and enrollment into a VPK class.

SUMMARY: The rule establishes the child application and enrollment process for VPK, including acceptable documents to verify proof of residential and age eligibility. The proposed rule revisions update rule language to add clarity, consistency, and remove unnecessary or obsolete information.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION: The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the Agency.

The Agency has determined that the proposed rule is not expected to require legislative ratification based on the statement of estimated regulatory costs or if no SERC is required, the information expressly relied upon and described herein: the proposed rule revisions do not have a significant impact on the current process for parents seeking to enroll their child in the Voluntary Prekindergarten (VPK) Education program as most of the revisions merely update unnecessary language and replace obsolete information. The current process may indirectly impact an early learning coalition or a VPK provider, however, it is streamlined to create efficiencies overall and therefore does not ultimately have a positive nor negative cost impact.

(1) Child registration. (6) Enrollment. A VPK provider may only enroll a child in the VPK or VPK SIS program after the early learning coalition determines that the child is eligible for the program.
