(1) In order to demonstrate compliance with continuing education requirements, licensees must affirmatively declare attest to completion of the continuing education requirements upon licensure renewal.

(2) The Board will <u>randomly</u> audit <u>a minimum of three</u> <u>percent (3%)</u> at random a number of licensees as is necessary to assure that the continuing education requirements are met.

(a) In addition, licensees audited in the previous biennium who failed to demonstrate compliance will be included with the group of licensees audited for the current renewal cycle.

(b) A failure to produce documentation of compliance with continuing education requirements during an audit will result in the opening of a disciplinary complaint against the licensee for violation of paragraph 61G15-19.001(6)(s), F.A. C. If a violation is proven, the penalty shall be within the guidelines established by paragraphs 61G15-19.004(2)(g)4.i., F.A.C.

(3)(2) The licensee shall retain such receipts, vouchers, certificates, or other papers as may be necessary to document completion of the continuing education pursuant to an audit for four (4) years from the date of completion of the continuing education activity.

In addition, the Board shall use attendance information submitted by the provider to determine whether licensees can demonstrate compliance.

68B-31.0156: Florida East Coast Shrimp Bed: Repeal of Section 370.156, Florida Statutes; Seasonal Food Shrimp Production Closure; Exception; Definition

PURPOSE AND EFFECT: The purpose of this rule amendment is to modify the Commission's Florida East Coast Shrimp Bed regulations, 68B-31.0156, Florida Administrative Code (FAC). The proposed amendment would modify the boundaries of the area off northeast Florida that is open to the commercial harvest of food shrimp during April and May.

The state waters on the Atlantic coast generally extend three nautical miles from the coast. However, in the case of the St. Johns River mouth, the state waters boundary extends three nautical miles from the offshore jetties that stabilize the entrance to the river. This creates a seaward curve in the state waters boundary in the region. The curvature of this line is referred to by shrimpers in the region as the "bubble."

In 1995, the Marine Fisheries Commission created an exception to the April-May shrimping closure for a portion of the "bubble" at the industry's request. Shrimp in this area were believed to be large enough to be marketable, as were those in adjacent federal waters, and it was easier for the shrimp fleet to operate if they could trawl through the "bubble" when fishing in federal waters instead of having to pick up their nets or trawl around it.

The shrimp industry has requested they be allowed to shrimp throughout the entire "bubble" during the two-month closure so that they can trawl continuously across the entire area. This change would require moving the western boundary of the area open to fishing between 0.5 - 1 mile to the west. Thereby creating a straight line that cuts directly across the base of the "bubble" and approximates a straight line three nautical miles off the mouth of the St. Johns River.

SUMMARY: Modifications to the western boundary line for the allowable harvest area would expand the area slightly and make it easier for the shrimp fishery in the region to operate without negatively impacting the shrimp resource.

(1) It is the intent of this rule to effect the repeal of and replace Section 370.156, F.S. (1995). The Marine Fisheries Commission has determined that the repeal and replacement of this statutory provision will not adversely affect the shrimp resources of the counties of the Florida East Coast Shrimp Bed or of the State of Florida.

(2)(a) Except as provided in paragraph (b), no person shall operate as a food shrimp producer during the months of April or May each year in any waters of the Florida East Coast Shrimp Bed.

(b) Paragraph (a) shall not apply to any person operating as a food shrimp producer during these two months in state waters east of 81°20' 00" West Longitude and north of 30°20' 00" North Latitude a line extending from 81°20.950'W Longitude and 30°26.658'N Latitude and continuing to 81°20.325'W Longitude and 30°21.469'N Latitude.

FINAL ORDER

REJECTING ISLAMORADA ORDINANCE NO. 17-08

The Department of Economic Opportunity ("Department") hereby issues its Final Order, pursuant to sections 380.05(6) and 380.0552(9), Florida Statutes, rejecting land development regulations adopted by the Islamorada, Village of Islands, Florida, Ordinance No. 17-08 (the "Ordinance").

FINDINGS OF FACT

1. The Florida Keys Area is designated by section 380.0552, Florida Statutes, as an area of critical state concern. Islamorada, Village of Islands (the "Village"), is a local government within the Florida Keys Area.

2. The Ordinance was adopted by Islamorada, Village of Islands, on July 13, 2017, and rendered to the Department on August 16, 2017.

3. The Ordinance amends the Islamorada, Village of Islands, Code of Ordinances to allow for the exchange of the Village's Building Permit Allocation System (BPAS) parcels for a privately-owned parcel of land. The exchanged BPAS parcels can only be used to build accessory units, and the privatelyowned parcel will be placed under a Grant of Conservation Easement Agreement.

CONCLUSIONS OF LAW

4. The Department is required to approve or reject land development regulations that are adopted by any local government in an area of critical state concern. *See* sections 380.05(6) and 380.0552(9), Florida Statutes.

5. Islamorada, Village of Islands, is a local government within the Florida Keys Area of Critical State Concern. *See* section 380.0552, Fla. Stat.

6. "Land development regulations" include local zoning, subdivision, building, and other regulations controlling the development of land. Section 380.031(8), Florida Statutes. The regulations adopted by the Ordinance are land development regulations.

7. The Ordinance is inconsistent with the Islamorada, Village of Islands, Comprehensive Plan Objective 3-1.1, and Policy 3-1.1.3. *See* section 163.3177(1), Florida Statutes.

8. All land development regulations enacted, amended, or rescinded within an area of critical state concern must also be consistent with the principles for guiding development for that area. *See* sections 380.05(6) and 380.0552(9), Florida Statutes. The Principles for Guiding Development for the Florida Keys

Area of Critical State Concern are set forth in section 380.0552(7), Florida Statutes.

9. The Ordinance is inconsistent with the Principles for Guiding Development, as a whole, and is specifically inconsistent with the following Principles:

(a) Strengthening local government capabilities for managing land use and development so that local government is able to achieve these objectives without continuing the area of critical state concern designation.

(k) Limiting the adverse impacts of public investments on the environmental resources of the Florida Keys.

WHEREFORE, IT IS ORDERED that the Department finds that the Islamorada, Village of Islands, Ordinance No. 17-08 is inconsistent with the Islamorada, Village of Islands, Comprehensive Plan and the Principles for Guiding Development for the Florida Keys Area of Critical State Concern and is hereby <u>REJECTED</u>.

This Order becomes effective 21 days after publication in the Florida Administrative Register unless a petition is timely filed as described in the Notice of Administrative Rights below.
