11D-8.014 Blood Alcohol Permit - Analyst: Renewal

The Florida Department of Law Enforcement hereby gives notice:

On May 3, 2017, the Alcohol Testing Program of the Florida Department of Law Enforcement (ATP) issued a Final Order granting a waiver of Rule 11D-8.014, F.A.C., to Shibaughan Ramsey. Rule 11D-8.014, F.A.C. requires blood alcohol analysts to satisfactorily determine the blood alcohol level of at least 2 proficiency samples provided by the Department semiannually to remain qualified for a permit to conduct blood alcohol analysis; the waiver permits Petitioner, who was on maternity leave at the time of one of the proficiency cycles, to remain qualified for her permit so long as she participates in the next proficiency cycle. The Petition was filed on February 10, 2017, and notice of the petition was published on February 24, 2017, in Vol. 43, No. 38, of the Florida Administrative Register. No public comments were received. In rendering its decision, the ATP determined that Petitioner would suffer a substantial hardship were the waiver not granted as she would be unable to work until she satisfactorily participated in the next proficiency cycle. FINAL ORDER

APPROVING ISLAMORADA ORDINANCE NO. 17-10

The Department of Economic Opportunity ("Department") hereby issues its Final Order, pursuant to sections 380.05(6) and 380.0552(9), Florida Statutes, approving land development regulations adopted by the Islamorada, Village of Islands, Florida, Ordinance No. 17-10 (the "Ordinance").

FINDINGS OF FACT

- 1. The Florida Keys Area is designated by section 380.0552, Florida Statutes, as an area of critical state concern. Islamorada, Village of Islands, is a local government within the Florida Keys Area.
- 2. The Ordinance was adopted by Islamorada, Village of Islands, on August 24, 2017, and rendered to the Department on September 25, 2017.
- 3. The Ordinance amends the Islamorada, Village of Islands, Code of Ordinances to allow for 15 deed-restricted affordable housing units in multiple future land use categories and

decreasing the bufferyard and setbacks for these affordable housing units.

CONCLUSIONS OF LAW

- 4. The Department is required to approve or reject land development regulations that are adopted by any local government in an area of critical state concern. See sections 380.05(6) and 380.0552(9), Florida Statutes.
- 5. Islamorada, Village of Islands, is a local government within the Florida Keys Area of Critical State Concern. See section 380.0552, Fla. Stat.
- 6. "Land development regulations" include local zoning, subdivision, building, and other regulations controlling the development of land. Section 380.031(8), Florida Statutes. The regulations adopted by the Ordinance are land development regulations.
- 7. The Ordinance is consistent with the Islamorada, Village of Islands, Comprehensive Plan generally, and specifically Policy 1-2.1.4, Objective 3-1.1, and Policies 3-1.1.3 and 3-1.1.4, as required by section 163.3177(1), Florida Statutes.
- 8. All land development regulations enacted, amended, or rescinded within an area of critical state concern must also be consistent with the principles for guiding development for that area. See sections 380.05(6) and 380.0552(9), Florida Statutes. The Principles for Guiding Development for the Florida Keys Area of Critical State Concern are set forth in section 380.0552(7), Florida Statutes.
- 9. The Ordinance is consistent with the Principles for Guiding Development, as a whole, and is specifically consistent with the following Principle(s):
- (a) Strengthening local government capabilities for managing land use and development so that local government is able to achieve these objectives without continuing the area of critical state concern designation.
- (l) Making available adequate affordable housing for all sectors of the population of the Florida Keys.

WHEREFORE, IT IS ORDERED that the Department finds that the Islamorada, Village of Islands, Ordinance No. 17-10 is consistent with the Islamorada, Village of Islands, Comprehensive Plan and the Principles for Guiding Development for the Florida Keys Area of Critical State Concern and is hereby APPROVED.

This Order becomes effective 21 days after publication in the Florida Administrative Register unless a petition is timely filed as described in the Notice of Administrative Rights below.
