Seasonal Harvest Closure

PURPOSE AND EFFECT: The purpose of this rule amendment is to repeal 68B-5.003, Florida Administrative Code, a seasonal harvest closure in Warren Bayou (Bay County), its tributaries, and all waters within 100 yards of the mouth of the bayou.

Warren Bayou is adjacent to West Bay (a segment of St. Andrews Bay in Bay County). In this area, a power plant has historically used water from the bay as a coolant for its energy-generating processes, specifically the coal-fired generators. As a result of this cooling process, artificially-heated water was released into a canal that empties into Warren Bayou. Artificially-heated water bodies can serve as thermal refuges for marine life in winter months and often result in dense aggregations of fish seasonally. In 1993, at the request of Bay County Board of County Commissioners (BOCC), a seasonal closure was implemented in the waters of Warren Bayou to reduce harvest pressure on saltwater fish aggregating in these waters during the cold weather months of November through February.

In March 2016, the power company phased out this power plant's coal-fired generator units and, as a result, warm water is no longer discharged into the surrounding water bodies. The seasonal closure is no longer needed because of the operational changes at the power plant. This rulemaking is being conducted at the request of Bay County BOCC and stakeholders.

The effect of this rule will be to remove an unnecessary closure to harvest of marine fish from Warren Bayou, its tributaries and within 100 yards of the mouth of Warren Bayou and give anglers increased fishing opportunities by allowing fishing in that area year-round.

SUMMARY: This rule will repeal the Warren Bayou Special Seasonal Harvest Closure and allow anglers year-round access to harvest opportunities in Warren Bayou. In addition, it will reduce confusion for anglers who are aware of the power plant's operational changes, but may be unaware the rule remains in effect. This rulemaking is being conducted at the request of Bay County BOCC and stakeholders.

- (1) Beginning May 1, 2017, and continuing through June 25, 2017, ("Promotional Period") the Florida Lottery will conduct as a retailer sales incentive, the GROUPER® Retailer Sales and Triple Sales Commission program. During the Promotional Period, the Florida Lottery will pay Florida Lottery retailers a \$.30 sales commission for each GROUPER® play sold, except as provided in subsection (3) below. The \$.30 sales commission includes the five percent sales commission set forth in Rule 53ER13-46 F.A.C., *Retailer Compensation*, on the purchase price of the \$1.00 PICK 2™ ticket, the \$2.00 FLORIDA LOTTO® with XTRA ticket, the \$2.00 FANTASY 5® with EZmatch™ ticket and a five percent sales commission on the promotional FREE \$1.00 LUCKY MONEY™ ticket included in the GROUPER play.
- (2) As a bonus, during the first thirty-one (31) days of the Promotional Period (May 1, 2017 May 31, 2017 "Triple Sales Commission Period"), the Florida Lottery will pay Florida Lottery retailers an additional \$.60 bonus sales commission for each GROUPER® play sold, except as provided in subsection (3) below, for a \$.90 total sales commission (or triple sales commission).
- (3) If the Quick Pick numbers selected for the PICK 2 game have been cut off for the day due to the game's liability limit being reached so that the PICK 2 ticket does not print, the purchase price of the transaction will be automatically adjusted, and the retailer will receive the otherwise applicable sales commission (depending on the transaction date) on only the remaining GROUPER tickets, including the promotional FREE \$1 LUCKY MONEY ticket.
- (4) GROUPER \$.30 sales commissions will be reflected on the retailer's weekly Settlement Report.

- (5) GROUPER \$.60 bonus sales commissions will be reflected on the retailer's weekly Settlement Report at the conclusion of the Triple Sales Commission Period.
- (6) Retailers whose Florida Lottery contracts are terminated or inactivated prior to payment of the \$.60 bonus sales commissions shall be paid the commissions earned provided said termination or inactivation was not due to noncompliance with Chapter 24, Florida Statutes, Chapter 53, Florida Administrative Code, or terms of the retailer contract.
- (7) GROUPER \$.60 bonus sales commissions will be considered compensation to the retailer for Internal Revenue Service purposes. The Florida Lottery reserves the right to apply a \$.60 bonus sales commission earned against a retailer's outstanding debt to the Florida Lottery.

- (2) Florida Lottery retailers who sell a winning Scratch-Off ticket (also known as an "instant ticket") with a prize of \$1,000,000 or greater will receive a bonus commission of \$2,000 for every \$1,000,000 in prize value. A Scratch-Off ticket prize of \$1,000,000 or greater that is not an even increment of \$1,000,000 will be rounded down to the nearest \$1,000,000.

- (3) Award of a bonus commission is dependent upon the winning Scratch-Off ticket being claimed by the winner.
- (4) Retailers whose Florida Lottery contracts are terminated or inactivated prior to the bonus commission award shall be paid the bonus commission earned provided said termination or inactivation was not due to noncompliance with Chapter 24, Florida Statutes, Chapter 53, Florida Administrative Code, or the retailer contract terms.
- (5) A bonus commission will be considered compensation to the retailer for Internal Revenue Service purposes. The Florida Lottery reserves the right to apply a bonus commission earned against a retailer's outstanding debt to the Florida Lottery, and to award the remaining balance of the bonus commission, if any.
- (6) Bonus commissions are subject to availability of funds appropriated for retailer incentives. This Program is subject to cancellation by future emergency rule if retailer incentive funding is not appropriated or if the Florida Lottery determines that it is no longer in the state's best interest to use such funds for this purpose.
