61G20-3.008 Approval of Product Evaluation Entities, Product Validation Entities, Testing Laboratories, Certification Agencies, Quality Assurance Agencies and Accreditation Bodies

PURPOSE AND EFFECT: Subparagraph 61G20-3.008(4)(a)3., F.A.C., provides for the approval of lumber

grading or inspection agencies which have been approved in accordance with the United States Department of Commerce's Voluntary Product Standard DOC PS20-99, which pertains to American softwood lumber. Products which meet the Department of Commerce's standards, however, are deemed approved pursuant to paragraph 61G20-3.003(1)(a), F.A.C., which effectively means that certification agencies for these products are unnecessary and superfluous. Accordingly, there are no certification agencies currently approved by the Florida Building Commission to certify these products.

Since this rule provision is unnecessary, the Commission intends to remove it.

SUBJECT AREA TO BE ADDRESSED: Criteria for the approval of certification of lumber grading or inspection agencies in the state product approval program.

2. Certification Agencies accredited as meeting the requirements of ISO/IEC Guide 65: General Requirements for Bodies Operating Product Certification Systems or other standard certified as equivalent by the accrediting entity pursuant to Rule 61G20-3.015, F.A.C., and approved by the Commission.

~~3. Lumber grading or inspection agencies approved by the American Lumber Standards Committee (ALSC) or other agency approved by the Commission as equivalent, in accordance with United States Department of Commerce "Voluntary Product Standard: DOC PS 20 99," "American Softwood Lumber Standard."~~

PURPOSE AND EFFECT: The State Board of Administration, Florida Hurricane Catastrophe Fund, seeks to amend Rule 19-8.029, F.A.C., Insurer Reporting Requirements and Responsibilities, to implement Section 215.555, Florida Statutes.

SUMMARY: In general, Rule 19-8.029, F.A.C., Insurer Reporting Requirements and Responsibilities, addresses reporting and examination requirements. The proposed revisions to Rule 19-8.029, F.A.C., Insurer Reporting Requirements and Responsibilities, adopt the 2021-2022 Data Call for exposure reporting, the forms for loss reporting, and forms relating to exposure examinations and claims examinations. As amended, Rule 19-8.029, F.A.C., Insurer Reporting Requirements and Responsibilities, adopts the Data Call and other applicable reporting requirements and examination instruction forms for the 2021-2022 contract year, deletes obsolete or duplicative material, and provides additional clarification.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within

(1) Purpose. This rule specifies certain deadlines and other requirements for insurers that participate in the Florida Hurricane Catastrophe Fund (FHCF).

(2) Definitions. The definitions in the Reimbursement Contract for the applicable Contract Year also apply to this rule and the forms referenced in this rule. In addition, as used in this rule and the forms referenced in this rule:

(a) "Contract Year" is defined in section 215.555(2), F.S.

(b) "Insurer" or "Company" means an insurer that is required to enter into a Reimbursement Contract.

(3) Data Call form.

1. If the Company is responsible for the delay of an examination, the inability to conduct an examination as scheduled, or the inability to complete an examination, the Company shall be required to reimburse the FHCF for all the usual and customary expenses connected to such delay, cancellation, or incompleteness.

2. If the FHCF finds any Company’s records or other necessary information to be inadequate or inadequately posted, recorded, or maintained, the FHCF may employ experts to reconstruct, rewrite, record, post, or maintain such records or information, at the expense of the Company being examined.

3. A Company required to reimburse the FHCF for costs as required in subparagraphs 1. and 2. is liable for interest on the

amount owed to the FHCF from the date the FHCF pays such expenses until the date payment from the Company is received. The applicable interest rate will be the average rate earned by the SBA for the FHCF for the first four months of the current Contract Year plus 5%. The payment of reimbursements or refunds by the FHCF to the Company will be offset by any amounts owed by that Company to the FHCF under this paragraph.

(6) Company contact information. Companies must submit Form FHCF C-1, Company Contact Information, by March 1 preceding each Contract Year to the FHCF Administrator, Paragon Strategic Solutions Inc., 8200 Tower, 5600 West 83rd Street, Suite 1100, Minneapolis, Minnesota 55437. A New Participant must submit Form FHCF C-1 within 30 calendar days after writing its first Covered Policy. This form must be updated by the Company as the information provided thereon changes. The FHCF shall have the right to rely upon the information provided by the Company to the FHCF on this form until receipt by the FHCF of a new properly completed and ~~notarized~~ Form FHCF C-1 from the Company.

(7) Deadlines. If any deadline provided for herein falls on a Saturday, Sunday or on a legal State of Florida or federal holiday, then the actual due date will be the day immediately following the applicable due date which is not a Saturday, Sunday or legal State of Florida or federal holiday.

RULE TITLE: Delegations of Authority to the Executive Director

PURPOSE AND EFFECT: This amendment creates a delegation of authority to the Executive Director in Rule 68-1.009, F.A.C. This delegation will allow the Executive Director to approve acquisition agreements (purchase or option agreements) that include up to \$1,000,000 in Commission funding, or when exceeding \$1,000,000, are subject to Commission approval. This delegation of authority will help streamline and expedite the acquisition process, which is undertaken in partnership with the Department of Environmental Protection, Division of State Lands. Final approval for acquisitions is provided by the Governor and Cabinet. Lands acquired by FWC are important for the conservation of fish and wildlife and to provide public access for hunting and other recreational activities.

SUMMARY: The delegation of authority rule lists the items that the Executive Director can take action on without additional Commission direction. This delegation will allow the Executive Director to approve acquisition agreements (purchase or option agreements) that include up to \$1,000,000 in Commission funding, or when exceeding \$1,000,000, are subject to Commission approval.

59A-3.249 Neonatal Intensive Care Units.

(1) No change.

(2) Level II Neonatal Intensive Care Services. Hospitals that are licensed for Level II NICU beds, but not Level III or Level IV NICU beds may perform only Level II Neonatal Intensive Care Services.

(a) Each Level II NICU must be directed by a board certified pediatrician with experience in the care of newborn infants including intubation and mechanical ventilation, or a board certified neonatologist.

FINAL ORDER

APPROVING MONROE COUNTY ORDINANCE NO. 031-2020

The Department of Economic Opportunity (“Department”) hereby issues its Final Order, pursuant to subsections 380.05(6) and 380.0552(9), Florida Statutes, approving land development regulations adopted by Monroe County, Florida, Ordinance No. 031-2020 (the “Ordinance”).

FINDINGS OF FACT

1. The Florida Keys Area is designated by Section 380.0552, Florida Statutes, as an area of critical state concern. Monroe county is a local government within the Florida Keys Area.
2. The Ordinance was adopted by Monroe County on September 16, 2020 and rendered to the Department on October 16, 2020.
3. The Ordinance amends Section 130-164 of the Monroe County Land Development Code to reduce the open space requirement within the Parks and Refuge land use zoning district from 90% to 50%. The purpose of the Ordinance is to facilitate re-development of parks and recreations facilities within the County after damage from previous storms.

CONCLUSIONS OF LAW

4. The Department is required to approve or reject land development regulations that are adopted by any local government in an area of critical state concern. *See* §§ 380.05(6) and 380.0552(9), Fla Stat.
5. “Land development regulations” include local zoning, subdivision, building, and other regulations controlling the development of land. § 380.031(8), Fla. Stat. The regulations adopted by the Ordinance are land development regulations.
6. The Ordinance is consistent with the Monroe County Comprehensive Plan generally, as required by section 163.3177(1), Florida Statutes, and specifically, with Policy 101.5.25, Future Land Use Densities and Intensities.
7. All land development regulations enacted, amended, or rescinded within an area of critical state concern must be consistent with the Principles for Guiding Development for that area. § 380.05(6) and 380.0552(9), Fla Stat. The Principles for Guiding Development for the Florida Keys Area of Critical State Concern are set forth in subsection 380.0552(7), Florida Statutes.
8. The Ordinance is consistent with the Principles for Guiding Development as a whole, and specifically complies with the following:

(a) Strengthening local government capabilities for managing land use and development so that local government is able to achieve these objectives without continuing the area of critical state concern designation.

(n) Protecting the public health, safety, and welfare of the citizens of the Florida Keys and maintaining the Florida Keys as a unique Florida resource.

WHEREFORE, IT IS ORDERED that the Department finds that Monroe county Ordinance No. 031-2020 is consistent with the Monroe County Comprehensive Plan and Principles for Guiding Development for the Florida Keys Area of Critical State Concern and is hereby **APPROVED**.

This Order becomes effective 21 days after publication in the Florida Administrative Register, unless a petition is timely filed as described in the Notice of Administrative Rights below.
