However, the timeframes, species, and bag/possession limits allowed by current and pending federal rules differ from state rule. This proposed rule would update FWC regulations regarding these trips for reef fish to be consistent with existing rules for the Atlantic and rules for the Gulf of Mexico that are pending approval by the U.S. Secretary of Commerce. Consistent regulations to federal rules will help reduce regulatory confusion and ease enforcement compliance. RULE NO.: 68B-6.004
RULE TITLE: Western Dry Rocks Seasonal Closure

PURPOSE AND EFFECT: The purpose of this rule amendment for state waters within the Florida Keys National Marine Sanctuary is related to fishing regulations found in 68B-6, Florida Administrative Code (F.A.C.), at Western Dry Rocks. The Florida Fish and Wildlife Conservation Commission (Commission) is establishing a seasonal closed area to protect multi-species fish spawning aggregations thereby sustaining and potentially enhancing fishery populations. Western Dry Rocks is a spawning aggregation site for many recreationally and commercially important fish species, including permit, mutton snapper, yellowtail snapper, and gray snapper.

The effect of the rule amendment would seasonally prohibit fishing within a one-square-mile area at Western Dry Rocks, resulting in reduced fishing pressure on fish when they are aggregated for spawning at the site.

SUMMARY: This rule amendment modifies fishing regulations at Western Dry Rocks. The rule amendment seasonally prohibits fishing from May 1 – June 30 in a one-square-mile area at Western Dry Rocks. However, fish may be possessed aboard a vessel, provided such vessel is in continuous transit through Western Dry Rocks, fishing gear is appropriately stowed, and such resources are stowed in a cabin, locker, or similar storage area prior to entering and during transit through Western Dry Rocks.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the Agency.

68B-6.004 Western Dry Rocks Seasonal Closure

(1) WESTERN DRY ROCKS – For purposes of the restrictions specified in subsection (2) below, Western Dry Rocks shall consist of all state waters located within the following geographic boundary coordinates:

Point	Latitude	Longitude
1	24°26.217’N	81°57.007’W
2	24°25.676’N	81°57.002’W
3	24°25.686’N	81°55.489’W
4	24°26.227’N	81°55.493’W

(2) Fishing and possession of fish are prohibited within Western Dry Rocks, described in subsection (1), from May 1 through June 30. However, fish may be possessed aboard a vessel, provided such vessel is in continuous transit through Western Dry Rocks, fishing gear is appropriately stowed, and such resources are stowed in a cabin, locker, or similar storage area prior to entering and during transit through Western Dry Rocks. For the purpose of this subsection, appropriately stowed means hooks cannot be baited, and spear shafts shall not be inserted into any spearing device. All hook-and-line gear, spearing equipment, nets, and other harvesting equipment must be secured in a manner that makes their immediate use impracticable.
