Notice is hereby given that the following changes have been made to the proposed rule in accordance with subparagraph 120.54(3)(d)1., F.S., published in Vol. 47 No. 187, September 27, 2021 issue of the Florida Administrative Register.

The changes are in response to written comments submitted by the staff of the Joint Administrative Procedures Committee and discussion and subsequent vote by the board at a public meeting held October 13, 2021. The changes are as follows:

**61G15-22.0002 Licensure Change of Status, Reactivation;  
Reinstatement of Void Licenses.**

(1) through (2) No change.

(3) Reinstatement of Void Licenses. Persons previously licensed as professional engineers in Florida may not re-apply for licensure by examination or by endorsement pursuant to Section 471.013 or 471.015, F.S. Rather, pursuant to Sections 455.271(6) and 471.019, F.S., any person previously licensed as a professional engineer in Florida whose Florida license has become void must apply for reinstatement of the previous license. Application for reinstatement shall be made on form FBPE/023, Change of Status Application, referenced in subsection (1). In addition to a completed application form, all applications for reinstatement shall be accompanied by the following.

- (a) No change.

(c) Passage of the Board’s Laws and Rules Study Guide as detailed in Rule 61G15-20.0016; and

(d) No change.

2. Applicants not currently in active practice as a professional engineer must provide proof of completion of thirty-six (36) hours of Board approved continuing education, including two (2) hours of professional ethics and a one (1) hour course in Florida Laws and Rules. With the exception of the one (1) hour Florida Laws and Rules course, which can be taken online, the remaining thirty-five (35) hours must be either in-person or synchronous live streaming / videoconference / interactive webinar OR obtained through distance learning CE courses provided by a national or Florida statewide engineering society or association pursuant to Rule 61G15-22.011, F.A.C.; other online or distance learning courses will not be accepted.

(4) No later than 90 days prior to December 31, 2026, the Board shall review and consider amendment, modification, or repeal of this rule if review determines this rule creates barriers to entry for private business competition, is duplicative, outdated, obsolete, overly burdensome, or imposes excessive costs. Failure by the Board to act in accordance with this provision will result in the expiration of this rule on December 31, 2026.

FINAL ORDER

APPROVING CITY OF GROVELAND ORDINANCE NO. 2021-27

The Department of Economic Opportunity (“Department”) hereby issues its Final Order, pursuant to subsection 380.05(6), Florida Statutes, approving a land development regulation adopted by the City of Groveland, Florida, Ordinance No. 2021-27 (the “Ordinance”).

FINDINGS OF FACT

- The Green Swamp Area is designated by section 380.0551, Florida Statutes, as an area of critical state concern. The City of Groveland (“City”) is a local government within the Green Swamp Area.
- The Ordinance was adopted by the City on September 7, 2021, and rendered to the Department on September 9, 2021.
- The Ordinance amends existing provisions by clarifying the maximum impervious surface and minimum open space percentages for properties in the Green Swamp Town Community Type.
- The Ordinance also repeals changes made to the Community Development Code by Ordinance 2020-30.

CONCLUSIONS OF LAW

- The Department is required to approve or reject land development regulations that are adopted by any local government in the Green Swamp Area of Critical State Concern. See section 380.05(6), Florida Statutes.
- “Land development regulations” include “local zoning, subdivision, building, and other regulations controlling the development of land.” Section 380.031(8), Florida Statutes. The regulations adopted by the Ordinance are land development regulations.
- The Ordinance is consistent with the City’s Comprehensive Plan as required by section 163.3177(1), Florida Statutes, generally, and specifically is consistent with Policy 1.2s.
- All land development regulations enacted, amended, or rescinded within an area of critical state concern must be consistent with the principles for guiding development for that area. See section 380.05(6), Florida Statutes. The Principles for Guiding Development for the Green Swamp Area of Critical State Concern are set forth in Rule 28-26.003(1), Florida Administrative Code.
- The Ordinance is consistent with the following Principles for Guiding Development set forth in Rule 28-26.003(1), Florida Administrative Code:

- (1) Minimize the adverse impacts of development on resources of the Floridan Aquifer, wetlands, and flood-detention areas.
- (2) Protect the normal quantity, quality, and flow of ground water and surface water which are necessary for the protection of resources of state and regional concern.
- (3) Protect the water available for aquifer recharge.
- (4) Protect the functions of the Green Swamp Potentiometric High of the Floridan Aquifer.
- (5) Protect the normal supply of ground and surface water.
- (6) Prevent further salt-water intrusion into the Floridan Aquifer.
- (7) Protect or improve existing ground and surface water quality.
- (8) Protect the water-retention capabilities of wetlands.
- (9) Protect the biological-filtering capabilities of wetlands.
- (10) Protect the natural flow regime of drainage basins.
- (11) Protect the design capacity of flood-detention areas and the water-management objectives of these areas through the maintenance of hydrologic characteristics of drainage basins.

WHEREFORE, IT IS ORDERED that the Department finds that the City of Groveland Ordinance No. 2021-27 is consistent with the City of Groveland Comprehensive Plan and the Principles for Guiding Development for the Green Swamp Area of Critical State Concern and is hereby APPROVED.

This Order becomes effective 21 days after publication in the Florida Administrative Register unless a petition is timely filed as described in the Notice of Administrative Rights below.

For the required contents of a petition challenging agency action, refer to subsections 28-106.104(2), 28-106.201(2), and section 28-106.301, Florida Administrative Code.

Depending on whether or not material facts are disputed in the petition, a hearing will be conducted pursuant to either section 120.569 and subsection 120.57(1), Florida statutes, or Section 120.569 and subsection 120.57(2), Florida statutes.

Pursuant to section 120.573, Florida statutes, and chapter 28, part iv, Florida administrative code, YOU ARE NOTIFIED THAT mediation is not available.
