- (3) The unearned premium reserve account is calculated as follows:
- (a) For all one year policies, the minimum reserve for all legal expense <u>insurance</u> corporations shall be 50% of the gross written premium for which the corporation is obligated on all policies issued in any state.
- (b) A <u>legal expense insurance corporation eompany</u> may count as one-month policies those policies which are paid by the month and can be cancelled by either party with 30 days notice. The reserve amount required on monthly policies is one-half of the total monthly gross written premium. The <u>legal expense insurance corporation eompany</u> must specify if <u>the reserve is calculated</u> they are calculating the reserve on a monthly basis.
- (c)1. For all multiyear policies issued in any state the reserve shall initially be calculated at 50% of the gross written premium for the first year premium, and 100% for each subsequent year's premium, for all gross written premiums for which the <u>legal expense insurance</u> corporation is obligated.
- 2. As each subsequent year becomes current, 50 percent of that current year's premium is earned and shall be subtracted from the reserve.
- 3. The reserve is maintained until the expiration of the multiyear policy.
