The UP was submitted by GC Development of Lake County, Inc. and accepted by the City.

More specifically, the project proposed in the UP includes:

The City owns the Parking Garage site, which is bounded by the significant U.S 301 corridor and a railroad yard (approximate size is 108' x 168' (one-quarter block)). The City also owns the Commercial Site which is likewise bounded by the significant U.S. 301 corridor and a railroad yard. The Commercial Site is made up of four (4) parcels consisting of three downtown-style buildings and a small vacant rear lot.

The City has determined that the UP has sufficiently met the criteria for consideration as a qualifying project on a preliminary basis and is publishing notice pursuant to Section 255.065, F.S.
