The effect of the rule amendment would be to establish consistent recreational bag and vessel limits for shortfin mako in state and federal waters off Florida.

SUBJECT AREA TO BE ADDRESSED: Subject areas addressed in the rule development notice include recreational bag and vessel limits for shortfin make shark in Florida state waters.
