The new FSU Football Operations Facility will be located on the main FSU Campus adjacent to the Indoor Practice Facility (IPF) in the Athletic complex. This new facility will provide space for football operations and include a variety of specialized spaces for football including team segment/position rooms, team meeting rooms, locker rooms, an equipment area, a nutrition area, a hydrotherapy area, trophy/display areas, player's lounge, coaches' offices/meeting rooms, conditioning areas, and a new weight room that will connect to the existing IPF and other gameday and support spaces. The project will also include exterior site work that includes hardscape/plazas, parking adjustments, and any practice field repair/replacement work that is required. The design is being developed by Populous, Kansas City, Missouri and the program will add approximately 150,000 gsf of new space.

It is expected that the football department will remain functional during the project and temporary accommodations to be made including mav need phasing. Renovation/remodeling to other existing and related athletic venues, such as the Moore Center when vacated, may be added if funding should become available. The selected construction manager, at the discretion of the University, may be contracted for this work as well. LEED Silver Certification (v.4) by the USGBC will be sought. The estimated project budget is \$90,000,000, and the construction budget is approximately \$70,000,000. An updated facility program is in development and will be made available to the applicants.

The contract for construction management services will consist of two phases. Phase one is pre- construction services, for which the construction manager will be paid a fixed fee. Phase one services include value engineering, constructability analyses, development of a cost model, estimating, and the development of a Guaranteed Maximum Price (GMP) at 100% Construction Document phase. The final determination of the exact timing of the GMP will be confirmed prior to entering a contract with the prospective Construction Manager. If the GMP is accepted, phase two, the construction phase, will be implemented. In phase two of the contract, the construction manager becomes the single point of responsibility for performance of the construction of the project and shall publicly bid trade contracts, encouraging the inclusion of Small and/or Minority Owned Business Enterprises. Failure to negotiate an acceptable fixed fee for phase one of the contract, or to arrive at an acceptable GMP within the time provided in the agreement may result in the termination of the construction manager's contract.

Selection of finalists for interviews will be made based on construction manager qualifications, including experience and experience; capacity; ability; bonding recordkeeping/administrative ability, critical path scheduling expertise; cost estimating; cost control ability; quality control capability; and qualifications of the firm's personnel, staff, and consultants. As required by Section 287.133, Florida Statutes, a construction management firm may not submit a proposal for this project if it is on the convicted vendor list for a public entity crime committed within the past 36 months. The selected construction management firm must warrant that it will neither utilize the services of, nor contract with, any supplier, subcontractor, or consultant more than \$50,000.00 in connection with this project for a period of 36 months from the date of their being placed on the convicted vendor list.
