PURPOSE AND EFFECT: The Florida Fish and Wildlife Conservation Commission is modifying cobia recreational and commercial size, bag, and vessel limits based on the results of a recent stock assessment and stakeholder concerns about the status of the cobia fishery. A recent stock assessment determined cobia is undergoing overfishing, and the Gulf of Mexico and South Atlantic Fishery Management councils recently took action to amend cobia regulations in federal waters to reduce harvest and improve stock abundance.

The purpose of these rule changes for cobia is to help end overfishing, improve stock abundance, and ensure future fishing opportunities.

The effect of the rule amendments is to increase the size limit from 33 to 36 inches fork length in all state waters, reduce commercial bag limit from 2 to 1 fish per harvester per day for Atlantic state waters, and reduce the commercial and recreational vessel limit from 6 to 2 fish per vessel per day for Atlantic state waters.

SUMMARY: These rule amendments modify cobia size, bag, and vessel limits for commercial and recreational fishermen in state waters. These amendments are consistent with pending regulations in adjacent federal waters.

harvest or possession of cobia in excess of the applicable bag limits.

(2) Commercial Bag Limits –

(a) <u>Bag Limit – A commercial harvester may not harvest or</u> <u>land from Florida Waters, or possess in or on Florida Waters,</u> <u>more than 1 cobia per day.</u> <u>Atlantic Region – A commercial</u> <u>harvester may not harvest or land from the Atlantic Region, or</u> <u>possess in or on waters of the Atlantic Region, more than 2</u> <u>cobia per day.</u>

(b) <u>Vessel Limit – The commercial harvesters aboard a</u> vessel in or on Florida Waters may not collectively possess or land more than 2 cobia, regardless of the number of persons onboard. This provision will not be construed to authorize harvest or possession of cobia in excess of the applicable bag limits. Gulf Region – A commercial harvester may not harvest or land from the Gulf Region, or possess in or on the waters of the Gulf Region, more than 1 cobia per day.

(3) General Vessel Limit -

(a) Atlantic Region The persons aboard a vessel in or on waters of the Atlantic Region may not collectively possess more than 6 cobia, regardless of the number of persons onboard. This provision will not be construed to authorize harvest or possession of cobia in excess of the applicable bag limits.

(b) Gulf Region The persons aboard a vessel in or on waters of the Gulf Region may not collectively possess more than 2 cobia, regardless of the number of persons onboard. This provision will not be construed to authorize harvest or possession of cobia in excess of the applicable bag limits.

Endangered and Threatened Native Flora Conservation Grants Program

The FDACS' Division of Plant Industry is soliciting applications for review for the 2023 ENDANGERED AND THREATENED NATIVE FLORA CONSERVATION

GRANTS PROGRAM. The program was authorized by the 1997 Florida Legislature to support the protection, curation, propagation, reintroduction and monitoring of native plant species of the state that are endangered or threatened and is contingent on an annual appropriation.

Who is eligible to apply?

By law, a qualified corporation is:

• a not-for-profit corporation pursuant to s. 501(c) (3) of the Internal Revenue Code of 1954.

• is described in, and allowed to, receive contributions pursuant to the provisions of, s. 170 of the Internal Revenue Code of 1954.

• is a corporation not for profit, incorporated pursuant to Chapter 617 Florida Statutes.

• can demonstrate, based on program criteria described below, the ability to protect, conserve, propagate, reintroduce and monitor endangered and threatened native flora.

What specific criteria must the applicant document to be eligible for consideration?

The law requires that each applicant must successfully document:

(1) Existing conservation experience with endangered and threatened native flora.

(2) Existing facilities appropriate for program needs.

(3) Existing programs administered by the corporation that successfully protect, conserve, propagate, reintroduce, and monitor native flora.

(4) Existing record keeping and data that is accessible to national databases of endangered and threatened plants.

(5) Qualified staff with demonstrated experience in native plant conservation.

(6) Documentation of collaboration with related state, national, or international conservation programs.

(7) Successful experience propagating and reintroducing endangered and threatened native flora.

(8) Public exhibit programs publicizing the conservation of native species and the importance of the conservation effort.

(9) Fiscal stability and ability to match grant funding.

What projects are eligible for funding?

Activities which may receive Endangered and Threatened Native Flora Conservation grant funding are:

• Activities which provide recognition of those native floras to the state that are endangered and threatened.

• Activities that encourage, within a controlled program, the protection, curation, propagation, reintroduction and monitoring of native flora that are identified as endangered or threatened.

Local Match

In all cases, applicants eligible to receive state funds must document matching funds. Local match may be in the form of cash, in-kind services, donated services, or materials.

Application Deadline

To be considered for funding, applications must be delivered to the Division of Plant Industry on or before <u>5:00 p.m., July 31,</u> <u>2022</u>, or clearly postmarked or show evidence of submission to an express mail service on or before the same time and date. Application Review and Project Selection

All eligible applications will be evaluated on a competitive basis by the Endangered Plant Advisory Council at a public meeting scheduled for the fall of 2022. The Council consists of members appointed by the Florida Commissioner of Agriculture. The Council will review the applications in accordance with the criteria and procedures established in Florida Statute 581.185 and Rule-Chapter 5B-40, Florida Administrative Code. The Council will make а recommendation, based on applications received and the qualifications of each applicant, to the Commissioner of Agriculture. A level of funding (full or partial) will be suggested for each project recommended.

Final selection of projects for inclusion in the Department of Agriculture and Consumer Services 2023 legislative budget request will be made by the Florida Commissioner of Agriculture and will be based on Council recommendations.

The selection will not result in an immediate grant award. Rather, the proposed grants will be subject to approval of the Department's budget request before the 2023 Legislature. The award and level of funding of each project will be subject to legislative consideration.

If projects receive 2023 legislative funding, funds will become available after July 1, 2023, the beginning of the next fiscal year. The funds will need to be obligated by June 30, 2024. Any unexpended balance of grant funds not under terms of a contract will revert to the state.

Administrative Requirements

To receive grant funds, grantees will be required to sign a grant award contract. The grant award contract shall be prepared by the Division and shall contain by reference all regulations, rules, and other conditions governing the grant award. In addition, each grant recipient shall cause an annual post audit to be conducted by an independent certified public accountant. The annual audit report must be submitted to the Department for review.
