The purpose of the rule amendment will be to incorporate new language related to the governing of credit for law enforcement training and incorporation of a law enforcement course equivalency list for use by Florida's public postsecondary institutions to award credit or clock hours for courses taken by current and former law enforcement officers. Additionally, the rule amendment will update the Credit-by-Examination Equivalencies list and the Military Credit Equivalency List for the 2023-2024 academic year, both of which are incorporated by reference.

**SUBJECT AREA TO BE ADDRESSED:** The uniform awarding of credit for law enforcement training, the uniform award of credit for military experience, and credit-by-exam.

**PURPOSE AND EFFECT:** To move the application form from a paper-based format to an online format to streamline the review and recognition process. This will allow downloading of MSID numbers and school names for certificates, principal's email and school mailing addresses for correspondence, principal's and superintendent's acknowledgement statements, website links, and other evidence of meeting the Purple Star criteria for reviewers.

**SUMMARY:** The Purple Star School of Distinction Designation recognizes schools that support the unique needs of military families by helping military-connected students navigate critical challenges and providing resources for military-connected students when transitioning to a new school environment. The rule provides criteria on how to obtain the distinction and the renewal process.
