- (c) Tampa Bay Region <u>One (1) snook per day</u> A person may not harvest, land, or possess a snook within the Tampa Bay Region.
- (d) through (i) No change.
- (2) Regional Recreational Vessel Limits
- (a) Except as provided in paragraph (b) for the Tampa Bay Region, two or more recreational harvesters aboard a vessel within or without Florida Waters may not collectively harvest or land more than two (2) snook per day, or possess within or without Florida Waters more than two (2) snook.

(b) The persons aboard a vessel in or on waters of the Tampa Bay Region may not harvest, possess, or land a snook.

(e) This provision will not be construed to authorize harvest or possession of snook in excess of applicable bag limits.

FINAL ORDER APPROVING CITY OF MARATHON ORDINANCE NO. 2023-13

The Department of Commerce (the "Department") hereby issues its Final Order, pursuant to Section 380.05(6), Florida Statutes, approving land development regulations adopted by the City of Marathon (the "City"), Ordinance No. 2023-13 (the "Ordinance").

FINDINGS OF FACT

1. The Florida Keys Area is designated by Section 380.0552, Florida Statutes, as an area of critical state concern. The City is a local government within the Florida Keys Area.

2. The Ordinance was adopted by the City on August 8, 2023 and rendered to the Department on August 15, 2023.

3.The Ordinance amends Section 108.15 of the City's Land Development Code ("Code") to remove outdated provisions relating to the signage restrictions for certain nonconforming businesses and to ensure consistency with other signage provisions throughout the Code.

CONCLUSIONS OF LAW

4.The Department is required to approve or reject land development regulations that are adopted by any local government in an area of critical state concern. See Section 380.05(6), Florida Statutes.

5."Land development regulations" include local zoning, subdivision, building, and other regulations controlling the development of land. Section 380.031(8), Florida Statutes. The regulations adopted by the Ordinance are land development regulations.

6.The Ordinance is consistent with the City's Comprehensive Plan as required by Section 163.3177(1), Florida Statutes, generally, and is specifically consistent with Goal 1-1, Objective 1-1.1, Policy 1-1.1.2., Goal 9-1, and Objective 9-1.1. 7.All land development regulations enacted, amended, or rescinded within an area of critical state concern must be consistent with the principles for guiding development for that area. See Section 380.05(6), Florida Statutes. The Principles for Guiding Development for the Florida Keys Area of Critical State Concern are set forth in Section 380.0552(7), Florida Statutes.

8.The Ordinance is consistent with the Principles for Guiding Development in Section 380.0552(7), Florida Statutes and is specifically consistent with the following Principles:

(a)Strengthening local government capabilities for managing land use and development so that local government is able to achieve these objectives without continuing the area of critical state concern designation.

(f)Enhancing natural scenic resources, promoting the aesthetic benefits of the natural environment, and ensuring that development is compatible with the unique historic character of the Florida Keys.

WHEREFORE, IT IS ORDERED that the Department finds that the City of Marathon Ordinance No. 2023-13 is consistent with the City of Marathon's Comprehensive Plan and the Principles for Guiding Development for the Florida Keys Area of Critical State Concern and is hereby APPROVED.

This Final Order becomes final 21 days after publication in the Florida Administrative Register unless a petition is timely filed as described in the Notice of Administrative Rights below.
