These amendments implement recent statutory changes by requiring an email of record on the Motor Vehicle Repair Registration Application and designating new violations in the penalty section. In addition to the required statutory changes,

the form has been streamlined and the fine amounts for violations have been amended.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the Agency.

The Final Order was in response to a Petition for an emergency permanent Variance from Mediterra Beach Club located at 26110 Hickory Blvd., Bonita Springs, FL 34134, filed October 18, 2023, and advertised on October 23, 2023, in Vol. 49, No. 206, of the Florida Administrative Register. No comments were received in response to the petition. The Final Order on the Petition for Variance grants the Petitioner a variance from Rules 2.4.1.5 and 2.15.9.2, ASME A17.1, 2016 Edition, as adopted by Rule 61C-5.001 Florida Administrative Code that requires when the car is resting on its fully compressed buffers or bumpers, no part of the car, or any equipment attached thereto or equipment traveling with the car, shall strike any part of the pit or any equipment mounted therein and The guard plate shall have a straight vertical face, extending below the floor surface of the

platform. A horizontal door guiding groove is permitted below the floor surface for door operating devices, door guiding devices, and door retaining devices in accordance with 2.15.9.5. The guard plate shall conform to one of the following: (a) where the elevator is required to conform to 2.19.2.2(b) the depth of the truck zone, where provided plus 75 mm (3 in.), but in no case less than 1 220 mm (48 in.) (b) where the elevator is not required to conform to 2.19.2.2(b) the depth of the leveling zone or truck zone, where provided, plus 75 mm (3 in.), but in no case less than 525 mm (21 in.) from the floor surface, because the Petitioner has demonstrated that the purpose of the underlying statute has been met and that Petitioner would suffer a substantial hardship if required to comply with this rule (VW2023-123).
