#### THE FULL TEXT OF THE PROPOSED RULE IS:

64B18-17.001 Continuing Education Required for License Renewal.

(1) All actively licensed podiatric physicians shall obtain continuing education that which contributes to the reduction of risk in the practice of podiatric medicine and the advancement, extension or enhancement of professional skill and knowledge in the field of podiatric medicine and the licensee's understanding of the regulatory law and rules which govern the practice of podiatric medicine. The continuing education that

contributes to the advancement, extension or enhancement of professional skill and knowledge in the field of podiatric medicine, shall focus on subjects that which are primarily scientific in nature and of significant benefit to the podiatric physician on a post-graduate level. No commercial laboratories will be approved for continuing education credit because those laboratories are designed primarily to demonstrate equipment and procedures for the purpose of making a sale.

- (2) All licensees who seek to renew the active status of their licensure must demonstrate that they have completed, during the previous two years, at least forty (40) hours of continuing education.
- (a) Within each license renewal biennium, a licensed podiatric physician shall complete a minimum of 32 hours via live in-person, or live interactive virtual events of professional continuing education, according to the criteria set forth in these rules. A maximum of 8 hours of continuing professional education may be earned from courses involving home study or anytime courses.
  - (a) through (b) renumbered (b) through (c) No change.

(d)(e) At least one two (2) 2-hour course of the forty (40) hours must be on the subject of prevention of medical errors pursuant to section 456.013(7), F.S.

(e)(d) At least two (2) of the forty (40) hours must be on the safe and effective prescribing of controlled substances, as required by sSection 461.007, F.S.

- (e) through (g) renumbered (f) through (h) No change.
- (i) All 40 hours may be earned through live in-person or live interactive virtual events as defined in 64B18-17.002(8)(b), but a maximum of only eight (8) hours may be obtained through homestudy or anytime courses asd defined in 64B18-17.002(8)(a).
  - (3) No change.
- (4) Except for the home study authorized by subsection 64B18 17.002(1), F.A.C., Aa licensed podiatric physician may only receive only up to 8 hours of professional credit for home study continuing education from courses involving home study or anytime coursesprograms taken during the biennium. For the 2020-2022 biennial renewal period, there shall be no cap on the number of credit hours that a licensed podiatric physician may receive for continuing education hours obtained through home study continuing education programs.
  - (5) through (6) No change.
- (7) If the licensee has not actively practiced podiatric medicine for at least 2 years of the immediately preceding 4 years, the board shall require the licensee to successfully complete a board-approved course prior to renewal of the license. For a licensee to have "actively practiced podiatric medicine" as defined in <a href="Section 461.007">Section 461.007</a>, F.S., the annual

practice, teaching, or administration of podiatric medicine must minimally constitute an average of 20 hours per week.

- (8) No change.
- (9) Licensees must retain proof of attendance at continuing education programs for two years subsequent to the expiration of the biennial period for which the programs are claimed. Proof of attendance must be documented by a record of registration or certification of attendance issued by the program which states the number of credit hours received. An acceptable record of registration at a program is a receipt for the program, a copy of an embossed badge identifying the name, date and location of the program, or a copy of the front and back of the canceled check used by the licensee to pay for the program.
- (10) Certified podiatric x-ray assistants must complete <u>a 6-hour board-approved recertification course</u> which includes an <u>examiantion asthe eight hour course</u> set forth in <u>sSection 461.0135</u>, F.S., prior to renewal of certification. <u>Certified podiatric x-ray assistants shall also complete a (2) hour course on the subject of prevention of medical errors pursuant to section 456.013(7), F.S.</u>

Substantial rewording of Rule 64B18-17.002 follows. See Florida Administrative Code for present text.

64B18-17.002 Board Approval of Continuing Education Programs.

#### (1) Automatic Approval.

(a) Continuing education programs, in the areas of podiatric medicine and surgery or relevant to podiatric medicine in that the course will enhance the knowledge and abilities of the podiatric physician in terms of improved quality and delivery of patient care sponsored and approved by the American Podiatric Medical Association (APMA), formerly known as the American Podiatry Association (APA), the Council on Podiatric Medical Education (CPME), formerly

- known as the Council on Podiatry Education (CPE), the American Medical Association (AMA), the American Osteopathic Association (AOA), the American Hospital Association (AHA) or any of their component or affiliate organizations are hereby approved by the Board. Neither those providers nor the programs they provide need to be submitted to the Board for approval.
- (b) Continuing education credit may be obtained, without prior Board approval, for activities that meet the requirements of Rules 64B18-17.003 and 64B18-17.004, F.A.C.
- (2) All other programs must meet the procedures for approval set out in subsection (3), of this rule.
- (3) Procedure for Approval. Except for those programs and activities set out in subsection (1), of this rule, all continuing education providers seeking Board approval to award continuing education credit for programs recognized by the Board for licensure renewal must submit those programs to the Board for approval at least thirty (30) days prior to the presentation of the program. Programs submitted for approval after they have been presented will not be approved retroactively. The Board will not approve any program with less than one (1) hour of instructional content. The approval of the program by the Board shall be valid only until the last day of the biennial renewal period during which approval is granted. In seeking program approval, the provider must remit the application fee of \$250.00 and must demonstrate that the program presenters have either presented or published in the topic area of the program in which they are presenting.
- (4) Procedure for Approval of Live In-Person, or Live Interactive Virtual Events.

For live in-person, or live interactive virtual events to be approved pursuant to subsection (2) of this rule, they must meet the requirements of subsection (3) of this rule, and they must also include the following:

- (a) A detailed, timed outline including a course description and learning objectives that clearly demonstrate to the Board how a Podiatric Physician's skills, knowledge or needs will be enhanced;
- (b) The name and a current detailed curriculum vitae of any instructor or lecturer reflecting competency, qualifications, education, and experience in the subject matter.
- (c) Upon completion of the program, the program provider must distribute, and the participants must complete, an evaluation form. The program provider must maintain the completed evaluation forms for at least (2) two years from the date the program was offered.
- (5) Procedure for Approval of Courses Involving Home Study or Anytime Courses. For home study or anytime courses to be approved pursuant to subsection (2) of this rule, they must meet the requirements of subsection (3) of this rule, and they must also include the following:

- (a) A procedure to ensure notice has been given to licensed podiatric physicians taking home study or anytime courses that no more than 8 hours of home study or anytime courses may be credited toward the licensee's biennial continuing education requirement for license renewal.
- (b) A detailed, timed outline including a course description and learning objectives that clearly demonstrate to the Board how a Podiatric Physician's skills, knowledge or needs will be enhanced;
- (c) A copy of the testing mechanism with associated answers supplied by the provider for demonstration of competency by the licensee in the program's topics. The test must contain a minimum number of five (5) questions.
- (d) The name and a current detailed curriculum vitae of any instructor or lecturer reflecting competency, qualifications, education, and experience in the subject matter.
- (e) A procedure to inform the licensee before the licensee incurs any obligation to pay for the home study or anytime course, that a test must be completed and passed to receive credit for the course.
- (6) The chairperson of the Continuing Education Committee has the authority to act on behalf of the Board in matters pertaining to continuing education. Having exercised that authority, the chairperson shall report to the Board at its next regularly scheduled meeting any actions taken by the chairperson since the last regularly scheduled meeting of the Board.
- (7) The Board may monitor or review any continuing education program approved under subsection (2) of this rule, and, upon evidence of significant variation in the program presented from the program approved, may, before the end of the biennium for which approval is granted, withdraw approval upon the issuance of a Notice of Intention to Withdraw Approval, the finality of which shall accord with the due process provisions of section 120.57, F.S. Nothing herein should be construed to mean that the Board is obliged to continue approval of a program beyond the date for renewal.

#### (8) Definitions:

- (a) Home Study or Anytime Courses are independent studies that require a certificate of completion and an examination. These courses are not date-time specific and do not allow for interaction with a presenter or host.
- (b) Live In-Person or Live Interactive Virtual Events consist of, but are not limited to, live webinars, live teleconference, or interactive online-based applications that allow or require the licensee to interact or communicate back and forth with the instructor during the presentation of the program
- (9) Any Provider offering courses for continuing education credit in the state of Florida, must submit their courses through the states continuing education tracking system.

Notice is hereby given that the following changes have been made to the proposed rule in accordance with subparagraph 120.54(3)(d)1., F.S., published in Vol. 48 No. 246, December 21, 2022 issue of the Florida Administrative Register. In response to JAPC and public comment the rule is amended as follows:

## 6A-10.087, Postsecondary Education Benefits and Services for Students Who Have Been or are in Foster Care or are Experiencing Homelessness.

- (1) Purpose. The purpose of this rule is to set forth the requirements related to <u>tuition and</u> fee exemptions, <u>including lab fees</u>, and services for students who have been or are in foster care and students experiencing homelessness.
  - (2) Definitions.
- (a) "Campus coaching services" means the services that institutions may provide in accordance with Section 409.1452(2), <u>Florida Statutes (F.S.)</u>, to assist students in their successful completion of postsecondary education and transition to independent living.
- (b) "Institution" means a Florida College System institution, school district career center authorized under Section 1001.44, F.S., and charter technical career center authorized under Section 1002.34, F.S.

- (c) "Liaison" means the institution's employee or employees who that are responsible for providing on-campus support for students related to tuition and fee exemptions and related issues, as required by Section 409.1452(1), F.S., for institutions that have students exempt under Section 1009.25, (1)(c) and (1)(e), F.S., and this rule.
- (d) "Students experiencing homelessness" means <u>individuals</u> students of any age who lack a fixed, regular, and adequate nighttime residence. This definition and includes:
- 1. Individuals who are sharing the housing of other persons due to loss of housing, economic hardship, or a similar reason; are living in motels, hotels, trailer parks, or camping grounds due to the lack of alternative adequate accommodations; are living in emergency or transitional shelters; or are abandoned in hospitals; Students who were verified as a homeless child or youth using the following criteria, which are set forth in 42 U.S.C. Section 11434a(2):
- a. Children and youths who are sharing the housing of other persons due to loss of housing, economic hardship, or a similar reason; are living in motels, hotels, trailer parks, or camping grounds—due—to—the—lack—of—alternative—adequate accommodations; are—living—in—emergency—or transitional shelters; or are abandoned in hospitals;
- b. Children and youths who have a primary nighttime residence that is a public or private place not designed for or ordinarily used as a regular sleeping accommodation for human beings; and
- c. Children and youths who are living in cars, parks, public spaces, abandoned buildings, substandard housing, bus or train stations, or similar settings; and
- d. Migratory children who qualify as homeless for the purposes of this part because the children are living in circumstances described in the clauses above.
- 2. Individuals who have a primary nighttime residence that is a public or private place not designed for or ordinarily used as a regular sleeping accommodation for human beings; Students who were verified as lacking a fixed, regular, and adequate nighttime residence as defined in 42 U.S.C. Section 11302(a)(1) but who do not meet the criteria under subparagraph (2)(d)1.
- 3. Individuals who are living in cars, parks, public spaces, abandoned buildings, substandard housing, bus or train stations, or similar settings;
- 4. Migratory children who qualify as homeless for the purposes of 42 U.S.C. Sections 11431-11435; and
- 5. Individuals who would otherwise meet this definition This definition includes a student who meets the requirements of this rule, as determined by the institution, but for their residence in college dormitory housing.
  - (e) No change.

- (3) Exemption for students who have been or are in foster care. Each institution's board shall adopt policies or procedures to must exempt eligible students who have been or are in foster care from the payment of tuition and fees. These policies or procedures must address:
- (a) Eligibility determination and verification. The institution must determine and verify eligibility and maintain related documentation for each student in accordance with Sections 1009.25 and 409.1452, F.S. and this rule. Once eligibility is verified, the institution may not make additional requests for such documentation. Documentation may include the Department of Children and Families' Tuition and Fee Exemption form, CF FSP 5220, or official state documentation (e.g., a court order) that the student received support from the Department of Children and Families in foster care. Students under subparagraph (2)(e)4. must be eligible for the Pell Grant, as determined by the Free Application for Federal Student Aid and verified by the postsecondary institution entity imposing the tuition and fees.
  - (b) No change.
- (c) Enrollment. A student receiving benefits under this rule must be enrolled according to the customary rules and requirements of the institution attended.
- (d) Records Retention. Pursuant to Section 409.1452(1)(b), F.S., each institution must maintain the original documentation submitted by the student regarding his or her eligibility for the tuition and fee exemption under Section 1009.25, F.S. and may not make additional requests for such documentation. Institutions must retain the documentation in accordance with the Florida Department of State's General Records Schedule GS5 For Public Universities and Colleges, Item #89.
- (4) Exemption for students experiencing homelessness. Each institution's board shall adopt and implement policies or procedures to <u>must</u> exempt students experiencing homelessness from the payment of tuition and fees, <u>including lab fees</u>. These policies and procedures must address:
- (a) Eligibility determination and verification. for students who meet the definition of homeless under subparagraph (2)(d)1. The institution must determine and verify eligibility and maintain related documentation for each student in accordance with Sections 1009.25 and 409.1452, F.S., and this rule. Once eligibility is verified, the institution may not make additional requests for such documentation, unless the student informs the institution their circumstances have changed, the institution receives conflicting information regarding a change in the student's independence status, or if the student reenrolls after discontinuing enrollment for twelve (12) consecutive months or more.
- (b)1. Required documentation. Eligibility <u>D</u>documentation for these students must include Form FSH-1, Florida Student Homelessness Verification for Tuition and Fees Exemption

- Purposes, and associated documentation, if applicable, required to establish eligibility in a format determined by the institution. Form FSH-1 (DOS link), effective May 2023, is hereby incorporated by reference and made part of this rule. Copies may be obtained from the Division of Florida Colleges, 325 West Gaines Street, Tallahassee, Florida 32399.
- (c)2. Individuals authorized to certify eligibility. The following individuals are authorized to certify that students meet eligibility under this paragraph subparagraph.: Once a determination that the student is experiencing homelessness is made by one of the authorized individuals below, no further action is needed. Such documentation of the student's circumstances shall be considered adequate.
- <u>1. a. A The</u> designated Florida school district's liaison for homeless children and youths;
- <u>2.</u> b. <u>A</u> The director of an emergency shelter program funded by the United States Department of Housing and Urban Development, or the director's designee;
- 3. e. A The director of a runaway or homeless youth basic center or transitional living program funded by the United States Department of Health and Human Services, or the director's designee; or
  - 4. d. A continuum of care lead agency, or its designee;
- 5. A director of an emergency or transitional shelter, street outreach program, homeless youth drop-in center, or other program serving individuals who are experiencing homelessness, or the director's designee;
- 6. The director of a project supported by a Federal TRIO program or a Gaining Early Awareness and Readiness for Undergraduate program grant under 20 U.S.C. sections 1070a-11 through 1070a-18 and 1070a-21 through 1070a-28, or the director's designee;
- 7. A financial aid administrator at the current postsecondary institution; or
- 8. A financial aid administrator at another institution who documented the student's circumstance in the same or a prior award year.
- (b) Eligibility determination and verification for students who do not meet the definition of homeless under subparagraph (2)(d)2. The institution must determine and verify eligibility and maintain related documentation for each student in accordance with Section 1009.25, F.S. and this rule.
- 1. Required documentation. Eligibility documentation for these students must include Form FSH 1, Florida Student Homelessness Verification for Tuition and Fees Exemption Purposes and at least one document that meets the standards under 20 U.S.C. Section 1087uu 2(a). Associated documentation, if applicable, may be required to establish eligibility.

2. Individuals authorized to certify eligibility. The following individuals are authorized to certify that students meet eligibility under this subparagraph:

a. The director of an emergency or transitional shelter, street outreach program, homeless youth drop in center, or other program serving individuals who are experiencing homelessness, or a designee of the director;

b. The director of an emergency shelter program funded by the United States Department of Housing and Urban Development, or the director's designee;

c. The director of a project supported by a Federal TRIO program or a Gaining Early Awareness and Readiness for Undergraduate program grant under division 1 or 2 of subpart 2 of part A, or a designee of the director;

d. A financial aid administrator at the current postsecondary institution; or

e. A financial aid administrator at another institution who documented the student's circumstance in the same or a prior award year.

(d)3. Case-by-case determinations. If a student is unable to provide documentation from any individual described in paragraph subparagraph (4)(c)(b)2., institutions must make a case-by-case determination, which must be based on a written statement from, or a documented interview with, the student that confirms that the student is an unaccompanied homeless youth, or unaccompanied, at risk of homelessness, and self-supporting; and made without regard to the reasons that the student is an unaccompanied homeless youth, or unaccompanied, at risk of homelessness, and self-supporting.

(e)(e) Tuition and fees. Pursuant to Section 1009.25, F.S., students who meet the eligibility requirements under subsection (4) are exempt from the payment of tuition and fees, including lab fees. The exemption remains valid until the student informs the institution that the student's circumstances have changed or the institution has specific conflicting information about the student's independence and has informed the student of this information.

(5)(d) Enrollment. A student receiving benefits under this rule must be enrolled according to the customary rules and requirements of the institution attended.

(6)(e) Records retention. Pursuant to Section 409.1452(1)(b), F.S., each institution must maintain the original documentation submitted by the student regarding his or her eligibility for the tuition and fee exemption under Section 1009.25, F.S. and may not make additional requests for such documentation. Institutions may request additional documentation if the student reenrolls after discontinuing enrollment for twelve (12) consecutive months or more or if the institution receives conflicting information regarding a change in the student's status. For purposes of these this exemptions, institutions must retain the documentation in accordance with

the Florida Department of State's General Records Schedule GS5 For Public Universities and Colleges, Item #89.

(7)(5) Fraud. If fraud is suspected that a student, employee, or other individual has misreported information or altered documentation to fraudulently allow the student to obtain this tuition and fees exemption, the individual must report his or her suspicions and provide any evidence to the appropriate institutional authority.

(6) Third Attempt. Pursuant to Section <u>1009.285</u>, F.S., a student will be required to pay tuition at one hundred (100) percent of the full cost of instruction upon the third attempt of a course unless the Florida College System institution has granted an exception due to extenuating circumstances.

(8)(7) Reporting requirements. (a) Pursuant to Section 409.1452(3), F.S., the Division of Florida Colleges and the Division of Career and Adult Education are required to annually report specified data to the Department of Children and Families. Florida College System Institutions and school district career centers must maintain documentation and annually report in a format prescribed by the Chancellor of the Division of Florida Colleges and the Chancellor of the Division of Career and Adult Education, respectively, to the Florida Department of Education the on the following:

(a)1- Liaisons. The number of staff members acting as liaisons under Pursuant to Section 409.1452(1), F.S., institutions must provide at least one knowledgeable, accessible staff member to act as a liaison for students exempt from the payment of tuition and fees and provide how the liaison's' contact information to exempt students who are attending the institution, the Department of Children and Families, and community based care lead agencies is communicated; The contact information must also be published and the location of the liaisons' contact information on the institution's website.

(b)2. Student-progress data. Institutions must comply with state reporting requirements regarding Tthe progress of students served by the liaisons, including data on academic progress, retention, financial aid status, and information required by the National Youth in Transition Database.

(c) Value of fee exemptions. The number and value of all fee exemptions granted annually.

(d)3. Campus coaching services. As provided in Section 409.1452(2), F.S., each Whether the institution may provides campus coaching services and other support to exempt a students who is exempt from the payment of tuition and fees under Section 1009.25, F.S. are attending the institution to promote his or her successful completion of postsecondary education and transition to independent living, and if so, the type of services and support provided.

(b) Value of fee exemptions. Each institution shall report to the Florida Department of Education the number and value of all fee exemptions granted annually.
