33-208.002 Rules of Conduct.

The Department of Corrections requires all employees to familiarize themselves with all rules and regulations pertaining to their positions and duties, and requires all employees to abide by these rules and regulations. The following rules of conduct and performance standards are applicable to all employees both on and off the job. Some of these rules of conduct are restated in abbreviated form in Rule 33-208.003, F.A.C. However, all rules of conduct, procedures, post orders, regulations, directives and policy statements are enforceable by appropriate disciplinary action.

(1) through (26) No Change.

(27)(a) No employee shall refuse to submit to a search or inspection by authorized Department staff of his or her person, personal property, or vehicle when entering, exiting, or otherwise being upon the premises of a Department institution or facility. Refusal to submit to such searches or inspections is considered a serious form of insubordination.

(b) All employee property that is introduced into the secure perimeter such as purses, briefcases, lunch boxes, or bags is subject to search at any time by a Department employee of the rank of a correctional officer or higher <u>or other individual</u> <u>authorized to conduct the search</u>.

(c) All employees shall be subject to some form of metal detection search, and items in their possession or on their person shall be inspected prior to entering a Department institution or facility. Employees may also be subject to a clothed pat search as a part of the routine search process. Exterior layers of clothing and accessories such as gloves, scarves, jackets, coats, sweaters, footwear, and any approved head covering shall be removed and inspected upon request during the metal detection process and during clothed pat searches. Clothed pat searches shall include manual and visual inspection of an employee's hair, hair piece, toupee, wig, hair extensions, facial hair, and scalp. Metal detection and clothed pat searches conducted prior to entry to a Department institution or facility shall be performed by an employee of the rank of correctional officer or higher or other individual authorized to conduct the search.

PURPOSE AND EFFECT: Rulemaking is necessary to provide for denture replacement; increase eligibility for acrylic partial dentures; amend form DC4-698A to reflect current procedures; and other minor revisions as necessary.

33-402.101 Dental Services – General.

(1) through (6) No change.

(7) Dental services available to inmates are based upon four levels of dental care.

(a) No change.

(b) Level II dental care is available to inmates with less than six months of Department of Corrections' incarceration time. It includes:

1. through 4. No change.

5. If an inmate has no upper or lower teeth and requests dentures, the inmate is to be placed on the appointment waiting list at his or her permanent facility. The inmate is not required to wait six months for Level III care.

(c) Level III dental care is available to inmates with six months or more of continuous Department of Corrections' incarceration time. Level III includes:

1. through 4. No change.

5. After the inmate has received a complete cleaning, he or she is eligible for:

a. Fillings/Restorative treatment.

b. Partial dentures.

I. Acrylic partial dentures provided the inmate has at least four months of continuous Department of Corrections' incarceration time remaining on his or her sentence. Three or more anterior (front) teeth in an arch must be missing before an anterior acrylic partial denture is considered. Acrylic partial dentures will not be made available for purely cosmetic reasons.

II. through III. No change.

IV. When indicated, dentures(s) are eligible for replacement every five years. Only one denture(s) will be provided in a lifetime with one reline provided at no cost. Dentures required more often will be charged to the inmate unless such a requirement is caused by a change in the inmate's dental condition that renders the existing denture(s) nonfunctional.

c. Nonemergency endodontic (root canal) therapy is available to Level III inmates (more than six months of continuous Department of Corrections' incarceration time) when clinically indicated. All teeth receiving endodontic therapy must have adequate support in the surrounding gum tissues and have a good chance of recovery and <u>long-term long</u> term retention. In addition, posterior teeth receiving endodontic therapy must be crucial to arch integrity (no missing teeth in the quadrant or necessary as a partial denture abutment.)

d. No Change

(d) Level IV dental care represents advanced dental services that may be available on a limited basis.

1. This level of dental care is available to inmates on an asneeded basis after completion of Level III services and successful demonstration of a plaque free index score of 90 percent or greater for two consecutive months. If an inmate cannot demonstrate that he or she is following an acceptable oral hygiene program, advanced dental therapy will not be considered.

2. No Change

3. Fixed prosthetics (<u>multiple units</u> crowns and bridges) are not to be done except in unusual circumstances and only when an adequate restoration cannot be placed. The inmate will be responsible for the lab charges associated with the replacement of single unit crowns installed prior to incarceration.

(8) Dental Care Requests, Complaints and Formal Grievances.

(a) Inmate requests for dental services shall be submitted on Form DC6-236, Inmate Request or Form DC4-698A, Inmate Sick-Call Request, and submitted to the Senior Dentist or his or her designee. Form DC4-698A is hereby incorporated by reference. (b) There will be no co-payment for emergency dental services. If an inmate declares a dental emergency that does not meet the dental emergency guidelines, no treatment will be rendered, and a co-payment charge will be assessed.

(10) Missed Appointments. Inmates who do not keep their dental appointments shall be rescheduled, with the following exceptions except for the following:

(a) No Change

(b) All inmates having three non-security related no-shows within a <u>six-appointment</u> six appointment time span shall be removed from the dental treatment list and will not be rescheduled again for routine or comprehensive dental care unless a written request is submitted for continuation for dental care. If such written request is submitted, the inmate will be placed on the appointment waiting list and will not be given preferential appointments unless the inmate's overall health would be adversely affected by delaying dental treatment.

(e) Any licensing examination taken as a condition for state licensure by a professional nurse after 1951 or by a practical nurse after 1952, if the examination meets the following standards:

1. The examination was developed using accepted psychometric procedures,

2. The content and passing score of the examination was substantially equivalent to the examination given in Florida at the time.

3. The security of the examination was maintained,

4. At least one of the reliability estimations for the examination is .70 or higher,

5. The examination was revised after each administration to ensure currency of content,

6. For examinations given after 1984, the test plan was based on a job analysis of new nursing graduates.

(3) To apply for endorsement pursuant to Section 464.009(1)(b), F.S., an applicant shall meet all requirements for eligibility to take the licensure examination as provided in Rule 64B9 3.002, F.A.C., and demonstrate a passing score on one of the following:

(a) The National Council Licensure Examination for registered nurses with a minimum score of 1600, or, after 1988, a report of Pass;

(b) The National Council Licensure Examination for practical nurses with a minimum score of 350, or, after 1988, a report of Pass;

(c) A state, regional, or national examination which meets the following minimum requirements:

1. The examination is developed using accepted psychometric procedures.

2. The content and passing score of the examination are substantially equivalent to that of the National Council Licensure Examination.

3. The security of the examination is maintained.

4. At least one of the reliability estimations for the examination is .70 or higher.

5. The examination is revised after each administration to insure currency of content.

(4) An applicant who has not been in active practice of nursing within the past 5 years is required to take a remedial course as specified in Rule 64B9 3.0025, F.A.C., prior to licensure.

64B16-27.410 Registered Pharmacy Technician to Pharmacist Ratio

NOTICE IS HEREBY GIVEN that on September 12, 2024, the Board of Pharmacy, received a petition for variance or waiver filed by Publix Super Markets, Inc., seeking a waiver of the requirement of subsection 64B16-27.410(5), Florida Administrative Code, which states, Six to One (6:1) Ratio: Any pharmacy or any pharmacist may allow a supervision ratio of up to six (6) registered pharmacy technicians to one (1) pharmacist (6:1), as long as the pharmacist or registered pharmacy technicians are not engaged in sterile compounding. The PIT at Frost Park is a Beach Sport Complex that offers a variety of lifestyle beach sports ranging from beach volleyball, footvolley, beach tennis, beach flag football and more. Home to 6-8 lighted courts with a sitting area for viewing, The PIT is a great place for locals and tourists to experience these lifelong sports.

Partnering with Dania Beach, The PIT will offer vacation training packages to bring visitors to the city for not only sports, but also to experience all of the opportunities the "first city of Broward County has to offer." RCBSA will create a unique beach sports academy that will serve the City of Dania Beach by bringing an array of beach sports for locals as well as becoming a destination for all beach sports. The PIT will host local, national, and international tournaments, bringing attention to the City of Dania Beach. RCBSA will attract beach sport lovers to participate in all beach sports, including, but not limited to: Sand Pickleball, Beach Volleyball, Beach Tennis, Beach Badminton, Beach Foot Volley, Beach Soccer, Beach Flag Football, and Beach Handball.

Free-play time for the community, Beach Volleyball Juniors Club and showcases, after school sports programs, a multiple sports training facility destination, college annual beach volleyball invitational tournament, etc....

In summary, Dania Beach has the potential to be a thriving location for a beach sports academy/facility, benefiting the community economically and promoting a fun and active lifestyle.

2. FINANCIAL STRUCTURE AND ECONOMIC EFFICIENCIES:

The project is expected to boost the local economy by attracting visitors to Dania Beach, leading to increased spending on accommodations, dining, and other local services.
Revenue generated from leagues, training packages, and tournaments can contribute to the financial sustainability of the facility.

The revenue streams include membership fees, training fees, tournament entry fees, travel expenses, private coaching services, merchandise sales, and equipment sales. The City and RCBSA will have a revenue share of all revenue generated from "The Pit" with the City receiving 30% of the revenue share and RCBSA receiving 70%.

Revenue Programming: Tentative pricing structures have been outlined for various services provided by the facility, such as junior beach volleyball club memberships, team training fees, tournament entry fees, travel expenses, private coaching, and merchandise/equipment sales.

Economic Efficiencies: - Potential Return on Investment: The projected annual revenues demonstrate strong potential for a solid return on investment, indicating the economic viability of the proposal.

Revenue Diversification: The proposal includes considerations for revenue diversification through services like club memberships, training programs, tournaments, coaching services, and merchandise sales. This diversification can help mitigate risks and enhance economic efficiencies.

Cost Management: Effective cost management strategies, such as careful monitoring of operational expenses, maintenance costs, and pricing structures, will be crucial for ensuring economic efficiencies and long-term financial sustainability.

- Market Sensitivity and Competition: The proposal acknowledges factors like seasonal fluctuations, weather conditions, local market competition, and the need for marketing and promotion to attract customers. Addressing these factors strategically can enhance economic efficiencies and revenue generation.

In summary, the financial structure and economic efficiencies of the proposal for the beach sports facility at Frost Park are designed to support sustainable operations, revenue growth, and a positive return on investment through diversified revenue streams, cost-effective management practices, and marketsensitive pricing strategies

This Comprehensive Plan has a Parks and Recreation element with goals and objectives for the city with the overall goal of providing a sustainable recreation and open space system to adequately meet the physical, social, recreational and cultural needs for all current and future residents and visitors of the City with an objective of all public facilities in the city being open to the public. Another main objective of the Comprehensive Plan is to ensure these recreational needs and standards are met through public and private resources. A partnership with Rita Crockett Beach Sports Academy supports these objectives.

- Along with the with the City's Parks Master Plan and the Comprehensive Plan, Broward County has a Recreation and Open Space Element to their Comprehensive Plan that was adopted in 2019 with the goal to provide safe and adequate recreation sites and facilities to satisfy the current and future needs while promoting active and healthy living. Broward County amended their master plan in 2022 with the continued goal of providing a countrywide park system with diverse facilities and recreation opportunities to enhance the well-being of all residents, businesses and visitors while also creating a world-call and truly inclusive guest experience and develop specialty parks and signature elements unique to Broward County. The addition of the Rita Crockett Beach Sports Academy adds an additional element of recreation facilities for the community and visitors alike to promote active and healthy living that is truly a specialty and signature facility in Broward County. The Rita Crockett Beach Sports Academy, AKA, the "Pit" is the first of its kind in Florida and will be run by Rita Buck-Crockett an inductee of the Women's Volleyball Hall of Fame, an Olympic silver medalist, a collegiate volleyball coach and a resident of the City of Dania Beach to name a few of Rita's outstanding achievements.

In conclusion, the Rita Crockett Beach Sports Academy will help not only City of Dania Beach reach one of the many objectives the city's parks master plan and comprehensive plan, but all the objective of Broward County.
