RULE NO.: 6A-1.0018 **RULE TITLE:** School Safety Requirements and Monitoring

PURPOSE AND EFFECT: To set forth requirements relating to school safety and to define certain safety measures that schools are expected to meet. Amendments will address changes as a result of the need to make training available for parents and guardians on the proper use, and consequences for misuse, of FortifyFL, the mobile suspicious activity reporting tool.

SUBJECT AREA TO BE ADDRESSED: Office of Safe Schools requirements for districts to provide information to parents and guardians of students on FortifyFL, including the consequences for making a threat or false report, within the first 5 days of each school year. Additional changes to school safety and monitoring requirements may also be considered.

PURPOSE AND EFFECT: The Board proposes an amendment that updates the rules for clarity, updates and incorporate forms, and to comply with legislative changes.

SUMMARY: The proposed rules are updated to provide clarity, to update existing language, and update and incorporate outdated forms and comply with legislative changes.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the Agency.

The Agency has determined that the proposed rule is not expected to require legislative ratification based on the

The executive director or commission representative shall determine whether a manager's coaching or behavior is excessive, inappropriate, disruptive, or otherwise, unbecoming a sportsman. A manager attempting by word or action, to heckle or annoy his or her participant's opponent or any official is strictly prohibited. A manager shall not enter the corner ring, or fenced area at any time during the match and not interfere with the conduct of a match during the match. If any manager enters the ring or fenced area during any match, the match shall be temporarily stopped and the manager shall be immediately ejected by the referee, and the referee shall order the match to continue. If any manager enters the ring during any match, the match shall be forfeited to the opposing participant. Whenever a person licensed as a manager in this state desires to work in the corner of a participant under contract to the manager, the manager shall be designated a second and shall be deemed to be a second for that specific bout without the need to apply for a second license. When working in such capacity, the manager shall comply with the requirements set forth for seconds in Rule 61K1-3.011 4.018, F.A.C., of these rules.

- 7. Pre and post placement social services,
- 8. Contracted services, if applicable,
- 9. Other necessary services; and,
- 10. Agency facilities and administrative costs.

(c) The agency's up to date fee schedule shall be reviewed by the Department annually to ensure that the schedule is in compliance with Section 63.097, F.S., for adoption related services.

Can the A2L refrigerant quantity in an independent refrigerant circuit in a high-probability system exceed the amount for A2 refrigerants stated in Table 1104.3.2 of the Florida Building Code, Mechanical, 8th Edition (2023), Chapter 11 or in ASHRAE 15-2019, Table 7.1? 3. Can an alternative method be used to design and install an independent refrigerant circuit in a high-probability system that exceeds the amount of A2 or A2L refrigerant stated in Table 1104.3.2 of the Florida Building Code, Mechanical, 8th Edition (2023), Chapter 11? 4. Can a refrigeration system be designed and installed using ASHRAE

15-2022 or Chapter 11 of the 2024 International Mechanical Code as an alternative to the current FMC? On August 13, 2024, the Commission provided the following answers: In response to Petitioner's first question, the answer is yes. Pursuant to section 102.4, Florida Building Code, Building, 8th Edition (2023), and since ASHRAE Standard 15-2019 provides for more specific design and installation requirements for A2L refrigerant than that of chapter 11, Florida Building Code, Mechanical, 8th Edition (2023), ASHRAE Standard 15 as referenced in section 1101.6, Florida Building Code, Mechanical, 8th Edition (2023), is considered to be an integral part of the Florida Building Code, Mechanical volume. The design and installation of A2L refrigerant using ASHRAE 15 would meet the minimum requirements of the Florida Building Code, Mechanical, 8th Edition (2023). In response to Petitioner's second question, an answer is not possible. Tables 1104.3.2, Florida Building Code, Mechanical, 8th Edition (2023), and 7.1 of ASHRAE 15-2019 do not apply to A2L refrigerants. In response to Petitioner's third question, the answer is yes. Pursuant to section 104.11, Florida Building Code, Building, 8th Edition (2023), the building official has the authority to accept alternative design to that of the prescriptive requirements of the code where he/she finds that the proposed design/alternative complies with the requirements of section 104.11, Florida Building Code, Building, 8th Edition (2023). In response to Petitioner's fourth query, the question is general in nature and falls outside the scope of this specific request. Also, see the answer to petitioner's third question.
