(1) Eligibility of nonprofit scholarship-funding organizations. A nonprofit scholarship-funding organization (SFO) that is approved pursuant to Section 1002.395, F.S., may provide a scholarship for students subjected to a qualifying incident to attend an eligible private school pursuant to Section 1002.40(4), F.S. establish Hope Scholarships for eligible students.

(a) Pursuant to the requirements of Section 1002.40<u>(4)(6)</u>, F.S., a school district must timely notify a parent of the Hope Scholarship program and provide the parent a completed Hope Scholarship Notification Form (Form IEPC-HS1), available on the Department's website, www.floridaschoolchoice.org. Form IEPC-HS1

15153) is hereby incorporated by reference, effective <u>December</u> 2024 February 2023.

(b) through (c) No change.

(3)(4) Hope Scholarship application procedure. To receive a scholarship to attend a private school under Section 1002.394 or Section 1002.395, F.S., Hope Scholarship a parent must apply to an eligible and participating SFO according to the SFO's application procedures and deadlines. The application submitted by a parent must include, at a minimum, the following information:

(a) Student's name, student's Florida Education Identifier (FLEID), date of birth, gender, race, current public school district, current public school attended, grade level, parent's name, telephone number, mailing address and email address.

(b) A completed Form IEPC-HS1 <u>may</u> must be included with the application and submitted to the <u>SFO</u> scholarship funding organization to which the application is made.

(5) The nonprofit scholarship funding organization shall confirm eligibility for each student and award all scholarships consistent with the requirements of Section 1002.40, F.S. The process used to confirm the eligibility of students and award scholarships is subject to the annual financial and compliance audit required by law.

(4)(6) Public school Hope Scholarship option. Pursuant to Section 1002.40(4)(6), F.S., a student meeting the Hope Scholarship eligibility requirements may choose to attend another public school in the student's school district or in another school district. Public school options are subject to the receiving school's capacity.

(7) Quarterly and annual reports. Participating eligible SFOs shall provide quarterly reports no later than August 10, October 10, January 10, and March 10, and an annual report no later than July 15 of each fiscal year the SFO received any contributions, as defined in Section 1002.40(2), F.S. The quarterly and annual reports must be submitted in a format to be specified by the Department and must include an electronic list of all participating scholarship students. The list shall include the following information:

(a) Demographic information for each student, including name, date of birth, Florida Education Identifier, grade level, gender, race, parent's name, mailing address, email address, and telephone number;

(b) The name and Master School ID of the public school and district in which the student was enrolled when the incident was reported;

(c) Information on the student's school of attendance, including tuition, fees, and transportation amounts;

(d) The amount and type of each student's scholarship;

(e) The incident type as reported on Form IEPC HS1; and,

(f) Year to date information on the amount paid for each scholarship student during the school year and the school attended, including the first data of attendance and withdraw date. If a student attended more than one school, the summary shall detail the amount of the scholarship payments that the student generated by each school.

(2) Nonprofit <u>SFO</u> scholarship funding organization requirements. Eligible nonprofit <u>SFOs must</u> scholarship funding organizations shall:

(b) Verify eligible expenditures before <u>direct purchases or</u> the distribution of funds for any expenditures made pursuant to Section 1002.411(3)(a)2., F.S.

(4) Scholarship payments. The following provisions relate to the distribution of funds from the Department of Education to an eligible nonprofit <u>SFO</u> scholarship funding organization.

(a) An eligible <u>nonprofit SFO</u> scholarship funding organization may request a payment from the Department of Education for an eligible student after it has confirmed that the student has met the eligibility criteria in Section 1002.411(2), F.S. <u>Using the Department's web based system</u> (https://www.floridaschoolchoice.org/login/login\_sfo.asp), tThe nonprofit SFO scholarship funding organization must:

1. Confirm the eligibility of each scholarship student and include:

a. Student name, date of birth, Florida Education Identification number (FLEID), English Language Learner status (<u>if known</u>), <u>sex</u> gender, race, grade level, and address including <u>county of residence</u> public school district attended; and,

b. Date and time the nonprofit <u>SFO</u> scholarship funding organization confirmed eligibility.

2. No change.

(b) Eligible nonprofit <u>SFOs</u> scholarship funding organizations must set an annual deadline for scholarship participation.

(c) The Department shall distribute funds on a first-come first-served basis, in the following order of priority for each invoice period:

1. Students confirmed by the SFO as English Language Learners who are enrolled in a program or receiving services that are specifically designed to meet the instructional needs of English Language Learner students.; 2. Date and time the <u>SFO</u> scholarship funding organization confirmed eligibility.

(d) Requests for payments by a nonprofit <u>SFO</u> scholarshipfunding organization must be submitted no later than <u>June 30</u> May 1 for the fiscal year in which the student is eligible to receive a scholarship.

(e) No change.

(f) Eligible nonprofit <u>SFOs</u> scholarship funding organizations are responsible for the return of all scholarship funds to the Department that were received in error or associated with a scholarship account that has been closed pursuant to Section 1002.411(7)(g)(i), F.S. Funds returned must include the administrative fee if no reimbursements were made for expenditures that occurred in the fiscal year in which the scholarship was awarded.

(5) Quarterly Reports: Four (4) times a year, no later than October 30, January 30, April 30, and July 30 of each year, an eligible nonprofit <u>SFO</u> scholarship-funding organization <u>must</u> shall submit in a format to be specified by the Department an electronic list of all participating scholarship students and eligible expenditures. For purposes of the quarterly report, a participating scholarship student is one whose scholarship account has been funded in the current fiscal year.

(a) The list <u>must</u> shall include the following information:

(a)1. Demographic information for each student, including name, date of birth, FLEID, English Language Learner status, grade level, <u>sex gender</u>, race, and <u>county of residence public school district attended</u>;

(b)2. Program award amount for each student; and

3. Information on providers of services; and,

(c)4. Total year-to-date expenditures for each student on behalf of participating students by purpose type.

(b) No later than October 30 of each year, an eligible nonprofit scholarship funding organization shall provide the department a report that indicates the status of participants who did not renew participation for the current fiscal year.
