**PURPOSE AND EFFECT:** The Agency is amending the medication administration rules to comply with Chapter 2025-111, Laws of Florida. This law amended section 393.506, F.S., to authorize the subcutaneous administration of insulin and epinephrine by certain qualified individuals providing services to persons with developmental disabilities in Agency-licensed residential facilities. The medication administration rules in Chapter 65G-7, F.A.C., currently prohibit the administration of insulin, and authorize the administration of epinephrine only in emergencies. The statutory amendments authorize “unlicensed direct service providers” who meet the requirements of section 393.506, F.S., and the implementing rules to administer insulin subcutaneously and to supervise the self-administration of insulin subcutaneously. The proposed rule amendments will conform the rules to the law by revising the rule standards and procedures an unlicensed direct service provider must follow when administering insulin pursuant to section 393.506.

**SUBJECT AREA TO BE ADDRESSED:** The education, training, certification and validation requirements for unlicensed direct service providers who wish to be authorized to subcutaneously administer insulin and epinephrine to persons with developmental disabilities.

**SUMMARY:** The proposed rule amendment incorporates by reference the updated application to implement statutory requirements of §456.0135 and clarify the application process for trainee registration.

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the Agency.

The Agency has determined that the proposed rule is not expected to require legislative ratification based on the statement of estimated regulatory costs or if no SERC is required, the information expressly relied upon and described herein: During discussion of the economic impact of this rule at its Board meeting, the Board concluded that this rule change will not have any impact on licensees and their businesses or the businesses that employ them. The rule will not increase any fees, business costs, personnel costs, will not decrease profit opportunities, and will not require any specialized knowledge to comply. This change will not increase any direct or indirect regulatory costs.
