### Freshwater Fish and Wildlife

RULE NO.: RULE TITLE: 68A-4.001 General Prohibitions

PURPOSE AND EFFECT: The purpose of the proposed rule amendment is to update hunting regulations for nonresidents to take wild turkey. The effect of the proposed rule amendment will be to better manage wild turkey populations.

SUMMARY: The proposed rule amendment prohibits the take of wild turkey by nonresidents unless they possess a valid, nonresident annual hunting license as provided in 379.354(5)(h), Florida Statutes, unless exempt from this requirement by 379.353 F.S.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the Agency.

PURPOSE AND EFFECT: The purpose of the proposed rule amendments is to revise regulations pertaining to general and specific rules for Wildlife and Environmental Areas (WEAs). The effect of the proposed rule amendments will be to enable the agency to better manage fish and wildlife resources and public recreation on WEAs.

SUMMARY: The proposed rule amendment adjusts current regulations on WEAs as follows:

68A-17.004 (General Regulations Relating to Wildlife and Environmental Areas):

Harvesting Saw Palmetto Berries on WEAs – remove redundant rule language related to the harvest of saw palmetto berries on lands in the WMA system, so 581.189 F.S. is in force on these areas.

Labeling tree stands, elevated shooting platforms, trail cameras, and ground blinds on WEAs – require WEA users to obtain a Go Outdoors Florida customer identification number and permanently attach this number in a legible and conspicuous manner to all tree stands, elevated shooting platforms, trail cameras, and ground blinds before placing any of these items on a WEA, prohibit tampering with or removal of this identifying information without the owner's permission, and establish that FWC and cooperator staff may remove any of these items if they are not properly labeled.

Additionally, the proposed rule amendment also clarifies existing rules; removes unnecessary, redundant, or conflicting

language; corrects prior mistakes; and makes non-substantive, technical corrections.

68A-17.005 (Specific Regulations for Wildlife and Environmental Areas):

Southwest Region

Lake Wales Ridge WEA – during quota hunts and one day prior to each quota hunt, prohibit vehicle access to the area except for individuals permitted to participate in a hunt and during the youth turkey hunt when one additional non-hunting guest per quota permit may also have vehicle access to the area.

North Central Region

Lafayette Forest WEA – allow public access including motor vehicles on Lafayette Loop during the small game season.

Northwest Region

Apalachicola River WEA – clarify that taking furbearers with dogs is prohibited in the still hunt area; correct existing errors in the boundary description of the still hunt area; and clarify that dogs are prohibited for taking rabbits and non-protected mammals during dates that overlap with the spring turkey season.

L. Kirk Edwards WEA – clarify that taking furbearers with dogs is prohibited; and clarify that the bag limit for wild turkey during spring turkey season is 1 gobbler or bearded turkey per spring turkey or youth turkey quota permit.

South Region

CREW WEA – clarify that taking antlerless deer is prohibited; and clarify that taking wild turkey is prohibited, except during the spring turkey season.

DuPuis WEA – establish an archery-only area east of the firebreak that connects Gate 2 to Jim Lake Grade, west of Powerline Grade, south of SW Kanner Hwy., and north of Jim Lake Grade and the firebreak connecting Jim Lake and Powerline grades.

Hungryland WEA – clarify that taking antlerless deer is prohibited; and clarify that taking wild turkey is prohibited, except during the spring turkey season.

Southern Glades – clarify that taking antlerless deer is prohibited.

Additionally, the proposed rule amendment also clarifies existing rules; removes unnecessary, redundant, or conflicting language; corrects prior mistakes; and makes non-substantive, technical corrections.

- (a) Authorized hunting equipment, defined for the purposes of this rule as tree stands and elevated shooting platforms, or dogs (if permitted by area regulations) may be taken on the area after 8:00 a.m. one day before the opening of the hunt and shall be removed from the area before 6:00 p.m. one day following the close of the hunt unless otherwise provided by specific area regulations. Recreational users of wildlife and environmental areas must obtain a Commission-issued customer identification number and permanently affix this number in a conspicuous and legible manner to all tree stands, elevated shooting platforms, ground blinds, and trail cameras prior to placing any of these items on a wildlife and environmental area. Removing, tampering with, or otherwise interfering with any label or tag

displaying a Commission-issued customer identification number on any of these items without the owner's permission is prohibited. Commission and cooperator staff may remove any of these items at any time if they are not labeled as described herein.

- (a) No person shall cut or destroy any tree on, or remove any tree, shrub, or protected plant (as designated in Section 581.185, F.S.) from any wildlife and environmental area unless authorized by the landowner or the Commission. (b) No person shall possess or remove saw palmetto berries from any wildlife and environmental area where the Commission is the landowner or lead managing agency without written permission.
