ANNOUNCEMENT OF STUDY APPROVAL

On September 9, 2025, the Florida Department of Transportation (FDOT), pursuant to 23 U.S.C. §327 and a Memorandum of Understanding dated May 26, 2022, and executed by the Federal Highway Administration and FDOT, was granted Location and Design Concept Acceptance for: Interstate 75 (I-75)

Project Development and Environment (PD&E) Study

from Moccasin Wallow Road to south of US 301 Work Program Item (WPI) Segment No: 419235-2

The Preferred Alternative includes adding two express lanes (ELs) in each direction within the existing Interstate 75 (I-75) median throughout the project limits and making interchange improvements at State Road (SR) 674 and Gibsonton Drive. The project is expected to relieve congestion, enhance safety, and improve operating conditions along the corridor.

The Preferred Alternative Typical Section includes designating the existing mainline travel lanes as General Use Lanes (GULs), which will remain. Adjacent to the GULs, two 12-footwide ELs and 12- to 15-foot-wide inside shoulders will be added within the I-75 median in each direction. The ELs and GULs will be separated by a 4-foot-wide painted and delineated buffer. The project also includes improvements at the SR 674 and Gibsonton Drive interchanges.

The addition of express lanes will require the widening of 16 existing bridges over local roads and waterways. In addition, two new bridges are proposed at the SR 674 interchange to connect collector-distributor roads to the existing loop ramps. Two new bridges are also proposed at the Gibsonton Drive interchange, one for westbound Gibsonton Drive over I-75 and one for the westbound to northbound ramp over the Alafia River.

The Preferred Alternative will not require the acquisition of additional right-of-way (ROW) along I-75 for roadway or interchange improvements; however, additional ROW will be required for construction of offsite stormwater management facilities (SMF) and floodplain compensation (FPC) sites.

This project is now eligible to proceed to the next phase of development. Currently, only the Gibsonton Drive interchange improvement project, under WPI Segment No. 437650-2, is funded for design and ROW acquisition in FDOT's Adopted Five-Year Work Program (FY 25/26 to 29/30). Additional phases and projects will be programmed as funding becomes available.
