##### Vessel Registration and Boating Safety

RULE NO.: RULE TITLE:  
68D-24.008 Broward County Boating Restricted Areas

PURPOSE AND EFFECT: This rule amendment will establish a year-round slow speed, minimum wake boating restricted area for the purpose of protecting public safety in the Intracoastal

Waterway between Oakland Park Boulevard Bridge and Sunrise Boulevard Bridge.

SUMMARY: Establishment of a year-round slow speed minimum wake boating restricted area in the Intracoastal Waterway adjacent to Lauderdale Beach in Broward County.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the Agency.

The Agency has determined that the proposed rule is not expected to require legislative ratification based on the statement of estimated regulatory costs or if no SERC is required, the information expressly relied upon and described herein: The nature of the rule and the preliminary analysis conducted to determine whether a SERC was required.

THE FULL TEXT OF THE PROPOSED RULE IS:

#### **68D-24.008 Broward County Boating Restricted Areas.**

(1) For the purpose of regulating speed and operation of vessel traffic on and adjacent to the Florida Intracoastal Waterway in Broward County, Florida, the following year-round boating restricted areas are established. The boating restricted areas exclude all associated tributaries, creeks, canals, backwaters, channels, boat basins and other waterways unless otherwise designated or specifically described for inclusion:

(a)1. Hillsboro Boulevard Bridge – An Idle Speed No Wake zone from shoreline to shoreline, in and adjacent to the Florida Intracoastal Waterway, bounded on the north by a line drawn perpendicular to the centerline of the Florida Intracoastal Waterway 750 feet north of the Hillsboro Boulevard Bridge and bounded on the south by a line drawn perpendicular to the

centerline of the Florida Intracoastal Waterway 800 feet south of said bridge as depicted in drawing A.

2. through 14. No change.

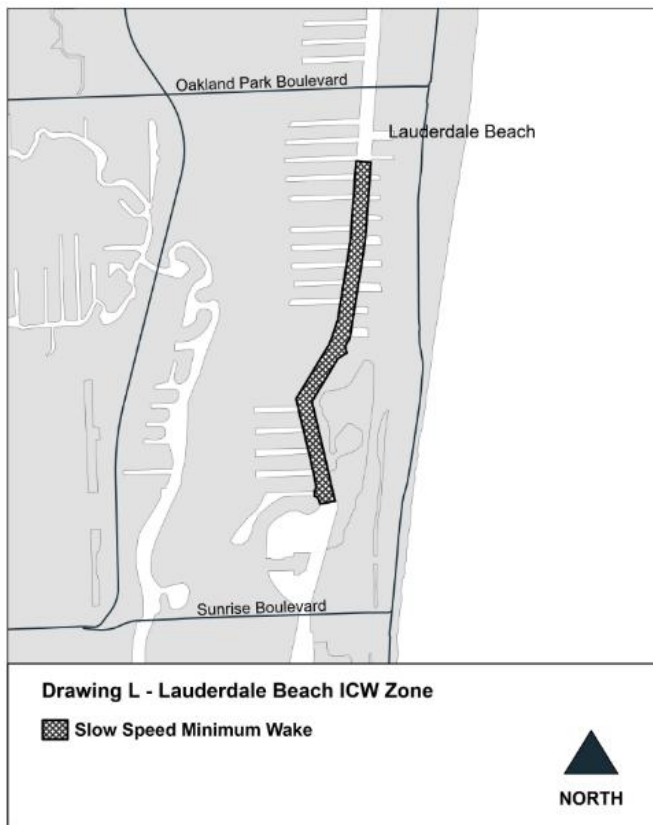
15. Lauderdale Beach ICW Zone – A Slow Speed Minimum Wake zone from shoreline to shoreline, in and adjacent to the Florida Intracoastal Waterway, bounded on the north by a line drawn perpendicular to the centerline of the Florida Intracoastal Waterway 1,500 feet south of the Oakland Park Boulevard Bridge and bounded on the south by a line drawn perpendicular to the centerline of the Florida Intracoastal Waterway 2,250 feet north of the Sunrise Boulevard Bridge, as depicted in drawing L.

#### FINAL ORDER APPROVING ISLAMORADA, VILLAGE OF ISLANDS

##### ORDINANCE NO. 25-17

The Department of Commerce ("Department") hereby issues its Final Order, pursuant to Section 380.05(6), Florida Statutes, approving land development regulations adopted by the Islamorada, Village of Islands, Florida ("Village"), by Ordinance No. 25-17 (the "Ordinance").

##### FINDINGS OF FACT

1.The Florida Keys Area is designated by Section 380.0552, Florida Statutes, as an area of critical state concern. The Village is a local government within the Florida Keys Area.

2.The Ordinance was adopted by the Village on November 13, 2025, and rendered to the Department on November 20, 2025.

3.The Ordinance amends Section 30-851 of the Village Code to allow backing movements or other vehicle maneuvering within a street right-of-way (excluding U.S. 1) when necessary to support a public purpose.

##### CONCLUSIONS OF LAW

4.The Department is required to approve or reject land development regulations that are adopted by any local government in an area of critical state concern. See Section 380.05(6), Florida Statutes.

5."Land development regulations" include local zoning, subdivision, building, and other regulations controlling the development of land. Section 380.031(8), Florida Statutes. The

regulations adopted by the Ordinance are land development regulations.

6.The Ordinance is consistent with the Village's Comprehensive Plan generally, as required by Section 163.3177(1), Florida Statutes, and is specifically consistent with Goal 1-1, Policy 1-4.2.1, Objective 2-1.1, and Policy 2-1.1.1.

7.All land development regulations enacted, amended, or rescinded within an area of critical state concern must be consistent with the principles for guiding development for that area. See Section 380.05(6), Florida Statutes. The Principles for Guiding Development for the Village are set forth in Section 380.0552(7), Florida Statutes.

8.The Ordinance is consistent with the Principles for Guiding Development in Section 380.0552(7), Florida Statutes, and is specifically consistent with the following Principles:

(a) Strengthening local government capabilities for managing land use and development so that local government is able to achieve these objectives without continuing the area of critical state concern designation, and

(n) Protecting the public health, safety, and welfare of the citizens of the Florida Keys as a unique Florida resource.

WHEREFORE, IT IS ORDERED that the Department finds that Ordinance No. 25-17 is consistent with the Village's Comprehensive Plan and the Principles for Guiding Development for the Village and is hereby APPROVED.

This Final Order becomes final 21 days after publication in the Florida Administrative Register unless a petition is timely filed as described in the Notice of Administrative Rights below.
