62S-8.003 Project Scoring Criteria

PURPOSE AND EFFECT: The Department of Environmental Protection proposes amending this rule chapter to update internal references to Section 380.093, F.S., consistent with legislative amendments to Section 380.093, F.S., that took effect on July 1, 2024, and to revise the rule chapter's use of "financially disadvantaged small community" to "community eligible for a reduced cost share," consistent with current Section 380.093(5)(e), F.S. These amendments will maintain regulatory consistency between Chapter 62S-8, F.A.C., and Section 380.093, F.S., as well as facilitate qualification of additional communities as "communit[ies] eligible for a reduced cost share," thereby reducing or eliminating the minimum cost share otherwise required by Section 380.093(5)(e), F.S., for projects proposed by those communities to be included in the Statewide Flooding and Sea Level Rise Resilience Plan.

SUMMARY: These proposed rule amendments include updates to one term ("community eligible for a reduced cost share") used throughout the rules proposed for amendment, as well as updates to multiple statutory references required to maintain consistency with Section 380.093, F.S., as amended by Chapter 2024-180, Laws of Florida, on July 1, 2024. While the Department proposed certain discretionary changes to Rule 62S-8.001, F.A.C., for development upon publication of the November 14, 2024, Notice of Development of Rulemaking in the F.A.R., the Department is not proposing any changes to that rule at this time, hence why said rule is not included in this Notice of Proposed Rule.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the Agency.

62S-8.003 Project Scoring Criteria.

- (1) All projects eligible for inclusion in the Statewide Flooding and Sea Level Rise Resilience Plan by meeting the requirements in Section 380.093(5), F.S., will be reviewed by the Department. Each eligible project will be allocated points based on the tiered structure outlined in this rule and consistent with Section 380.093(5)(g) 380.093(5)(h), F.S. Total points awarded will determine the project rank. If an applicant fails to demonstrate it meets a specific scoring criteria by failing to satisfy all relevant requirements for that criteria set forth in this rule, that criteria will receive a score of zero.
- (2) The maximum number of points that may be awarded for Tier 1 criteria is 40 points.
 - (a) No change.
- (b) Ten points will be awarded if the project reduces one or more risks to a regionally significant asset, as defined in Section 380.093(2)(e) 380.093(2)(d), F.S., or if the project adapts a regionally significant asset to help avoid such risk. For the purpose of this paragraph, adaptation of a regionally significant asset to avoid risk may include relocation of the asset outside the area(s) of flooding risk.
 - (c) and (d) No change.
- (3) The maximum number of points that may be awarded for Tier 2 criteria is 30 points.

- (b) Up to 7.5 points will be awarded for readiness of the project to proceed in a timely manner, as defined by subparagraphs 62S-8.003(3)(b)1. through 3., F.A.C., below.

- 3. One point will be awarded if local funding sources are committed as cost share or if the community is a community eligible for reduced cost share financially disadvantaged small community. Available cost share can be demonstrated by relevant documentation, including an approved and adopted capital improvement plan, a signed letter from the Chief Executive Officer (or equivalent) of the eligible entity, a resolution or agenda item to be presented to the governing board committing funding to the project if selected, or any other comparable document showing availability of funds.
 - (c) and (d) No change.
- (4) The maximum number of points that may be awarded for Tier 3 criteria is 20 points.
- (a) Up to 6.5 points will be awarded for available local, state, or federal cost share. Points will be allocated in the following manner:
- 1. Zero points will be awarded if the proposal does not demonstrate that a source for the required 50% cost share has been specifically identified unless the community is a community eligible for reduced cost share financially disadvantaged small community; or
 - 2. No change.
- 3. A total of 6.5 points will be awarded if the project proposal provides documentation that 50% cost share is available or if the community is a <u>community eligible for reduced cost share financially disadvantaged small community</u>. Available cost share can be demonstrated by providing an approved and adopted capital improvement plan, a letter from the Chief Executive Officer (or equivalent) of the eligible entity committing funding, a resolution from the governing board committing funding to the project if selected, or any other similar document showing availability of funds.
- (b) A total of 6.5 points will be awarded if verification of state funding previously awarded to the project is provided to the Department with the proposal. Verification must include previously funded phases, amount of prior state funding, and previous partial appropriations, and must be submitted in a format that is verifiable by the agency or agencies having awarded the previous funding. For the purposes of this paragraph, Department grants to a county or municipality to fund the costs of community resilience planning and necessary data collection for such planning will not be considered state funding previously awarded to the project. Points will be allocated in the following manner:
- 1. One point will be awarded if the applicant provides verification of previous state funding awarded for preconstruction activities, as defined in Section 380.093(2)(d)

- (2)(a) Surgical and other instruments that normally penetrate soft tissue or bone, including, but not limited to, forceps, scalpels, bone chisels, scalers, and surgical burs, must be sterilized after each use.
- (b) Instruments that are not intended to penetrate oral soft tissue or bone, including, but not limited to, high speed dental handpieces, <u>slow-speed handpieces</u>, <u>slow speed motors</u>, <u>air polishers</u>, contra-angles, reusable prophy angles, amalgam condensers, plastic instruments, and burs, but that may come into contact with oral tissues must be sterilized after each use according to the manufacturer's instructions for use.
 - (c) No change.
- (d) High speed dental handpieces, <u>slow-speed dental</u> <u>handpieces</u>, <u>slow-speed motors</u>, <u>air-polishers</u>, slow speed dental sleeves, <u>and</u> contra-angles, and <u>reusable</u> prophy angles must be sterilized after each use using <u>a heat or</u> heat with pressure or heat with chemical method. The method used must be capable of sterilization.

69A-73.001 Definitions and Application of Chapter.

- (1) Application of Chapter: The provisions outlined in the Florida Fire Prevention Code, incorporated in Chapter 69A-60, F.A.C., shall be applicable to all elements of this rule chapter concerning code and administrative provisions that are not specifically addressed in this rule chapter.
 - (2) Definitions:
- (a) Approved- Acceptable to the authority having jurisdiction.
- (b) Authority Having Jurisdiction (AHJ)- An organization, office, or individual responsible for enforcing the requirements of a code or standard, or for approving equipment, materials, an installation, or a procedure.
- (c) Battery- One or more cells connected together electrically in series, parallel, or both, to provide the required operating voltage and current levels.
- (d) Electric Vehicle (EV)- An automotive-type vehicle for on-road use, such as passenger automobiles, buses, trucks, vans, neighborhood electric vehicles, and electric motorcycles, primarily powered by an electric motor that draws current from a rechargeable storage battery, fuel cell, photovoltaic array, or other source of electric current. Plug-in hybrid electric vehicles (PHEV) are electric vehicles having a second source of motive power.
- (e) Electric Vehicle Power Export Equipment (EVPE)- The equipment, including the outlet on the vehicle, that is used to provide electrical power at voltages greater than or equal to 30 Vac or 60 Vdc to loads external to the vehicle, using the vehicle as the source of supply.
- (f) Electric Vehicle Supply Equipment (EVSE)-Equipment for plug-in charging, including the ungrounded, grounded, and equipment grounding conductors, and the electric vehicle connectors, attachment plugs, personnel protection system, and all other fittings, devices, power outlets, or apparatus installed specifically for the purpose of transferring energy between the premises wiring and the electric vehicle.
- (g) Micromobility Device, Powered- Motorized bicycles, motorized scooters, or other personal transportation devices powered by lithium-ion or lithium metal batteries.

(h) Wireless Power Transfer Equipment (WPTE)-Equipment installed specifically for the purpose of transferring energy between the premises wiring and the electric vehicle without physical electrical contact.

- (1) For purposes of this rule chapter, energy storage systems as defined in the National Fire Protection Association ("NFPA") 855, 2023 Edition, incorporated herein by reference, shall comply with all requirements of the NFPA 855, 2023 Edition, and the Florida Fire Prevention Code, except that section 4.8.2.2. is amended to read as follows: "Multiple panels shall be aggregated to an interface, master, or annunciator panel at a location approved by the AHJ."

69A-73.003 Powered Micromobility Devices.

- (1) Powered micromobility devices shall be charged in accordance with this Rule.
- (2) In other than one-and two-family dwellings, when more than five powered micromobility devices or batteries are charged inside or within 10 ft of a building or structure, the AHJ is authorized to require a permit in accordance with the Florida Fire Prevention Code.
- (3) Powered micromobility devices and batteries for such devices shall be charged in accordance with their listing and the manufacturer's instructions using either the original-equipment-manufacturer-supplied listed charging equipment or listed charging equipment specified in the manufacturer's instructions.
- (4) Powered micromobility devices and battery packs shall be listed and labeled in accordance with UL 2272, Electrical Systems for Personal E-Mobility Devices, Edition 2 (2024), or

- <u>UL 2849</u>, <u>Electrical Systems for eBikes</u>, <u>Edition 1 (revised 2022)</u>, as applicable, which are hereby incorporated by reference.
- (5) Charging equipment for powered micromobility devices shall be listed and labeled in accordance with UL 4900, Micromobility Charging Equipment, Edition 1 (2025), which is hereby incorporated by reference.
- (6) Micromobility Device Battery Charging. Battery charging for powered micromobility devices and batteries for such devices shall be in accordance with all of the following:
- (a) The charging equipment for each device shall be plugged directly into a listed receptacle;
- (b) Extension cords and relocatable power taps shall not be utilized;
- (c) Storage of combustible materials, combustible waste, or hazardous materials shall not be permitted within 10 ft of the charging equipment; and
- (d) The charging operation shall not be located in any exit access corridor or exit enclosure.
- (7) The assembly or reconditioning of a lithium-ion battery using cells removed from used lithium-ion batteries is prohibited.
- (8) The sale or offer for sale of lithium-ion batteries or micromobility devices that do not comply with this rule is prohibited.
