PURPOSE AND EFFECT: The proposed rulemaking implements the statutory changes made to the My Safe Florida Condominium Pilot Program (Program) in House Bill 393. The rulemaking will provide more clarity to applicants regarding eligibility for participation and the process for grant applications. The rule provides information on participant eligibility and improvements that are reimbursable under the Program.

SUMMARY: This rule will outline the requirements for the My Safe Florida Condominium Pilot Program.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

Wind Certification Entity will complete the Initial Inspection Report, Form DFS-O1-011, effective 03/25, incorporated herein by reference, and available at <https://www.flrules.org/Gateway/reference.asp?No=Ref-47949>. The Inspector will use Form OIR-B1-1802, Uniform Mitigation Verification Inspection Form, incorporated by reference in Rule 69O-170.0155, F.A.C., to perform Initial Inspections on condominium buildings with three (3) or fewer stories. Inspectors will use the Building Type II and III Mitigation Inspection Form when performing Initial Inspections on condominium buildings with four (4) or more stories. (2) ~~Required Documentation.~~ Condominium Associations must upload the documentation required by the MSFCP Program through the Program Portal.

(a) Before voting to participate in the MSFCP Program, a Condominium Association must provide unit owners the Disclosure Notice, Form DFS-O1-012, effective 10/25 03/25, incorporated herein by reference, and available at <http://www.mysafecondo.casemanagement.tbtech.com>, and <https://flrules.org/Gateway/reference.asp?No=Ref-18464> 17950.

(b) As part of the Grant Application, Condominium Associations must submit a notarized and completed Intended Contractors List and Commitment to Complete, Form DFS-O1-013, effective 03/25, incorporated herein by reference, and available at <http://www.mysafecondo.casemanagement.tbtech.com>, and <https://www.flrules.org/Gateway/reference.asp?No=Ref-17951>. ~~Contractors must be licensed by the Department of Business and Professional Regulation under the provisions of chapter 489, F.S.~~

(3) ~~Service Area Requirement.~~ The MSFCP Program will utilize a geographic informational system (ArcGIS) to analyze the condominium's latitudinal and longitudinal coordinates and its geographic relationship to the absolute boundaries of the fifteen (15) mile buffer of the state's coastline to determine eligibility.

(4) ~~Application Process.~~ Instructions and requirements for participating in the MSFCP Program can be found in the Condominium Association Guide, Form DFS-O1-009, effective 10/25 03/25, incorporated herein by reference, and available at <http://www.mysafecondo.casemanagement.tbtech.com>, and <http://flrules.org/Gateway/reference.asp?No=Ref-18463> 17947.

(5) The Condominium Association and Inspector shall coordinate to schedule any Inspections. The Condominium Association's MSFCP Program Application will be closed, and no further action will be taken by the MSFCP Program if the Condominium Association:

- (a) declines an Inspection;
- (b) refuses to allow the Inspector access to the condominium building;
- (c) fails to schedule the Inspection after the Inspector makes three (3) attempts to schedule; or
- (d) fails to appear for the Inspection.

~~(6) A Condominium Association that fails to select a licensed contractor to perform the Mitigation Project will be denied for a mitigation grant.~~

(7) ~~Eligible Improvements.~~ Improvements, ~~listed in section 215.55871(5)(c), F.S.,~~ must be recommended in the Initial Inspection Report and identified ~~observed~~ in the Final Inspection Report to be eligible for a Mitigation Grant. The MSFCP Program will not provide Mitigation Grant funds for any construction ~~that is not recommended in the Initial Inspection Report.~~ The statements in the Initial Inspection Report and Final Inspection Report dictate MSFCP Program eligibility, regardless of other information or statements made outside the Initial Inspection Report or Final Inspection Report. ~~When recommended by a hurricane mitigation inspection report, grants for eligible associations may be used for the following improvements:~~

- ~~(a) Opening protection.~~
- ~~(b) Roof-related improvements, as follows:~~
 - ~~1. For buildings with a pitched roof:~~
 - ~~a. Reinforcing roof to wall connections.~~
 - ~~b. Improving the strength of roof deck attachments.~~
 - ~~c. Providing secondary water resistance for the roof.~~
 - ~~d. Replacing the roof covering, if necessary, for any of the improvements listed in sub-subparagraphs (7)(b)1.a.-c.~~
 - ~~2. For buildings with a flat roof, if improvements to protect the property that which complied with the current applicable building code at the time have been previously installed, the association must use a mitigation grant to install improvements that do both of the following:~~
 - ~~a. Comply with or exceed the applicable building code in effect at the time the association applied for the grant.~~
 - ~~b. Provide more hurricane protection than the improvements that the association previously installed.~~

~~(8) Assigning Funds.~~ A Condominium Association shall not assign any Mitigation Grant funds under the MSFCP Program to any other person or entity. A Condominium Association that assigns, encumbers, or transfers, or any attempt thereof, an interest in a Mitigation Grant, shall result in a denial of the Grant Application and the MSFCP Program will not pay the ~~will be denied for a Mitigation Grant.~~

(9) Mitigation Project costs include applicable Contractor overhead, indirect costs, profit, taxes, and permitting. Any other costs associated with construction at the condominium property are not authorized for Mitigation Grant funding. Any differences in costs between the Contractor's invoice and the information submitted in a Reimbursement Request should be noted by the Condominium Association.

(10) To apply for a Mitigation Grant, Condominium Associations must submit documentation showing they will receive an insurance credit, discount, or other rate differential

as a result of the recommended improvements. Acceptable documentation includes:

(a) Correspondence from the insurance carrier or agent acknowledging that the recommended improvements will qualify the structure for a mitigation credit or discount;

(b) An insurer's mitigation credit schedule showing how recommended improvements affect premium rates for the structure; or

(c) A copy of the carrier's underwriting or mitigation guidelines specifying the credit, discount, or rate differential for recommended improvements for the structure.

THE FULL TEXT OF THE EMERGENCY RULE IS:

53ER26-1 X THE CASH Bonus Play.

(1) General Provisions.

(a) Bonus Play Period: January 12 through April 5, 2026, dates inclusive.

(b) Eligible Tickets for Entry into the Bonus Play: Non-winning Game Number 1619, 10X® THE CASH; Game Number 1620, 20X THE CASH; Game Number 1621, 50X THE CASH; Game Number 1622, 100X THE CASH; Game Number 1623, 200X THE CASH; and Game Number 1627, 500X THE CASH Scratch-off tickets purchased during the Bonus Play Period. Game Number 1627, 500X THE CASH will be available for purchase beginning February 23, 2026; all other games are available January 12, 2026. Winning tickets are not eligible. Tickets meeting the criteria set forth in this paragraph are "Eligible" tickets.

(c) Available Prizes: \$1,000; \$5,000; or \$20,000

(d) Players who purchase a Game Number 1627, 500X THE CASH ticket will also have a chance to win a Coupon for a \$100 cash prize.

(2) How to Enter.

(a) To enter Eligible tickets into a drawing, a player may use the Florida Lottery's website at floralottery.com or the Florida Lottery's Mobile Convenience App ("App"). Only Eligible tickets purchased during a given Drawing Entry Period can be entered during that Drawing Entry Period. See subsection (5), below, for Drawing Entry Period dates.

1. Website. On the home page of the Florida Lottery's website, players go to the PROMOTIONS tab, select the X THE CASH Bonus Play. Players using the website may manually enter the 24-digit ticket number on the ticket entry page to collect entries as described in subsection (3), below.

2. App. On the App, players go to the Promotions section, select the X THE CASH Bonus Play. A Promotions button is located on the main menu and on the bottom navigation bar. Players may scan the barcode on the bottom of a ticket or may manually enter the 24-digit ticket number on the ticket entry page to collect entries as described in subsection (3), below.

3. Deleted Accounts. If a player deletes his/her account, whether through the App or on the Florida Lottery's website, all account data associated with the email address used to register his/her account will also be deleted. Any entries earned will not be entered into a drawing. A player's account cannot be reactivated using the email associated with the deactivated account. Should a player establish a new account utilizing a

different email address, account data, including ticket entries, cannot be transferred to the newly established account. Tickets entered under the prior account cannot be re-entered utilizing the newly created account.

4. Regardless of whether a player chooses to participate in the Bonus Play by using the web browser or the App, the following provisions shall apply:

a. a player will be prompted to either register or login;

b. the player must use the same account login information to enter tickets;

c. the player will only be required to register one time; and

d. the player's entry history will be cumulative across the entry platforms.

(b) Any player using multiple or different email addresses, identities, registrations, logins, or any other methods will subject the player and any associated entries to disqualification. In the event a player wins a prize, the name a player uses to register must match the name shown on his/her identification used to make a claim, except for a person who has made a legal name change. A person who has made a legal name change must provide a copy of a marriage certificate/judgment/court order, as applicable, as proof of a differing name. Fictitious names and business names will not be accepted and shall subject the player and any associated entries to disqualification.

(c) The odds of winning depend on the number of entries in a drawing. All entries are subject to validation by the Florida Lottery and will be disqualified if eligibility requirements are not met.

(d) Lottery tickets should not be mailed to the Lottery for entry into the drawing. Lottery tickets received in the mail by the Florida Lottery for entry into the Bonus Play will not be entered into a drawing and will not be returned.

(3) How to Earn Entries.

(a) To earn entries into a drawing, a player may enter ticket numbers by scanning the barcode on the bottom of an Eligible ticket using his/her mobile device or by manually entering the 24-digit ticket number on the website or the App. A player may earn multiple entries during an entry period and may enter a maximum of 200 tickets per day. (7) Prize Winner Notification. The Florida Lottery will notify winners by telephone or email using the contact information provided in a winner's registration data no later than one business day after the winners are posted on the Lottery's website. The Lottery deems the winner's registration data as the winner's official contact information. Issuing an email or leaving a telephone message on voicemail, if available, shall constitute notification. The Lottery will not attempt to further notify a winner if the attempt to notify the winner by telephone or email was unsuccessful. If a winner does not respond to the Lottery's notification within ten (10) calendar days of the date the winners are posted on the website, the winner will forfeit his/her right to claim the prize and the Lottery will select an alternate winner in accordance with subsection (5), above. If the alternate winner does not respond to the Lottery's notification within ten (10) calendar days of the date of notification, the alternate winner will forfeit his/her right to claim the prize and the Lottery will select the next alternate winner. This process will continue until an alternate winner responds to the Lottery's notification or the Lottery has exhausted the list of alternates due to unsuccessful notification or due to failure of a winner or an alternate winner to timely provide required claim documentation as set forth in subsection

(8), below. The Florida Lottery is not responsible or liable for system failures of any sort or type, including, but not exclusively, computer failures, email service failures, telephone failures.

(8) How to Claim a Prize. To claim a prize won in a Drawing, a winner must submit to the Florida Lottery a completed Winner Claim Form DOL-173-2, Revised 2/23, or Spanish Winner Claim Form DOL-173-2S, Revised 2/23, and a copy of acceptable identification as set forth in the rule of the Lottery governing payment of prizes.  FINAL ORDER
 APPROVING CITY OF KEY WEST ORDINANCE NO. 25-26

The Florida Department of Commerce (“Department”) hereby issues its Final Order, pursuant to Section 380.05(6), Florida Statutes, approving land development regulations adopted by the City of Key West, Florida (“City”), by Ordinance No. 25-26 (“Ordinance”).

FINDINGS OF FACT

1. The City is designated within an area of critical state concern. See, Rule 28-36.002, Fla. Admin. Code.
2. The City adopted the Ordinance on October 10, 2025, and rendered it to the Department on November 10, 2025.
3. The Ordinance modifies regulations within Chapter 122 of the Land Development Regulations to specify that applications for home occupation permits should be submitted to the City’s licensing official rather than the City’s building official.

CONCLUSIONS OF LAW

4. The Department is required to approve or reject land development regulations that are adopted by any local government in an area of critical state concern. See, section 380.05(6), Florida Statutes.
5. “Land development regulations” include local zoning, subdivision, building, and other regulations controlling the development of land. §380.031(8) Fla. Stat. The regulations adopted by the Ordinance are land development regulations.
6. The Ordinance is consistent with the City’s Comprehensive Plan generally, as required by section 163.3177(1), Florida Statutes, and is specifically consistent with Policy 1-1.9.2 and Policy 1-1.9.5.
7. All land development regulations enacted, amended, or rescinded within an area of critical state concern must be consistent with the principles for guiding development for that area. See, section 380.05(6), Florida Statutes. The Principles for

Guiding Development for the City are set forth in section 380.0552, Florida Statutes.

8. The Ordinance is consistent with the Principles for Guiding Development for the City as a whole, and specifically furthers the following Principles:

- (a) Strengthening local government capabilities for managing land use and development; and
- (e) Protection of the historical heritage of Key West and the Key West Historical Preservation District.

WHEREFORE, IT IS ORDERED that the Department finds that Ordinance 25-26 is consistent with the City’s Comprehensive Plan and the Principles for Guiding Development for the City and is hereby APPROVED.

This Final Order becomes final 21 days after publication in the Florida Administrative Register unless a petition is timely filed as described in the Notice of Administrative Rights.

You waive the right to any administrative proceeding if you do not file a petition with the agency clerk within 21 calendar days of the final order being published in the florida administrative register.
