SUBJECT AREA TO BE ADDRESSED: The rulemaking updates the U.S. Food and Drug Administration (FDA) Food Code, which is the national standard and model code for food safety regulation, to the most recent edition and makes clear that testing requirements after a positive or violative test apply to packaged ice in addition to vended water and vended ice.

(8) Can a pool contractor, whether residential or commercial, subcontract to install pergolas? (9) Can a pool contractor, whether residential or commercial, install gazebos? (10) Can a pool contractor, whether residential or commercial, install gazebo? (11) Can a pool contractor install driveways? (12) Can a pool contractor subcontract to install driveways?" The Notice of Petition for Declaratory Statement was published in Vol. 51, No. 239, on December 11, 2025, in the Florida Administrative Register. The Boards Order was filed on February 4, 2026. The Board, at its meeting held on January 16, 2026, denied the Petition for Declaratory Statement, because the Board was unable to determine whether the Petitioner meets the definition of a "substantially affected person" as required by Statute as the petition does not contain sufficient information to determine same. Additionally, the Petition appears to request for the Board to opine on the conduct of another, namely Certified Pool/Spa Licensed Contractors. Finally, the petition does not contain a "particular set of circumstances" as required by statute.
