## RIGHT TO ADMINISTRATIVE HEARING

Pursuant to Sections 120.569 and 120.57, Florida Statutes, and Rule 28-106.201, Florida Administrative Code, you have the right to either a formal hearing, if disputed issues of material fact exist, or an informal proceeding, if no disputed issues of material fact exist.

If you wish to have either a formal hearing or an informal proceeding, you must ask for it in writing, and your request **must be postmarked within twenty-one (21) days following the date of this ORDER**. The written request for a formal hearing or informal proceeding must be filed with the Florida Athletic Commission, 2601 Blair Stone Road, Tallahassee, Florida 32399-1016. According to Rule 28-106.201, Florida Administrative Code, this written request **must** contain all of the following information:

- Your name, address, and telephone number;
- The name and address of the Florida Athletic Commission, and your case number referenced on this order;
- An explanation of how the your substantial interests will be affected by the agency determination;
- A statement of when and how you received notice of the agency decision;
- A statement setting forth all specific issues of material fact which are disputed, i.e., which of the charges in this order you dispute and the factual grounds upon which you base your dispute;
- If you do not dispute any material facts, you must indicate that in your petition;
- A concise statement of the ultimate facts alleged, including the specific facts you contend warrant reversal or modification of the agency's proposed action;
- A statement of the specific rules or statutes you contend require reversal or modification of the agency's proposed action, including an explanation of how the alleged facts relate to the specific rules or statutes; and
- A statement of the relief sought by the petitioner, stating precisely the action petitioner wishes the agency to take with respect to the agency's proposed action.

If you dispute any material fact and there is a formal hearing, you have the right to appear on your own behalf; to be represented by your attorney; to bring witnesses and evidence; to cross-examine any witness produced against you by the Commission; and to have subpoenas and subpoenas duces tecum issued on your behalf.

If there is an informal proceeding, you have the right to provide the Commission with any documentation or written or oral arguments which you wish it to consider in opposition to or in mitigation of the charges contained in this order.

If no hearing is requested, this will be considered the final agency action and no further orders will be issued relative to this suspension.

If you request, and are entitled to a formal hearing, you will be notified of the time, place and date of the hearing. If you request an informal proceeding, you will be notified of the time period which to submit written documentation which you wish the Commission to consider in opposition to, or in mitigation of the circumstances as set forth in this order.
