## **Inspection Application: Homestead & Home Type Information**

Please review the following information.

**To be eligible for an Inspection or Grant in the MSFH Program, you must have a Homestead Exemption on your property taxes. During review of the Inspection Application, the MSFH Program will verify the status of your homestead exemption and the type of home you have. Please note that if it is determined that your home is eligible and your home is Attached to (i.e. shares a wall) another property, your home will be treated as a Townhouse for the purposes of the MSFH Program.**

### **Properties that meet the following requirements may qualify for a MSFH Program Initial Inspection:**

- The home must be a Single-family, Detached residential property or a Townhouse as defined in section 481.203, F.S. Attached Single-family homes will be treated as Townhouses for the purposes of the MSFH Program.
- The home must be site-built and Owner-occupied.
- The Applicant must have been granted a homestead exemption on the home under chapter 196, F.S. The Program will verify the status of your homestead exemption and the type of home you have.

### **The following properties are NOT eligible to receive a free MSFH Program Initial Inspection:**

- Retirement Homes
- Mobile Homes and Manufactured Homes
- Second Homes, Vacation Homes, and Rental Properties

**IMPORTANT NOTE: Attached Single-family properties will be treated as Townhouses for the purposes of the MSFH Program.**

The Program will use data provided by your county's Property Appraiser's office to determine the status of your homestead exemption and your property's Use Code. Your homestead exemption status is usually listed as an amount or as a "Y" on the Property Appraiser's website for your county. Use Codes vary by county, but all homes with a Use Code that begins with "1" or "01" will be considered single-family homes. Other Use Codes may also be considered eligible based on the criteria laid out in the Program Rule (available [here](#)). If you would like to check this information yourself, please contact your county's Property Appraiser or Tax Collector Office website directly [here](#). Every Property Appraiser's website is different, but all have a system through which you can search for your address and find information about your home.

- Any person who knowingly makes a material false statement or report to the Department or any agent of the Department, or knowingly and materially overvalues any property in any document or report prepared to be presented to the Department or any agent of the Department, commits a felony of the third degree, punishable as provided in s. 775.082, s. 775.083, or s. 775.084. See 817.2341(3)(a), Florida Statutes.

The assigned Inspection company will contact you to schedule the Initial Inspection of your home. Please note that you may receive solicitations from other businesses, not connected to the MSFH Program, offering to perform inspection or construction services on your home. The “free Inspection” offered in the MSFH Program refers only to an Initial Inspection by the WCE named in the approval email from the MSFH Program. The MSFH Program will not pay for an inspection conducted by any other inspection company. The MSFH Program urges you to ensure you are communicating with the WCE named in the MSFH Program’s approval email addressed to you when scheduling the free Initial Inspection.

If the MSFH Program is unable to approve your Inspection Application, you will be sent a Request for Information (RFI). You will need to return to the system and submit additional information to satisfy the RFI. Please ensure you check your emails regularly in case an RFI is sent to you. RFIs must be responded to within 60 days. If you do not respond within 60 days, your case will be deemed withdrawn and will be administratively closed. Closed cases cannot be reopened, so ensure you check your case and your email regularly.
