The request window is open from March 5 to April 1 preceding the beginning of the K-12 academic year. The request form must be completed and submitted by the District CTE Director or other individual authorized by the superintendent. The request window allows school districts to submit information for the following purposes: - Request K-12 FEFP funding eligibility and program linkages for an industry certification which was added to the Master Credentials List since the last funding list adoption;

- Request K-12 FEFP funding eligibility and program linkages for an industry certification on the Master Credentials List which only has postsecondary funding eligibility on the most recent CAPE funding list; and

- Request new CTE program linkages for certifications that are already approved for the CAPE funding list.

For K-12 FEFP funding eligibility requests, only certifications listed on the 'MCL certifications not currently K-12 funding eligible' list can be requested.
