All training classes offered by the LP Gas Program are eligible for continuing education credits (CEU's). In order to earn these credits, the entire class session must be attended. No partial credits will be given for attending only part of a class session. All participants will be required to sign-in before, during, and upon completion of the class session. A certificate will be provided to only those persons completing the entire class session. This certificate should be retained for your records and may be utilized to verify CEU compliance.
