DISCLOSURE NOTICE

Pursuant to section 215.55871(2)(d), F.S., the Board of Administration is providing this important disclosure notice to all condominium unit owners.

The Board intends to, in its upcoming meeting, or a special meeting for the sole purpose of voting, propose participation in the My Safe Florida Condominium Pilot Program (MSFCP Program). ~~This The MS FCP P~~rogram aims to provide free property ~~I~~nspections to assess potential mitigation measures that could be made to residential condominium buildings, recommend ~~I~~mprovements to enhance the property's resilience against hurricane damage, and identify potential insurance premium discounts. Improvements include Opening Protection-Related Projects (exterior doors, garage doors, windows, water intrusion mitigation devices, and skylights), and Roof-Related Projects (reinforcing roof-to-wall connections, improving the strength of roof-deck attachments, secondary water resistance for the roof, and replacing the roof covering). Following the submission and approval of an Inspection Application, a Wind Certification Entity will perform an Initial Inspection and deliver an Initial Inspection Report with any recommended Improvements to harden the condominium property against hurricane wind damage. Should the recommendations necessitate further action, a Grant Application will be required indicating the Association's intent to independently hire a Ceontractor of our choosing and complete the recommended Improvements from the Initial Inspection Report ~~received~~. The Ceondominium Association must pay for the Mitigation Project upfront. Upon completion of the Mitigation Project, the Association may seek a Mitigation Grant to offset the cost of these Improvements with a maximum grant of \$175,000.

Please note that for the Board to approve participation in the MSFCP Program, a majority vote of the Board (as defined in the Association's By-Laws), or a majority vote of the total voting interests of the association is required. Additionally, once the Board approves participation, a meeting will be scheduled to discuss the MSFCP ~~this P~~rogram and provide an opportunity for all condominium unit owners to cast their votes. To move forward with a Grant Application, a Ceondominium Association needs a 75% unanimous vote from all condominium unit owners that will be affected ~~effected~~ by the Mitigation Project.

Unit owners are not eligible to independently apply to the MSFCP Program.
