

Florida Law Enforcement Officer Civil Immigration Arrest Transportation Process

UNDER THE FLORIDA LAW ENFORCEMENT OFFICER CIVIL IMMIGRATION ARREST WORKFLOW, FLORIDA LAW ENFORCEMENT OFFICERS WILL TAKE ILLEGAL ALIENS THEY ARREST ON SOLELY FEDERAL CIVIL IMMIGRATION CHARGES TO A COUNTY JAIL OR ICE OFFICE.

If the person is taken to a county jail, the county jail will hold the person for up to 48 hours under the BOA and book them under the IRC or ERO issued I-203 ICE Order to Detain or Release Alien. The I-203 must be accompanied by an I-247 Immigration Detainer, and I-200 Warrant for Arrest or I-205 Warrant of Removal, as applicable. If the person is transported directly to an ICE office, custody of the individual is immediately relinquished to ICE and the I-203 and I-247 are inapplicable.

If the person is booked into a county jail, prior to the end of the 48-hour temporary housing period, the booked alien will need to be picked up and transported to an ICE office.

If a Florida law enforcement officer decides to transport an illegal alien arrested solely on civil immigration charges directly to an ICE office and not to a county jail for initial processing, the Florida law enforcement officer may transport the alien to one of the following locations during normal business hours. Outside of normal business hours the alien will be transported to a county jail.

(Note: the following are ICE offices and facilities to which Florida law enforcement officers may directly transport an arrested illegal alien during normal business hours, the following are not all of the ICE offices or facilities in Florida. The sheriffs or others conducting zone transports as outlined below will be transporting arrestees to locations other than just those listed here).

If the alien is booked into a county jail, the booked alien will need to be picked up and transported to an ICE office prior to the end of the 48-hour temporary housing period.

From the area encompassing Zones 1-9 across north Florida, the transportation will be handled by sheriffs in these 9 zones. These sheriffs will be notified by the IRC that an alien is in a jail in their zone and the sheriff will pick up the alien before the end of the 48-hour period and transport them to the appropriate ICE office.

From the area of Florida encompassing Zones 10-18 and the ICE Transportation Zone on the Transportation Process Map, sheriffs will handle the transportation of arrested aliens from the county jails to ICE offices. In the ICE Transportation Zone (light blue on the map), ICE is responsible for the transports by their officers, contract transportation providers, or other means arranged by ICE. The IRC will notify the transportation provider that an alien is in a jail and ready for transport and the sheriff or other responsible transportation provider will transport the alien to the appropriate ICE office within the 48-hour period.

The following are the sheriffs and county operated jail transportation zones and the sheriff who has agreed to do the transports in their zone. These sheriffs will be notified by the IRC that an alien is in a jail in their zone and needs to be transported to an ICE office.

Each county jail will notify the IRC every day at 0800 and 1500 (0700 and 1400 for Central Time Zone jails) of the aliens in their jails who need to be transported, and the transportation sheriffs will be notified after that. The transport will probably occur the next day, but may occur at any time during the 48-hour window. Sheriffs may work out transportation details as they see fit in their zones with pick-ups occurring at the jail or a mutually agreed upon closer place. Sheriffs should coordinate with their local ICE office to make sure someone is there to receive the alien when they arrive at the office. In order to control the flow of arrestees into the ICE offices and due to processing capacity, ICE may “meter” the pick-ups from the county jails and an individual may not be designated for pick up until up to 48 hours after booking.
