Renewal Application MILITARY Change of Status December 2018

READ AND FOLLOW ALL OF THESE INSTRUCTIONS.

You must familiarize yourself and comply with the requirements for licensure. These instructions are not intended to remove, modify or amend the requirements.

<u>ALL INFORMATION MUST BE TYPED.</u> Handwritten applications WILL BE RETURNED. This will delay processing and may result in missing deadlines.

GENERAL INFORMATION

This form is for a professional engineer licensee to request that their current and active license be placed on MILITARY STATUS, that their license remain on MILITARY STATUS, or that their license be removed from MILITARY STATUS and returned to current and active status. Licenses that are returned to current and active status after having been on MILITARY STATUS will expire on February 28th of ODD YEARS. If not renewed, a current and active license will become delinquent on March 1 of that ODD YEAR, and, by law, a licensee may not perform any engineering work. Once your request to change to or renew MILITARY STATUS is complete, you will receive notification that your license remains on MILITARY STATUS. Or, if returning to current and active status, you will receive notification on how to print your new license online. If you experience any problems with renewing your license, please call the Board office immediately.

SETTING STATUS TO ACTIVE MILITARY (NO FEE) (Part I Below)

The Board shall keep your license in good standing, without requiring any dues, fees, or the permanence of any other act, as long as you are a member of the Armed Forces of the United States on active duty and are not engaged in the practice of engineering in the private sector for profit. In order to qualify for this status you must submit to the Board a copy of the orders calling you to active duty or a copy of your discharge papers demonstrating discharge within the preceding 24 months.

If you are engaged in the practice of engineering in the private sector for profit, you must comply with ALL provisions regarding renewal, except for payment of the renewal fee, which will be waived. (Section 455.02(1), F.S.)

RETURNING FROM ACTIVE MILITARY (NO FEE) (Part II Below)

If you are no longer on active duty as a member of the Armed Forces of the United States, having been discharged within the past 24 months, you must contact the Board to request that your license be returned to current and active status. You must submit a copy of your DD-214 separation orders along with this form. Licensees returning from active military duty are exempt from continuing education renewal and fees.

MILITARY SPOUSE RENEWAL (NO FEE) (Parts III & IV Below)

If you are the spouse of a member of the Armed Forces of the United States who is serving on active duty, or a surviving spouse of a member who at the time of death was serving on active duty, **and** you are absent from the state of Florida because of your spouse's duties with the Armed Forces of the United States, the Board shall keep your license in good standing, without requiring any dues, fees, or the permanence of any other act, and you are exempt from any licensure renewal provisions as long as you are absent from the state of Florida due to your spouse's duties with the Armed Forces. (Section 455.02(2), F.S.)

If you are the spouse of a member of the Armed Forces of the United States who is serving on active duty, or a surviving spouse of a member who at the time of death was serving on active duty, **and** you are present in the state of Florida because of your spouse's active duties with the Armed Forces of the United States, you must comply with ALL provisions regarding renewal, except for payment of the renewal fee, which will be waived. (Section 455.02(2), F.S.)
