In accordance with 482.1562(5), Florida Statutes, your limited commercial urban fertilizer landscape maintenance certificate will expire on {expiration date}. This certificate renews every four (4) years for a fee of \$25.00. You must also submit four (4) hours of continuing education, two (2) of which must address fertilizer best management practices and two (2) of which must address CORE topics as described in 482.111(10). Subsequent to the expiration date stated herein, a certificate may be issued only upon submission of a training certificate and application for certification with fees.

Renewing via the website is CONDITIONAL based upon you supplying your CEU attendance verification forms and proof of insurance to the Bureau for verification and completion of the renewal process.
