I / we agree to handle, pack, process and move regulated articles in accordance with applicable plant quarantines; use all permits and certificates in accordance with instructions; maintain and offer for inspection such records as may be required; and abide by the following stipulations:

1. In accordance with Rule Chapter 5B-65, F.A.C. to handle, process, and treat regulated articles that are transported more than 50 miles from origin within the state.
2. To treat all regulated articles in accordance with the USDA/APHIS Plant Protection and Quarantine Treatment Manual (Rev. 07/2020), Treatment Schedules T312 - Oak Logs and Lumber and T314 - Logs and Firewood to prevent the introduction or spread of serious plant pests known to be present in regulated articles.
3. To maintain and provide upon request all treatment records of regulated articles and documentation of movement of regulated articles.
4. To affix certification bearing the firm name and compliance number to the shipping documents accompanying each shipment and to each individual package of regulated articles. All certificates issued under the authority of this agreement shall remain the property of the Florida Department of Agriculture and Consumer Services and shall be relinquished upon request.
5. In authorizing and participating in these treatments/requirements as a basis for the certification of the regulated articles no liability shall attach to the Florida Department of Agriculture and Consumer Services, to cooperating agencies, or to any of their employees in the event of injury to the property or the regulated articles.
6. Violation of any stipulation of this agreement may be grounds for suspension or revocation of this agreement and may result in prosecution as provided by sections 581.141 and 581.211, Florida Statutes.
