

Optometry Services Fee Schedule
Effective January 1, 2011

Note: The base fees listed below are reimbursed for services provided to recipients age 21 and over. To calculate the fee for children under 21, multiply the base fee, the base PC fee, or the base TC fee by 1.04. 1.04 represents a 4% increase over the base for children's services provided by licensed practitioners.

Example: Base fee for code 65205 is \$25.84 X 1.04 = \$26.87 (under 21 fee). Fees are rounded to the nearest hundredth.
