In accordance with Section 482.151(6) and (7), Florida Statutes, special identification cards renew annually on June 1. After a grace period not exceeding 30 calendar days, following the anniversary renewal date, a late renewal charge of \$25 shall be assessed and must be paid in addition to the renewal fee. Unless timely renewed, a special identification card automatically expires 180 calendar days after the anniversary renewal date. Subsequent to such expiration, a special identification card may be issued only upon successful re-examination and upon payment of the examination fee due.

Carefully detach the payment coupon (the bottom portion of this form) and remit with your check/money order (made payable to DACS) and include ALL CONTINUING EDUCATION UNITS (CEUs) attendance verification forms for each special identification card to be renewed in the envelope provided. NOTE: Each CEU attendance verification form must have YOUR SIGNATURE in the space provided.

3. If postmarked on or after {July 2, 2011} remit \$125.00 which includes a \$25.00 late fee.

4. EACH renewal must have separate payment and be mailed separately.
